ply for hire, and such other orders and regulations for the better ordering and regulating the said hackney-coaches and other carriages and stagecoaches in the said streets, and the drivers or other the person or persons having the management thereof respectively, as to the said Court of Mayor and Aldermen shall seem proper, and from time to time to alter, amend, or repeal such rules, orders, and regulations, and to make others in the room thereof; and the said Court of Mayor and Aldermen shall cause all the rules, orders, and regulations to be made by them as aforesaid, and every alteration, amendment, or repeal thereof respectively to be advertised in the London Gazette, and in two or more newspapers circulated in the said city of London, and a copy thereof to be hung up for public inspection in the Town Clerk's Office, at the Guildhall of the said city, before the same or any of them shall be carried into effect, or be considered as repealed by the said Court of Mayor and Aldermen.

This Court doth by virtue and in pursuance of the said Act of Parliament hereby appoint the proper places in and near Gracechurch-street and Fish-street-hill aforesaid, where hackney-coaches and other carriages and stage-coaches respectively may stand and ply for hire; and doth by virtue and in pursuance of the said Act of Parliament, make orders for regulating the number of such carriages to stand in such places respectively, and the distances at which they shall stand from each other, and the hours at and during which they may stand and ply for hire; and for the better, ordering and regulating the said hackney-coaches and other carriages and stage-coaches in the said streets, and the drivers or other the person or persons having the management thereof respectively in manner following, that is to

It is by this Court ordered and directed, and this Court doth hereby appoint, that part of Gracechurch-street aforesaid, called the lower part of Gracechurch-street, commencing opposite to and at and from the south end of the house numbered 46; in Gracechurch-street aforesaid, and extending northward along the said street to and opposite the south end of White-hart-court, in the said street, for hackney-coaches, chariots, cabriolets, and other hackney carriages, to stand or ply for hire, that is to say, in the middle of the said street, only within the aforesaid limits.

And it is by this Court hereby further ordered and directed, that all hackney-coaches, chariots, cabriolets, or other hackney carriages, which shall at any time hereafter stand or ply for hire within the aforesaid limits in Gracechurch-street aforesaid, shall stand or ply for hire at the distance of eight feet at least apart from each other, in a direct line; such space to be computed from the heads of the horses of one such hackney-coach, chariot, cabriolet, or other hackney carriage, to the hinder part of the next or other hackney-coach, chariot, cabriolet, or other hackney carriage, standing or plying for hire within the aforesaid limits.

And it is by this Court hereby further ordered and directed, that the present standing for hackney-coaches, chariots, cabriolets, and other hackney carriages, in that part of Gracechurch-street called the upper part of Gracechurch-street aforesaid, and extending from the end of Lombard-street to the end

of Cornhill, in Gracechurch-street aforesaid, shalf, from and after these rules, orders and regulations shall be in full force, be removed and discontinued.

And it is by this Court hereby further ordered and directed, that no stage coach or other carriage, used as such, shall stand or ply for hire on either side of Gracechurch-street aforesaid, or in any other part of the said street, between the south-end of Saint Peter's-alley, and the south-end of Cornhill, or between the south-end of Lombard-street, and the south-end of the house numbered 19, in Gracechurch-street aforesaid.

And it is by this Court hereby further ordered and directed, that no more than six stage-coaches or other carriages used as such, shall hereafter stand or ply for hire on the eastern-side of Gracechurch-street aforesaid, between the south-end of Half-Moon-passage and the south-end of the house numbered 71, in the said street, and that such last mentioned stage-coaches or other carriages used as such, shall stand or ply for hire there, at the distance of eight feet at least apart from each other in a direct line, such space to be computed from the heads of the horses, or of the leading horse or horses, if more than two, of one such stage-coach or other carriage to the hinder part of the next or other stage-coach or other carriage standing or plying for hire within the last mentioned limits.

And it is by this Court hereby further ordered and directed, that no greater number of stage-coaches or other carriages used as such, shall stand or ply for hire on the western-side of Gracechurch-street aforesaid, between the south-end of Saint Peter's-alley, in the said street, and the south-end of the house numbered 19, in Gracechurch-street aforesaid, than can be conveniently placed to stand or ply for hire within the said last mentioned limits, each of such last mentioned stage-coaches or other carriages being placed and standing or plying for hire at the distance of eight feet at least apart from each other in a direct line, such space to be computed from the heads of the horses, or of the leading horse or horses, if more than two, of one of such stage-coaches or other carriages to the hinder part of the next or other stage-coach or other carriage standing or plying for hire within the said last mentioned limits.

And it is by this Court hereby further ordered and directed, that no stage-coach or other carriage used as such, shall stand or ply for hire on either side of the said street, within the limits herein before respectively mentioned and appointed for that purpose, or stand or remain there for any longer space of time than the space of ten minutes, and that the driver or other person having the management of any such stage-coach or other carriage used as such, shall at the expiration of the said space of ten minutes immediately drive such stage-coach or other carriage from such standing, and from and out of the said street without delay or loitering therein under any pretence whatever.

And it is by this Court hereby further ordered and directed, that no driver of any stage-coach or other carriage used as such, or any other person having the management thereof, or employed in or about, or attending upon the same, shall wilfully obstruct the foot-pavement of Gracechurch-street aforesaid, or the free passage of His Majesty's subjects passing and repassing therein, or use any abusive, indecent or
