And those Gentlemen who are to be presented are hereby informed, it is absolutely necessary that their names, with the name of the Gentleman who is to present them, should be sent in to the Lord Chamberlain's-Office on Wednesday the 26th instant, before twelve o'clock, in order that they may be submitted for 'the King's approbation, it being His Majesty's command, that no presentation shall hereafter be made at the Levee, but in conformity with the above regulations.

The state apartments will not be open for the reception of company coming to Court, until one o'clock.
