HEREAS by an Act, passed in the sixth year of His Majesty's reign, intituled "An Act "to regulate the trade of the British possessions "abroad," it is, amongst other things, enacted, that no goods shall be imported into, nor shall any goods, except the produce of the fisheries in British ships, be exported from any of the British possessions in America by sea, or from or to any place other than the United Kingdom, or some other of such possessions, except into or from the several ports in such possessions called free ports, enumerated or described in the table in the said Act of Parliament contained:

And it is thereby provided, that if His Majesty shall deem it expedient to extend the provisions of the said Act to any port or ports not enumerated in the said table, it shall be lawful for His Majesty, by Order in Council, to extend the provisions of the said Act to such port or ports, and it is enacted, that

from and after the day mentioned in such Order in Council, all the privileges and advantages of the said Act, and all the provisions, penalties, and forfeitures therein contained, shall extend, and be deemed and construed to extend, to any such port or ports respectively, as fully as if the same had been inserted and enumerated in the said table at the time of passing the said Act:

And whereas His Majesty doth deem it expedient to extend the provisions of the said Act to the ports of Pictou and Sydney, in the province of Nova Scotia; His Majesty doth therefore, in pursuance and exercise of the powers vested in him by the said Act of Parliament, and with the advice of His Privy Council, order, and it is hereby ordered, that, from and after the date of this Order, the provisions of the said Act of Parliament respecting free ports shall be, and the same are hereby, extended to the said ports of Pictou and Sydney, in the province of Nova Scotia:

And the Right Honourable the Lords Commissioners of His Majesty's Treasury, and the Right Honourable William Huskisson, one of His Majesty's Principal Secretaries of State, are to give the necessary directions herein as to them may respectively appertain.

The KING's Most Excellent Majesty in Council.

HEREAS by an Act, passed in the fiftyseventh year of His late Majesty's reign, cap. 57, intituled "An Act to empower His Majesty " to suspend the training and regulate the quotas of " the militia," it is enacted, that it shall be lawful for His Majesty, by any Order or Orders in Council, to suspend the calling out of the militia of the United Kingdom, or of any part of the United Kingdom, or of any county, riding, shire, stewartry, city, town, or place, for the purpose of being trained and exerciscd in any year, and to order and direct that no training or exercising of the militia of the United Kingdom, or of any part of the United Kingdom, or of any county or counties, riding or ridings, shire or shires, stewartry or stewartries, city or cities, town or towns, or place or places, specified in any such Order or Orders in Council, shall take place in any year, any thing contained in any Act or Acts of Parliament relating to the militia to the contrary notwithstanding: and whereas it is deemed expedient, that such training or exercising should be dispensed with in the present year; it is ordered by His Majesty, by and with the advice of His Privy Council, that the calling out of the militia of that part of the United Kingdom called Great Britain, for the purpose of being trained and exercised in the present year, be suspended; and that no training or exercising of the said militia do take place in the present year.

BRESENT,

The KING's Most Excellent Majesty in Council.

HEREAS by a certain Act of Parliament, passed in the sixth year of the reign of His present Majesty, intituled "An Act to regulate the "trade of the British possessions abroad," after reciting, that " by the Law of Navigation foreign " ships are permitted to import into any of the " British possessions abroad, from the countries to which they belong, goods, the produce of those countries, and to export goods from such possessions to be carried to any foreign country whatever, and that it is expedient that such permission " should be subject to certain conditions," it is enacted, " that the privileges thereby granted to " foreign ships shall be limited to the ships of those countries which, having colonial possessions, shall grant the like privileges of trading with those possessions to British vessels, or which, not having colonial possessions, shall place the commerce and navigation of this country, and of its possessions abroad, upon the footing of the most favoured nation, unless His Majesty, by His Order in " Council, shall in any case deem it expedient to grant the whole or any of such privileges to the ships of any foreign country, although the con-" ditions aforesaid shall not in all respects be fulfilled " by such foreign country:"

And whereas by an Act, passed in the seventh and eighth years of His present Majesty's reign, intituled "An Act to amend the laws relating to the "Customs," after reciting or taking notice of the said Act so passed as aforesaid in the sixth year of His Majesty's reign, and after reciting, that unless some period were limited for the fulfilment by foreign countries of the conditions mentioned and referred to in the said recited Act, the trade and navigation of the United Kingdom and of the British possessions abroad, could not be regulated by fixed and certain rules, but would continue subject to changes dependent upon the laws from time to time made in such foreign countries; it is therefore enacted, that no foreign country shall hereafter be deemed to have fulfilled the conditions so prescribed as aforesaid in and by the said Act, as to be entitled to the privileges therein mentioned, unless such foreign country had in all respects fulfilled those conditions within twelve months next after the passing of the said Act, that is to say, on or before the fifth day of July one thousand eight hundred and twenty-six; and for the better ascertaining what particular foreign countries are permitted by law to exercise and enjoy the. said privileges, it is further enacted, that no foreign country shall hereafter be deemed to have fulfilled the beforementioned conditions, or to be entitled to the privileges aforesaid, unless and until His Majesty shall by some Order or Orders to be by him made, by the advice of His Privy Council, have declared that such foreign country hath so fulfilled the said conditions, and is entitled to the said privileges; provided always, and it is thereby declared and Jas. Buller. enacted, that nothing therein contained, extends, or shall be construed to extend, to make void or annul any Order or Orders in Council theretofore issued, next; and whereas it is judged expedient that the said under the authority or in pursuance of the said recited Act, and to take away or abridge the powers vested in His Majesty in and by the said Act, or any of those powers, any thing therein contained to the contrary in anywise notwithstanding:

· And whereas the conditions mentioned and referred to in the said Acts of Parliament have not in all respects been fulfilled by the Government of the United States of America, and therefore the privileges so granted as aforesaid by the Law of Navigation to foreign ships, cannot lawfully be exercised or enjoyed by the ships of the United States aforesaid, unless His Majesty, by His Order in Council, shall grant the whole or any of such privileges to the ships of the United States aforesaid:

And whereas His Majesty doth deem it expedient to permit the exportation of salt and fruit, in certain vessels of the said United States of America, from His Majesty's island of Anguilla, in the West Indies; His Majesty doth, therefore, in pursuance and exercise of the powers vested in him in and by the said Acts of Parliament, by and with the advice of His Privy Council, declare and grant, that it shall be lawful for ships of the United States of America, arriving in ballast at any port or place in the said island of Anguilla, in which a custom-house is or shall be established, to export salt and fruit, or either of them, from such port or place, to be carried to any foreign country whatever; subject, nevertheless, to the payment of all such duties as by any law in force within the said island are or shall be payable upon such ships, or upon the exportation of any such salt or fruit:

And His Majesty is further pleased, with the advice aforesaid, to order, that this present Order shall take effect and be in force in the said island of Anguilla, so soon as the Governor, or the Officer administering the Government of His Majesty's island of Saint Christopher's for the time being, shall have made known the same to the inhabitants of the said island of Anguilla, by a Proclamation to be by him for that purpose issued, and not before:

The KING's Most Excellent Majesty in Council.

HEREAS the time limited by His Majesty's Order in Council, of the twenty-third of May last, for prohibiting the exportation of gun-powder, salt-petre; or any sort of arms or ammunition, to any port or place on the Coast of Africa (except to any ports or places within the Streights of Gibraltar),

will expire on the twenty-third day of November prohibition should be continued for some time longer; His Majesty, by and with the advice of His Privy Council, doth therefore hereby order, require, and command, that no person or persons whatever (except the Master-General of the Ordnance for His Majesty's Service), do, at any time during the space of six months (to commence from the twentythird of November next), presume to transport any gun-powder or salt-petre, or any sort of arms or ammunition, to any port or place on the Coast of Africa (except to any ports or places within the Streights of Gibraltar) or ship or lade any gun-powder or salt-petre, or any sort of arms or ammunition, on board any ship or vessel, for the transporting of the same into any such ports or places on the Coast of Africa (except as above excepted), without leave or permission in that behalf first obtained from His Majesty or His Privy Council, upon pain of incurring and suffering the respective forfeitures and penalties imposed in that behalf by an Act, passed in the sixth year of His present Majesty's reign, intituled "An Act for the general " regulation of the Customs:"

And the Right Honourable the Lords Commission sioners of His Majesty's Treasury, His Royal Highness the Lord High Admiral, the Lord Warden of the Cinque Ports, the Master-General and the rest of the Principal Officers of the Ordnance, and His Majesty's Secretary at War, are to give the necessary directions herein as to them may respectively appertain.

Trinity-House, London, April 10, 1828.

THEREAS representations have been addressed to the Corporation of Trinity-House, on behalf of the owners of vessels importing lobsters from Norway or Scotland for the supply of the London market, on the subject of the light and other dues to the said Corporation to which those vessels are liable, and soliciting that an annual commutation might be paid in lieu thereof; and that same together with the liability to the said dues which equally applies to vessels importing turbots having undergone consideration.—This Corporation in compliance therewith, and by virtue of the authority vested in them by the 4th section of the Act of Parliament, 3d Geo. IV, cap. 3, have submitted certain propositions thereupon for the assent and confirmation of His Majesty in Council.—And His Majesty having been graciously pleased by an Order in Council, bearing date at the Court at Windsor the 26th January 1828, to signify his royal assent to and confirmation thereof.

Notice is hereby given, that under authority of the same, the following annual commutation, subject to the conditions hereinafter stated, is to be paid by or in respect of the vessels beforementioned: that is to say, "That the sum of twenty shillings be paid annually in lieu of light and other duties payable to the Corporation of Trinity-House of Deptford Stroud, by all vessels importing lobsters from Norway or Scotland, and turbots from what-ever part, for the supply of the London market, whether imported in British or in foreign vessels, provided the latter shall, in respect to duties to the said Corporation, be placed at the time of their making such annual payment on the footing of British vessels, and when such importations shall be made in foreign vessels not so privileged in respect of charges the annual payment to be forty shillings each; that on payment of such commutation a certificate or receipt for the same be delivered, declar-ing that the said sum of twenty shillings or forty shillings, as the case may be, is in lieu of all light or other duties payable to the said Corporation to the 31st of December following the date of such payment, provided the cargo which such vessel may have on board shall not require her to make entry at the Custom-House, but that in all cases in which such entry shall be by law required, the full amount

relate to that specific voyage, be paid as by other vessels making entry, but which entry and payment shall not invalidate the cummutation in respect of any subsequent voyages in which entry at the Custom-House shall not be so required, provided such voyages shall take place within the period specified in the commutation receipt or certificate.
