The KING's Most Excellent Majesty in Council.

HEREAS the time limited by His Majesty's Order in Council, of the eighteenth of October last, for prohibiting the exportation of gun-powder, salt-petre, or any sort of arms or ammunition, to any port or place on the Coast of Africa (except to any ports or places within the Streights of Gibraltar), will expire on the twenty-third day of this instant May; and whereas it is judged expedient that the said prohibition should be continued for some time longer; His Majesty, by and with the advice of His Privy Council, doth therefore hereby order, require, and command, that no person or persons whatever (except the Master-General of the Ordnance for His Majesty's Service), do, at any time during the space of six months (to commence from the twentythird of this instant May), presume to transport any gun-powder or salt-petre, or any sort of arms or ammunition, to any port or place on the Coast of Africa (except to any ports or places within the Streights of Gibraltar) or ship or lade any gun powder or salt-petre, or any sort of arms or ammunition, on board any ship or vessel, for the transporting of the same into any such ports or places on the Coast of Africa (except as above excepted), without leave or permission in that behalf first obtained from His Majesty or His Privy Council, upon pain of incurring and suffering the respective forfeitures and penalties imposed in that behalf by an Act, passed in the sixth year of His present Majesty's reign, intituled "An Act for the general "Yegulation of the Customs:"

And the Right Honourable the Lords Commissioners of His Majesty's Treasury, His Royal High-

ness the Lord High Admiral, the Lord Warden of the Cinque Ports, the Master-General and the rest of the Principal Officers of the Ordnance, and His Majesty's Secretary at War, are to give the necessary directions herein as to them may respectively appertain.

The KING's Most Excellent Majesty in Council.

HEREAS by an Act, passed in the sixth year of His Majesty's reign, intituled "An Act "to regulate the trade of the British possessions "abroad," it is, amongst other things, enacted, that no goods shall be imported into, nor shall any goods, except the produce of the fisheries in British ships, be exported from any of the British possessions in America by sea, or from or to any place other than the United Kingdom, or some other of such possessions, except into or from the several ports in such possessions called free ports, enumerated or described in the table in the said Act of Parliament contained:

And it is thereby provided, that if His Majesty shall deem it expedient to extend the provisions of the said Act to any port or ports not enumerated in the said table, it shall be lawful for His Majesty, by Order in Council, to extend the provisions of the said Act to such port or ports, and it is enacted, that from and after the day mentioned in such Order in Council, all the privileges and advantages of the said Act, and all the provisions, penalties, and forfeitures therein contained, shall extend, and be deemed and construed to extend, to any such port or ports respectively, as fully as if the same had been inserted

The KING's Most Excellent Majesty in Council.

HEREAS by a certain Act of Parliament, passed in the sixth year of the reign of His present Majesty, intituled "An Act to regulate the "trade of the British possessions abroad," after reciting, that "by the Law of Navigation foreign ships are permitted to import into any of the British possessions abroad, from the countries to " which they belong, goods, the produce of those " countries, and to export goods from such possessions to be carried to any foreign country what-" ever, and that it is expedient that such permission " should be subject to certain conditions," it is enacted, " that the privileges thereby granted to " foreign ships shall be limited to the ships of those countries which, having colonial possessions, shall grant the like privileges of trading with those possessions to British vessels, or which, not having " colonial possessions, shall place the commerce and navigation of this country, and of its posses-" sions abroad, upon the footing of the most favoured " nation, unless His Majesty, by His Order in "Council, shall in any case deem it expedient to grant the whole or any of such privileges to the " ships of any foreign country, although the con-" ditions aforesaid shall not in all respects be fulfilled " by such foreign country:

And whereas by an Act, passed in the seventh and eighth years of His present Majesty's reign, intituled "An Act to amend the laws relating to the "Customs," after reciting or taking notice of the said Act so passed as aforesaid in the sixth year of His Majesty's reign, and after reciting, that unless some period were limited for the fulfilment by foreign countries of the conditions mentioned and referred to in the said recited Act; the trade and navigation of the United Kingdom and of the British possessions

rules, but would continue subject to changes dependent upon the laws from time to time made in such foreigh countries; it is therefore enacted, that no foreign country shall hereafter be deemed to have fulfilled the conditions so prescribed as aforesaid in and by the said Act, as to be entitled to the privileges therein mentioned, unless such foreign country had in all respects fulfilled those conditions within twelve months next after the passing of the said Act, that is to say, on or before the fifth day of July one thousand eight hundred and twenty-six; and for the better ascertaining what particular foreign countries are permitted by law to exercise and enjoy the said privileges, it is further enacted, that no foreign country shall hereafter be deemed to have fulfilled the beforementioned conditions, or to be entitled to the privileges aforesaid, unless and until His Majesty shall by some Order or Orders to be by him made, by the advice of His Privy Council, have declared that such foreign country hath so fulfilled the said conditions, and is entitled to the said privileges; provided always, and it is thereby declared and enacted, that nothing therein contained, extends, or shall be construed to extend, to make void or annul any Order or Orders in Council theretofore issued, under the authority or in pursuance of the said recited Act, and to take away or abridge the powers vested in His Majesty in and by the said Act, or any of those powers, any thing therein contained to the contrary in anywise notwithstanding:

And whereas the conditions mentioned and referred to in the said Acts of Parliament have not in all respects been fulfilled by the Government of the United States of America, and therefore the privileges so granted as aforesaid by the Law of Navigation to foreign ships, cannot lawfully be exercised or enjoyed by the ships of the United States aforesaid, unless His Majesty, by His Order in Council, shall grant the whole or any of such privileges to the ships of the United States aforesaid:

And whereas His Majesty doth deem it expedient to permit the exportation of salt and fruit, in certain vessels of the said United States of America, from His Majesty's island of Anguilla, in the West Indies; His Majesty doth, therefore, in pursuance and exercise of the powers vested in him in and by the said Acts of Parliament, by and with the advice of His Privy Council, declare and grant, that it shall be lawful for ships of the United States of America, arriving in ballast at any port or place in the said island of Anguilla, in which a custom-house is or shall be established, to export salt and fruit, or either of them, from such port or place, to be carried to any foreign country whatever; subject, nevertheless, to the payment of all such duties as by any law in force within the said island are or shall be payable upon such ships, or upon the exportation of any such salt or fruit:

And His Majesty is further pleased, with the advice aforesaid, to order, that this present Order shall take effect and be in force in the said island of Anguilla, so soon as the Governor, or the Officer administering the Government of His Majesty's island of Saint Christopher's for the time being, shall have made known the same to the inhabitants of the said

island of Anguilla, by a Proclamation to be by him, for that purpose issued, and not before:

THIS day, the Lords being met, a message was sent to the Honourable House of Commons by the Gentleman Usher of the Black Rod, acquainting them, that The Lords, authorised by virtue of a Commission under the Great Seal, signed by His Majesty, for declaring His Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An Act for prohibiting, during the present session of Parliament, the importation of foreign wheat into the Isle of Man, and for levying a duty on meal or flour, made of foreign wheat, imported from the Isle of Man into the United Kingdom.

An Act for paving, lighting, watching, cleansing, regulating, and improving the town of North Shields,

in the county of Northumberland.

An Act to amend and extend the provisions of an Act, for paving and improving the streets and other public passages and places within the borough of

An Act for regulating and fixing the rates to be paid for goods imported at and exported from the quay of Bideford, in the county of Devon, and for keyage and keelage of ships and vessels in the harbour of Bideford, and for more easily levying and collecting the same; and also for regulating ships and vessels in the said harbour.

An Act for amending three Acts, of the thirtieth year of King George the Second, and the thirtysecond and thirty-fifth years of His late Majesty King George the Third, so far as relates to the draining and preserving certain fen lands and low grounds within the township or hamlet of March, in the isle of Ely and county of Cambridge, called the Fourth District.
