#### NOTICE TO MARINERS.

#### LIGHT-HOUSES ON THE MAIDEN OR. HULIN ROCKS.

THE Corporation for preserving and improving the port of Dublin, &c. hereby give notice, that two Light-houses have been erected on the Maiden or Hulin Rocks, on the north east coast of Ireland, and off the county Antrim, which will be lighted on Monday the 5th of January 1829, and will continue from that time to exhibit two steady bright lights every night, from the going away of day-light in the evening to the return of day-light in the morning.

The Maiden or Hulin Rocks bear by compass, from the Mull of Cantire Light, S. by W.  $\frac{1}{4}$  W. distant  $20\frac{1}{2}$  miles. From Sana Island, S. S. W.  $\frac{1}{2}$  W. distant  $18\frac{3}{4}$  miles. From Ailsa, W. S. W. distant 23 miles. From the Point of Coarsal, W.  $\frac{1}{4}$  S. distant  $2l\frac{3}{4}$  miles, From Copeland Island Light, N.  $\frac{1}{2}$  E. distant  $16\frac{1}{2}$  miles; and from the eastern extremity of Rachline Island, S. by E. distant  $29\frac{1}{2}$ miles. The lights are distant from each other 320 fathoms, and bear one from the other N.W. by W. and S.E. by E. The mariner in passing these lights should give them a wide birth, there being a number of sunken rocks extending upwards of 3 miles north, and  $1\frac{4}{2}$  miles south of them.
