IT is this day ordered by His Majesty in Council that the Parliament be prorogued, from Thursday the fifteenth day of this instant October, to Thursday the tenth day of December next.

HAGUE'S INVENTION OF CERTAIN IM-PROVEMENTS IN THE METHOD OF EXPELLING THE MOLASSES OR SYRUP FROM SUGAR.
