WHEREAS Our Parliament stands prorogued to Thursday the tenth day of this instant December; We, with the advice of our Privy Council, do hereby publish and declare, that the said Parliament shall be further prorogued, on the said tenth day of this instant December, to Thursday the fourth day of February next; and We have given order to Our Chancellor of that part of Our United Kingdom called Great Britain, to prepare a commission for proroguing the same accordingly; and We do further hereby, with the advice aforesaid, declare Our Royal Will and Pleasure, that the said Parliament shall, on the said fourth day of February next, assemble and be held for the dispatch of divers urgent and important affairs: And the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgesses, and the Commissioners for Shires and Burghs of the House of Commons, are hereby required and commanded to give their attendance accordingly, at Westminster, on the said fourth day of February next.

THE following is a copy of an Order in Council, approving of a district being assigned to the new chapel built at Brompton, in the parish of Kensington, under the provisions of the 21st section of the Act of the 58 Geo. 3d. c. 45:

At the Court at Windsor, the 12th of October 1829, present, the King's Most Excellent Majesty in Counci

WHEREAS by an Act, passed in the 58th year of His late Majesty's reign, intituled "An Act for building and promoting the building of additional chirches in populous parishes," it is amongst other things enacted, "that in every case in which the Commissioners appointed for carrying into execution the purposes of the said Act, shall be of opinion that it will be expedient to divide any parish into two or more distinct and separate parishes for all recclesiastical purposes whatever, it shall be lawful for the said Commissioners, with the consent of the Bishop of the diocese in which such parish is locally situated, signified under his hand and seal, to apply to the patron or patrons of the church of such parish for his consent to make such division, and for such patron or patrons to signify his or their consent thereto under his hand and seal, and the said Commissioners shall, upon the consent of the said patron or patrons so signified, represent the whole matter to His Majesty in Council, and shall state in such representation the bounds by which it is proposed, with such consent as aforesaid, to divide such parish, together with the relative and respective proportions of glebe lands, tithes, moduses, or other endowments, which will by such division arise and accrue and remain and be within each of such respective divisions, and also the relative proportions of the estimated amount of the value or produce of fees, oblations, offerings, or other ecclesiastical dues or profits which may arise and accrue within each of such respective divisions, and if thereupon His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting such division; provided always, that no such division of any parish into distinct parishes shall completely take effect

and whereas by the said Act it is further enacted "that in any case in which the said Commissioners shall be of opinion that it is not expedient to divide any populous parish, or extra parochial place, into such complete separate and distinct parishes as aforesaid, but that it is expedient to divide the same into such ecclesiastical districts, as they with the consent of the Bishop, signified under his hand and seal, may deem necessary, for the purpose of affording accommodation for the attending Divine Service, according to the rites of the United Church of England and Ireland, to persons residing therein, in the churches and parochial chapels already built, or in additional churches or chapels to be built therein, and as may appear to such Commissioners to be convenient for the enabling the spiritual person or persons who may serve such churches or chapels to perform all ecclesiastical duties within the districts attached to such respective churches and chapels, and for the due ecclesiastical superintendance of such district, and the preservation and improvement of the religious and moral habits of the persons residing therein; the said Commissioners shall represent such opinion to His Majesty in Council, and shall state in such representation the bounds by which such districts are proposed to be described; and if thereupon His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the purlose of effecting such division:" and whereas by an Act passed in the 59th year of His late Majesty's reign, intituled "An Act to amend and render, more effectual an Act passed in the last session of Parliament, for building and promoting the building of additional churches in populous parishes," further provisions are made for carrying such division into effect: and whereas the said Commissioners have made a representation to His Majesty in Council, stating that the parish of St. Mary Abbotts, Kensington, in the county of Middlesex, and diocese of London, contained in the year 1821, when the last census was taken, a population of 14,428 persons, which has since considerably increased; that besides the parish church, there was only one consecrated chapel, which together afforded accommodation for 1700 persons only; that the said Commissioners have caused two new chapels to be erected in the said parish, one at Brompton, and the other in Addisonroad, Kensington, wherein accommodation has been provided for 2835 persons, including 1118 free seats for the use of the poor; that such chapels have been consecrated, and divine service is regularly performed therein; that it appears to the said Commissioners to be expedient, for securing a due ecclesiastical superintendance of the parish, and for the preservation and improvement of the religious and moral habits of the persons residing therein, that a district should be assigned to a new chapel built at Brompton, under the provisions of the said Act, passed in the 58th year of His late Majesty's reign, and that such district should be named, the District of Holy Trinity, Brompton, with boundaries as follows, viz .-- At its north eastern extremity at Knightsbridge, it abuts upon Sloane-street towards the north east, and includes the five first houses, the corner house inclusive, and part of the sixth house

in Sloane-street, from the north end of that street, and there joins the boundary line between the parishes of Kensington and St. Luke, Chelsea, which line it traverses from east to west as far as Sandfordbridge; then turns northward and rebuts towards the west upon the Creek now called the Kensington Canal, which divides the parishes of Kensington and Fulham, up to the new brick-built bridge built across the same Creek or Canal; then turns in a north easterly direction abutting toward the north upon the new turnpike road leading to the said bridge, as far as the south east corner of that road at Eatle's Court; then turns northward to the extreme south west corner of the buildings attached to the dwelling-house of Robert Gunter, Esq. at Earle's Court; it then runs in a north easterly direction in a straight line across the fields, east of Earle's Court, to the south east end of the cartway opposite to the north west corner of the wall of Gloucester Lodge, at Old Brompton; and from the said corner of that cartway it runs in a triffing more easterly direction in another straight line across the fields, gardens, and nursery grounds there to the boundary stone at the south west angle of the boundary line between the parishes of Kensington and St. Margaret's, Westminster, which stone is fixed near the north east corner of a nursery ground in the occupation of Messrs. Grey and Company; and from that stone it traverses the last-mentioned boundary line to the first-described point at the north west corner of Sloane-street, at Knightsbridge; the whole including the villages of Old and New Brompton, Little Chelsea, Sandford Brooke, and part of Earle's Court, as the same is in the map or plan hereunto annexed more particularly delineated, and is therein coloured red; that the consent of the Bishop of the diocese has been obtained as required by the said Act; and humbly praying, that His Majesty would be pleased to take the said circumstances into consideration, and to make such order therein as to His Majesty should seem meet:—His Majesty having taken the said representation into consideration, was pleased, by and with the advice of His Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed division be accordingly made and effected, agreeably to the provisions of the said Acts.

### NOTICE TO MARINERS. TARBETNESS LIGHT-HOUSE.

Edinburgh, 14th January 1830.

THE Commissioners of the Northern Lighthouses hereby give notice, that a Light-house has been erected upon Tarbetness, in the Moray Fith, the light of which will be exhibited on the night of Friday, the 29th day of January current, and every night thereafter, from the going away of day-light in the evening, till the return of day-light in the morning.

The following is a specification of the position of the Light-house, and the appearance of the light, by Mr. Stevenson, Engineer to the Commissioners.

Tarbetness forms the north-eastern extremity of Cromartyshire, situate in lat. 57 deg. 54 min. north, county and island, except for the counties in North

and in long. 3 deg. 47 min. west, distant about 12 miles from the entrance to Cromarty Frith. By compass, the Light-house bears from the sunken rocks, pass, the Light-house bears from the striker ipcas, ealled the Three Kings and the King's Sons, N.E. 1/4 E. distant nine miles; from Hallman's Scares, lying off Covesea or Cowsey Point, N.N.W. 1/2 W. distant 31 miles; from Clyphness S.W. by W. 1/2 W. distant 31 miles; and from Culloden Rock W. by S. distant one mile.

Tacbetness Light will be known to mariners as an intermittent light, suddenly appearing like a star of the first magnitude, and continuing in view 21 minutes, when it is suddenly eclipsed for half a minute; thus producing its characteristic effect once in every three minutes. It must, however, be observed, that within the Moray Frith, in a south-westerly direction from Tarbetness, where the light cannot be mistaken for any other on the coast, it will be permanently visible, until the mariner pass within a line drawn from Tarbetness through a point half a mile seaward of the King's Sons; when it will be intercepted from his view by the high land of the coast. The interception of the light by the land will thus form a direction to avoid these dangerous rocks.

The lantern is open or glazed seaward from S.W.  $\frac{1}{2}$  W. to W.  $\frac{1}{2}$  N. and is elevated 175 feet above the medium level of the sea. The light, in clear weather, will be seen at the distance of five or six leagues, and at lesser distances, according to the state of the atmosphere.
