

Whitehall, April 6, 1830.

WHEREAS it has been humbly represented to the King, that, on the night of the 28th March last, a violent assault was committed near Hell's-bay, within the port of St. Ives, in the county of Cornwall, upon the persons of two Officers, belonging to the Coast Guard Service at Portreath and Hayle, in the said county (while employed in the execution of their duty in endeavouring to seize and secure a large quantity of foreign spirits, which had been smuggled on shore at or near Hell's-bay), by a number of men, who severely ill-treated them, and fired a pistol at and wounded one of the said Officers, so that he is now lying dangerously ill;

His Majesty, for the better discovering of the offenders concerned in the said outrage, is hereby pleased to offer His most gracious pardon to any one or more of the said persons present at and aiding in such outrage (save and except the person who actually fired the pistol at the said Officer), who shall discover his or their accomplice or accomplices therein, so that he or they may be apprehended and brought to justice.

THE following is a copy of an Order in Council, approving of a district being assigned, under the provisions of the 21st sec. 58 Geo. 3, c. 45, to the new chapels built at Hoxton and Haggerstone, in the parish of St. Leonard, Shoreditch:

At the Court at St. James's, the 10th of June 1829, present: the King's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the 58th year of His late Majesty's reign, intituled "An Act for building and promoting the building of additional churches in populous parishes," it is amongst other things enacted, "that in every case in which the Commissioners appointed for carrying into execution the purposes of the said Act, shall be of opinion that it will be expedient to divide any parish into two or more separate and distinct parishes for all ecclesiastical purposes whatever, it shall be lawful for the said Commissioners, with the consent of the Bishop of the diocese in which such parish is locally situated, signified under his hand and seal, to apply to the patron or patrons of the church of such parish for his consent to make such division, and for such patron or patrons to signify his or their consent thereto under his hand and seal, and the said Commissioners shall, upon the consent of the said patron or patrons so signified, represent the whole matter to His Majesty in Council, and shall state in such representation the bounds by which it is proposed, with such consent as aforesaid, to divide such parish, together with the relative and respective proportions of glebe lands, tithes, moduses, or other endowments, which will by such division arise and accrue and remain and be within each of such respective divisions, and also the relative proportions of the estimated amount of the value or produce of fees, oblations, offerings, or other ecclesiastical dues or profits which may arise and accrue within each of such respective divisions, and if thereupon His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting such division; provided always, that no such division of any parish into distinct parishes shall completely take effect until after the death, resignation, or other avoidance of the existing incumbent of the parish to be divided;" and whereas by the said Act it is further enacted "that in any case in which the said Commissioners shall be of opinion that it is not expedient to divide any populous parish, or extra parochial place, into such complete separate and distinct parishes as aforesaid, but that it is expedient to divide the same into such ecclesiastical districts, as they with the consent of the Bishop, signified under his hand and seal, may deem necessary, for the purpose of affording accommodation for the attending Divine Service, according to the rites of the United Church of England and Ireland, to persons residing therein, in the churches or parochial chapels already built, or in additional churches or chapels to be built therein, and as may appear to such Commissioners to be convenient for the enabling the spiritual person or persons who may serve such churches or chapels to perform all ecclesiastical duties within the districts attached to such respective churches and chapels, and for the due ecclesiastical superintendance of such district, and the preservation and improvement of the religious and moral habits of the persons residing therein; the said Commissioners shall represent such opinion to His Majesty in Council, and shall state in such representation the bounds by which such districts are proposed to be described; and if thereupon His
