Earl Marshal's-Office, Whitehall-Yard, July 7, 1830. r. WE King has been pleased to command, that the - Great Officers of State, His Majesty's Ministers, and the Officers of the Royal Household, whe assist at the Intcrment of His late Most Sacred Majesty King George the Fourth, of blessed memory, do appear in their state uniforms, black waistcoats, breeches, stockings, and buckles, uniform swords with crape, and black feathers in their hats; and that all Officers of the Army and Navy, who attend at the Solemnity, appear in their respectire full dress uniforms, pantaloons and boots, with the mourning directed to be worn by them at Court, as notified in the Gazette of the 28th of June last.

The Bishops are to appear in their rochets; and all Peers, Eldest Sons of Peers, Privy Councillors, and others, who may not be included in the above regulations, are to appear in full dress black.

## PRESENT,

The KING's Most Excellent Majesty in Coumcil.

IVHERESS by an Act, passed in the fiftyseventh year of the reign of His late Majcsty King George the Third, intituled "An Act to "empower His Majesty to suspend the training "and regulate the quotas of the militia," it is cnacted, that it whall be lowful for His Majesty,
by any Order or Orders in Council, to suspend the calling out of the militia of the United Kingdom, or of any part of the United Kingdom, or of any county, riding, shire, stewartry, city, town, or place, for the purpose of being trained and exercised in any year, and to order and direct that no training or exercising of the militia of the Unitcd Kingdom, or of any part of the United Kingdou, or of any county or counties, riding or ridings, shire or shires, stewartry or stemartries, city or cilies, town or towns, or place or places, specificd in any such Order or Orders in Council, shall take place in any year, any thing contained in any Act or Acts of Parfiament relating to the militia to the contrary notwithstanding: and whereas it is deemed expedient, that such training or exercising should be dispensed with in the present year; it is ordered by His Majesty, by and with the advice of His Privy Council, that the calling out of the militia of thet part of the United Kingdon called Great Britain, for the purpose of being trained and exercised in the present year, be auspended; and that no treining or exereising of the said militia do take place in the present year.
