

hithor from France to the Hague, to give the States and the Prince of Orange an account how he left Affairs at Paris. We were yesterday informed by Letters from Lille, that the Marechal d'Humieres was going to decamp from Leslignes, when he received new orders from Court; that thereupon a Council of War was held; and that the Young Princes who were returning to Paris, are all come back to the Army, which makes us believe some sudden Action is intended. The Letters from Germany confirm the Particulars we gave you in our last, of the Victory at Barkau, but do not speak with any certainty, either of the Siege of Gran or Canisla.

Brussels, November 2. We have an account from Mons, that on Friday last 15 or 16 Squadrons of French Horse appearing within Cannon Shot of that place, the Governor caused several Pieces of Cannon to be discharged at them; and sent out a Party of Horse and Dragoons, who skirmished with them, and some were killed and wounded on both sides; but in the mean time the French raised their Contributions in the adjacent Villages, and pillaged those that refused. The Marechal de Humieres decamped on Sunday last very early in the Morning from *Leslignes*, and marched towards *Leuze* and *Renay*: He sent out a great Detachment towards *Audenarde*, and another towards *Courtray*; which last place it's believed will be attacked: This is certain, that great Preparations are made at *Tournay* for a Siege, and that all the Carriages on that side of the Country, have been summoned thither. Upon this news the Prince de *Vaudemont* parted from hence yesterday Morning by break of day with 400 Spanish Horse, and having joyned the Dutch Horse and Dragoons at *Humbeck*, continued his march towards *Flanders*; and our Maistre de Camp General, is likewise abroad with the Troops he has drawn out of *Ghent*, to observe the motions of the French. We have Letters from the Imperial Camp in *Hungary* of the 18th instant, which tell us, that they had not yet undertaken the Siege of *Gran*, the Garrison whereof has been lately considerably reinforced: That they as well as the Poles were still encamped on this side the *Danube*, not far from *Barkan*; that 3000 Horse had passed the River, and advanced to the Suburb of *Gran*, and set fire to it; that the Turks made a Sally out of the Town, and skirmished with the Christians, but were beaten home again, and several of them taken Prisoners. And that they had advice that the Grand Visier being reinforced with a considerable Body of fresh Troops, was encamped between *Buda* and *Stoel-Weissembourg*.

Hague, October 30. The Sieur *Roucke* Envoy Extraordinary from the Elector of *Brandenburgh*, parted from hence two days ago for *Berlin*, where, if not at *Potsdam*, there will be very suddenly an Entertainment between their Electoral Highnesses of *Brandenburgh* and *Saxony*. The Master of a Vessel which arrived the 28th instant at *Amsterdam* from the Eastward, reports, he met the Fleet of this State, consisting of twenty Sail, off *Sebagen*, and that they took their course towards *Gottenburg*. Our Letters from *Vienna* tell us, that there being a great Scarcity of Forage in *Hungary*, 20 or 22000 Horse would be sent towards the *Rhine* to winter there.

Hague, Novemb. 2. The States of *Holland* are again Adjourned till Thursday next, and in the time the Deputies are gone home; when they meet again it's believed they will come to a final Resolution in the matter of the new Levy. The Prince of *Orange* is gone to the *Veluwe* to Hunt, but will be back against Thursday. It's said our Fleet is arrived at *Gottenburg*,

Paris, October 30. We have advice that the Chevalier de Breuille is arrived at *Brest*, with the Squadron of Men of War under his Command from the South. The Marechal de Crequi is gone to his Government of *Lorraine*. The Sieur Heintius Envoy Extraordinary from the States General of the United Provinces, had two days since, his Audiences of leave of the King, the Dauphin, &c. being conducted thereunto by Monsieur de Boneil Introducer of Ambassadors.

Westminster, Octob. 27. This day Aron Smith, who was some time since convicted, upon an Information, for contriving and delivering most scandalous and libellous Instructions in Writing, to Stephen Colledge, to be used at his Trial at Oxford; and for speaking very scandalous and lewd Words in the Court at the said Trial, and fled for the same; being lately apprehended, was brought to the Kings-Bench-Bar to receive the Judgment of the Court, upon his said conviction; which was, That he pay a Fine of 500 pounds, and stand in the Pillory before Westminister-Hall gate, and before the Royal Exchange in London; That he find Sureties for the Good-behavior for a Year; and that he remain in Prison till this be done.

HIS Majesty has been graciously pleased, upon the surrender of the Charter of Northampton, not only to Regrant them their former Liberties, Priviledges, Lands, Tenements, Goods and Chattels, but likewise as a particular Instance of his Royal Favour, to Grant them a Market for all sorts of Cattel, to be held the first Thursday of every month throughout the year, and the said first Market is to be held and begun on the first Thursday in January next. The Loyal Society who did keep their meeting at the Sign of the White Horse in Fullers Kents, have thought fit to remove from thence to the Kings Arms Tavern over against St. Clements Church in the Strand, of which the Members of the said Societ., who were absent on the 26th instant, when this Resolution was taken, are desired to take notice.
