A PROCLAMATION.

WILLIAM, R.

WHEREAS by the advice of Our Council, We did ordain a certain Parliament to be holden at Our City of Westminster, on Tuesday the fourteenth day of September next; We, with the advice of our Privy Council, do hereby publish and declare, that Our said Parliament shall be prorogued, from the said fourteenth day of September next, to Tuesday the twenty-sixth day of October next; and We have given order to Our Chancellor of that part of Our United Kingdom called Great Britain, to prepare a writ patent for proroguing the same accordingly; and We do further hereby, with the advice aforesaid, declare Our Royal Will and Pleasure, that the said Parliament shall, on the said twenty-sixth day of October next, be held and sit for the dispatch of divers urgent and important affairs: And the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgesses, and the Commissioners for Shires and Burghs of the House of Commons, are hereby required and commanded to give their attendance accordingly, at Westminster, on the said twenty-sixth day of October next,

Given at Our Court at St. James's, the twenty-sixth day of August one thousand eight hundred and thirty, and in the first year of Our reign.

To His Most Excellent Majesty WILLIAM the FOURTH, KING of the United Kingdom of Great Britain and Ireland, &c. &c. &c.

May it please your Majesty,

WE, the Chaplain and Churchwardens of the English Episcopal Church in the City of Amsterdam, all British subjects, in our names and in behalf of our Congregation, most humbly beg leave to approach your Majesty with our sincere condolence at the lamented demise of our late Sovereign, your Royal Brother, of blessed memory, and to congratulate your Majesty on the accession to the Throne of your Ancestors, filled by them with so much honour, and under whose auspicious reigns the prosperity and glory of our beloved country have been so much advanced. Though dwelling in a foreign land, our hearts still remain English, and we exult in the name of Englishmen.

We pray Almighty God that your Majesty's reign may be long and increasingly prosperous, and that he

would pour down his blessings on your Government for the welfare of our nation, for your own individual happiness, and that of your Royal Consort, our most gracious Queen.

We most humbly claim your Royal protection of our Church Establishment in this City, which has so much conducted by its existence to maintain the character of our country.

We are, with the most profound veneration, and hearts glowing with true English feeling, your Majesty's most loyal subjects, &c.

To His Most Excellent Majesty KING WILLIAM the FOURTH.

The humble Address of the National Scottish Church in Rotterdam.

Sire,

WE, your Majesty's most dutiful and loyal subjects, the Ministers, Elders, and Deacons of the National Scottish Church at Rotterdam, in our own name, and as representing the most numerous British congregation in the Netherlands, presume respectfully to address your Majesty on your accession to the British Throne.

Kindled by distance of place, by a proportionally higher glow of loyal attachment to your Royal Person, we approach your Majesty, to offer our most sincere condolence on the lamented death of our late most gracious Monarch, George the Fourth,—a Sovereign, whose personal worth and brilliant reign will be long held in grateful remembrance.

Deprived by Providence of a King so justly dear to us, we heartily bless God for having raised up in the person of your Majesty a Prince so admirably fitted and disposed to maintain and perpetuate the renown of the illustrious House of Brunswick.

Imbued from your earliest years with the best principles, and brought up from your youth in enduring the hardships and in sharing the glory of Britain's most disinterested and meritorious sons; and happily united with a Queen Consort, the possessor and the pattern of every desirable quality in her sex, your Majesty ascends the Throne of your revered Ancestors under the most favourable auspices; and your gracious condescending manners; and the few, but conspicuous and significant acts of your reign, just begun, have already procured for your Majesty a degree of popularity rarely attained by Sovereigns, and which we, with our fellow-subjects at home, hail as the guarantee of increasing usefulness and prosperity.

That the God, by whom Kings reign and Princes decree justice, and who always honours those who honour him, may, by his effectual energy, crown with abundant success your Majesty's pious and patriotic designs; that the choicest blessings of Heaven may descend in rich abundance upon your Majesty and your Royal and beloved Consort; that your reign may be long and glorious, is the fervent prayer of your Majesty's most dutiful Scottish Presbyterian subjects in Rotterdam, whose unremitting exertions

shall not be wanting to ensure the approbation of their native Prince, to whose generous and fostering protection they humbly recommend their ancient Ecclesiastical Establishment in this City.

enacted, "that in every case in which the Commissioners appointed for carrying into execution the purposes of the said Act, shall be of opinion that it will be expedient to divide any parish into two or more distinct and separate parishes, for all ecclesiastical purposes whatever, it shall be lawful for the said Commissioners, with the consent of the Bishop of the diocese in which such parish is locally situated, signified under his hand and seal, to apply to the patron or patrons of the church of such parish for his or their consent, to make such division, and for such patron or patrons to signify his or their consent thereto, under his or their hand and seal, and the said Commissioners shall, upon the consent of the said patron or patrons so signified, represent the whole matter to His Majesty in Council, and shall state in such representation the bounds by which it is proposed, with such consent as aforesaid, to divide such parish, together with the relative and respective proportions of glebe land, tithes, moduses, or other endowments, which will by such division arise and accrue, and remain, and be within each of such respective divisions, and also the relative proportions of the estimated amount of the value or produce of fees, oblations, offerings, or other ecclesiastical dues or profits which may arise and accrue within each of such respective divisions; and if thereupon His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting such division; provided always that no such division of any parish into distinct parishes shall completely take effect until after the death, resignation, or other avoidance of the existing incumbent of the parish to be divided;" And whereas by the said Act it is further enacted "that in any case in which the said Commissioners shall be of opinion that it is not expedient to divide any populous parish or extra parochial place into such complete, separate, and distinct parishes as aforesaid, but that it is expedient to divide the same into such ecclesiastical districts as they, with the consent of the Bishop, signified under his hand and seal, may deem necessary for the purpose of affording accommodation for the attending divine service, according to the rites of the United Church of England and Ireland, to persons residing therein, in the churches and parochial chapels already built, or in additional churches or chapels to be built therein, and as may appear to such Commissioners to be convenient for the enabling the spiritual person or persons who may serve such churches or chapels to perform all ecclesiastical duties within the districts attached to such respective churches and chapels, and for the due ecclesiastical superintendance of such district, and the preservation and improvement of the religious and moral habits of the persons residing therein, the said Commissioners shall represent such opinion to His Majesty in Council, and shall state in such representation the bounds by which such districts are proposed to be described; and if, thereupon, His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting such division:" And whereas by an Act passed in the 59th year of the reign of His late Majesty King George the Third, intituled "An Act to amend and render more effectual an Act passed in the last session.
