HEREAS by an Act, passed in the fiftyseventh year of the reign of His late Majesty King George the Third, intituled " An Act to "empower His Majesty to suspend the training "and regulate the quotas of the militia," it is enacted, that it shall be lawful for His Majesty, by any Order or Orders in Council, to suspend. the calling out of the militia of the United Kingdom, or of any part of the United Kingdom, or of any county, riding, shire, stewartry, city, town, or place, for the purpose of being trained and exercised in any year, and to order and direct that no training or exercising of the militia of the United Kingdom, or of any part of the United Kingdom, or of any county or counties, riding or ridings, shire or shires, stewartry or stewartries, city or cities, townor towns, or place or places, specified in any such Order or Orders in Council, shall take place in any year, any thing contained in any Act or Acts of Parliament relating to the militia to the contrary notwithstanding: and whereas it is deemed expedient. that such training or exercising should be dispensed with in the present year; it is ordered by His Majesty, by and with the advice of His Privy Council, that the calling out of the militia of that part of the United Kingdom called Great Britain, for the purpose of being trained and exercised in the present year, be suspended; and that no training or exercising of the said militia do take place in the present year.

HEREAS by an Act, passed in the fiftysixth year of the reign of His late Majesty King George the Third, intituled "An Act to " empower His. Majesty to suspend the ballot or enrolment for the local militia," it is enacted, that it shall be lawful for His Majesty, by any. Order in Council, to direct that no ballot or enrolment for the local militia shall take place, but that such ballot and enrolment shall remain and continue suspended for the period specified in any such Order in Council, and from time to time by any like Order or Orders in Council, to continue such suspension as long as His Majesty shall deem the same expedient, any thing in any Act or Acts of Parliament to the contrary notwithstanding; and whereas by an Order in Council, made the sixteenth day of July one thousand eight hundred and twenty-nine, it was ordered by His late Majesty in Council, that no ballot or enrolment for the local militia should take place for the space of one year from the said sixteenth
