And those Gentlemen who are to be presented are hereby informed, it is absolutely necessary that their names, with the name of the Gentleman who is to present them (not the Lord in Waiting), should be sent in to the Lord Chamberlain's-Office, before twelve o'clock on Monday next the 22d instant, in order that they may be submitted for the King's approbation; it being His Majesty's command, that no presentation shall hereafter be made at the Levee, but in conformity with the above regulations; and further, that no person shall be admitted, on any pretence uhatever, who has not been so presented.

It is particularly requested, that Gentlemen who are to be presented at the

Levee will have their names distinctly written upon the card delivered to the Lord in Waiting, in order that there may be no mistake in announcing them to the King.

The state apartments will not be open for the reception of company coming to Court, until half past one o'clock.

The humble Address of the Portrieve and Corporation of Ardfert, in the County of Kerry.

Most Gracious Sovereign,

WE, your Majesty's most dutiful and loyal subjects, the Portrieve, Burgesses, and Freemen of Ardfort, in the County of Kerry, beg leave to approach your Majesty, to offer our condolence on the death of your Brother, our late Sovereign; and our congratulations on your accession to the Throne of these

realms

Dutifully and zealously attached to the illustrious House of Hanover, we yet looked up with more peculiar feelings of admiration to your venerable Father; and the first claim of His late Majesty, on the love and respect of his subjects, was the manner in which he followed up the measures of King George the Third, to uphold the honour and safety of the empire, in the awful contest in which we were then engaged, measures which ultimately were growned, through the favour of heaven, by the overthrow of the most powerful and implacable foe that ever attempted our destruction, which have left the annals of the Regency, the most splendid era in the history of the empire.

These, Sire, are feelings, which we share in common with all the subjects of His late Majesty, but, as Irishmen, we have others, more local, though not less warm. From the earliest period of his life, he was pleased at all times to give the strongest proofs of his personal interest for this country, and in the visit which he condescended to pay to Ireland, he was the first English Sovereign who sought our shores, as the friend and father of our country, and whose joy was to be derived, not from the conquest or the oppression, but from the reflected happiness of his

Trish subjects.

In the bereavement of such a Monarch, we have the strongest consolation, that the Throne is filled by one, who inherits all the desire of his Father and his Brother, to uphold the honour and dignity of the empire, and who has already shewn how much he can promote the happiness and the welfare of his people We beg your Majesty will believe, that we are duly sensible of your many claims, on the love, as well as loyalty, of all your subjects; and we sincerely offer up our most earnest prayers to heaven, that you may enjoy many, many years of health and happiness with your excellent Consort, our most gracious Queen. We remember also, that your Majesty is not a stranger to Ireland, and we trust that, when time may permit, you will renew your personal acquaintance with your Irish people, whose lives and whose affections are equally your 'Majesty's property, and at your Majesty's command

CAPTAIN GORDON, of His Majesty's Ship Atholl, has transmitted to the Right Honourable John Wilson Croker, a Letter from Commander William Broughton, of His Majesty's Sloop Primrose, to Captain Gordon, dated at the Island of Ascension, 5th October 1830, of which the following is an extract:

"Proceeding in execution of your orders of the 3d September, I had the good fortune to fall in at 11. 30. P. M. on the 6th of that month, with the Spanish ship Velos Passagera, Jose Antonio de la Vega Master, from Wydah, bound to Havannah, pierced for 28 guns, but having only 20 mounted; and from the Officer whom I sent to board her not being allowed to examine her below, as usual, I concluded she had slaves on board. Finding I had much the advantage of her in sailing, and wishing to avoid the effusion of blood by a night action with a Vessel crowded with slaves, I remained by her until morning, when, being within hail, and still resolutely refused permission to search her, we opened our fire, which she returned immediately, the ships nearly touching each other; after the second broadside, we laid her on board, and in ten minutes carried her, with a loss on our side of 3 killed, and 12 wounded; the Velos had. as I could ascertain 150 men, of different nations, and having on board 555 slaves, 5 of whom were killed.

Being myself wounded in the act of boarding, my place was ably taken by Lieutenant Butterfield, seconded by Acting Lieutenant Foley, Mr. Fraser, Acting Master, and Mr. Bentham, Midshipman, to each of whom I feel deeply indebted for their zealous exertions; as also to Mr. Williamson, Acting Purser, who rendered his services on deck during the action; and I feel myself called upon to notice in particular the conduct of the Acting Surgeon, Mr. Lane, who, though dangerously ill, exerted himself in an extraordinary manner in his attention to the wounded, having no Assistant on board. I cannot speak too highly in praise of the gallantry and good conduct of the Warrant and Petty Officers and Ship's Company, who distinguished themselves not only for their steadiness in action, but for their great personal exertions in refitting the two ships afterwards.
