And those Ladies who are to be presented are hereby informed, that it is absolutely necessary that their names, with the name of the Lady who is to present them, should be sent in to the Office of the Lord Chamberlain to the Queen, before four o'clock on Tuesday the 22d of March instant, in order that they may be submitted for the Queen's approbation, it being Her Majesty's command, that no presentations at the Drawing-Room shall be made through the Lord Chamberlain, anless the name of the Lady presenting, with that of the Lady to be presented, shall appear on the card to be delivered, as before directed, corresponding with the names sent in to the Office of the Lord Chamberlain to the Queen.

No Lady can be received by Her Majesty, but in conformity with the above regulations.

To the KING's Most Excellent Majesty. Most Gracious Sovereign,

WE, your Majesty's dutiful and loyal subjects, the Bishop and Clergy of the Established Church in the Provinces of Upper and Lower Canada, conremote dependency of your Majesty's Empire, to offer our tribute of condolence to your Majesty upon

the demise of your late Royal Brother.

While we lament, in common with all our fellow-subjects, the stroke of Providence which has removed from the earth a Prince whose regency and reign have added new splendour to the glories of British history, and the blessings of whose paternal government were amply extended to this portion of his dominions, we at the same time lay at the feet of your Majesty our humble but heartfelt congratulations upon your happy accession to the Throne of your Ancestors, and we offer up our fervent prayers to the King of kings for the prosperity of your Majesty's reign.

We feel our homage to be especially due to your Majesty upon this occasion, as the temporal head of the church, of which we form a part, as established in these provinces by your Majesty's late Royal Father, of blessed memory, and fostered by the encouragement and protection of his illustrious suc-

The humble and dutiful Address of the undersigned Inhabitants of the Ward of Bishopsgate, in the City of London, in Ward Meeting assembled,

Showeth,

THAT we, your Majesty's loyal and dutiful Inhabitants of this Ward, having so lately, in their petition to the House of Commons, delivered their opinion on the necessity of a speedy and effectual reform in that Honourable House, and having since seen a plan introduced, with your Majesty's approval, for realizing the hopes and gratifying the desires of the people, take this, the earliest, opportunity of humbly expressing our satisfaction at the principles of the proposed reform, and our unbounded gratitude to your Majesty for bringing under the consideration of Parliament, the removal of a grievance the nation has so long and so heavily suffered.

That, in answer to a calumny, charging advocates of parliamentary reform with seeking revolution under that name, we humbly, but honestly and conscientiously, declare our unalterable love and attachment to the Constitution, composed of King, Lords, and Commons; but, while prepared to defend the prerogatives of the Crown and the just privileges of the Peers, we are no less determined to uphold the rights of the people in obtaining a more equal, free, and independent representation in the Commons House of Parliament.

That the opponents of reform having openly declared, that the people are generally indifferent to the question, and that the desire, where it does exist,

is ephemeral and will speedily subside, we beg humbly to express our belief, that such declarations are the feeble emanations of falsehood and ignorance; but should the widely diffused corruption of the times enable its minions to defeat the wise and salutary views of your Majesty and your Majesty's Government, then we beseech your Majesty to dissolve the Parliament, and afford the people an opportunity of shewing how little they who slander them know the feelings of their countrymen, when they represent them so callous to distress, so utterly unworthy of freedom and all its attendant blessings, having pledged ourselves to vote no man our Representative, however deserving in other respects, who will not solemnly engage to support your Majesty's Ministers in their endeavours to carry through Parliament the plan of reform so ably and honourably brought forward with your Majesty's approval, arising, as it does, out of your Majesty's paternal feelings towards your people. And your humble and dutiful subjects will ever pray.

The humble Address of the Inhabitants of the Town of Birmingham, in Town's meeting assembled.

Sire.

WE, your Majesty's dutiful and loyal subjects, the Inhabitants of the Town of Birmingham, in Town's meeting assembled, beg leave humbly to approach your Majesty, for the purpose of expressing the deep and sincere gratitude which we feel towards

your Majesty's Royal Person, for the wise, judicious, and comprehensive measures of parliamentary reform, which your Majesty, in your paternal solici-tude for the welfare of your people, has graciously authorized your Ministers to propose to parliament. We are perfectly convinced that the success of those great measures is indispensably necessary to the restoration of the national prosperity, and to the preservation of the peace and order of society. But a few weeks ago the minds of your Majesty's faithful and loyal people were involved in painful anxieties, and filled with deep and gloomy forebodings. The measures of your Majesty's Government have dissipated these painful apprehensions, and spread universal satisfaction throughout the country; we humbly tender to your Majesty the expression of our dutiful and grateful attachment to your Royal Person, and of our determination to support your Majesty's government to the utmost of our power. We implore the Almighty to prosper your Majesty's great and patriotic designs, and to preserve your Majesty's life, that your Majesty may long have the gratification of witnessing the happiness of a free, grateful, and loyal people.

To His Most Gracious Majesty KING WILLIAM the FOURTH.

Sire,

SECOND to no one in attachment to your Majesty's Person and Government, to the illustrious House of Brunswick, in love of my country, or in zeal for the restoration of the original purity of the British Constitution; admiring, in common with my countrymen, those princely, wise, and liberal feelings for which you are so distinguished, as the organ and at the request of the undernamed Magistracy and dignified Clergy, and also near fourteen thousand individuals of all classes, I humbly, but honestly and respectfully, proceed (with your Majesty's gracious permission) on behalf of so many inhabitants of the country of Wilts to declare their warm and sincere attachment to your Majesty's person, to the Royal Family, and to the Constitution of this Country as by law established at the glorious revolution in 1688.

That they have for a length of time viewed with apprehension and alarm the many and increasing encroachments made upon the rights and liberties of the people in consequence of the undue and unconstitutional influence exercised by some of the Aristogracy, arising, principally, from their increasing possession of the decayed boroughs, at the election of members, and on their votes in the Commons' House of Parliament

That they consider the effect of such influence to have been the principal cause why the Ministers of the Crown have hitherto resisted every measure of substantial reform, and also those of economy and retrenchment, so necessary to be rigidly enforced in every department of the public service, the consequence of which has been, that the country continues burdened, after fifteen years of profound peace, with a weight of taxation (direct and indirect) which has

produced great distress and excitement in this once

happy and peaceful country.

They beg most respectfully and humbly to request the exercise of your Majesty's authority to obtain for them an immediate remission of those taxes which are most felt by the labouring and industrious classes, such as the imposts on malt, soap, and candles, with a reduction of those on tea and sugar; they are also desirous of the repeal of the whole of the assessed taxes, and instead thereof, that the necessities of the State should be supplied by a graduated property tax, which would relieve the farmer and tradesman, enable them to give more employment to the industrious classes, and, where necessary, to increase the rate of wages.

That they look forward with hope and confidence to the ministry just formed under the auspices of your Majesty (combining, as it does, so many men of rank and talent who have on many occasions proved themselves the friends of the people) and doubt not they will have your Majesty's sanction and support in the attempt to remedy (as far as is consistent with the safety of the State) the evils complained of, which will insure to them the united and determined support of those on whose authority I presume to deliver this Address, forming a large portion of the brave, patient, industrious, spirited,

and still loyal population of Wiltshire.

Should the great measure of reform in Parliament which now agitates all classes in the State, prove full and efficient, it will never be forgotten that for so happy a change to you, Sire, would your people be indebted; you would unite all hearts in affection and gratitude, and thus, besides being the most powerful and generous, you would be the most happy of Sovereigns.

Having thus, with deep felt respect, discharged my duty to my Country, and to a Sovereign who I pray God may long continue to reign over us, I humbly subscribe myself your Majesty's most du-

- To the KING's Most Excellent Majesty.

WE, your Majesty's loyal and dutiful subjects, the undersigned Magistrates, Clergy, Merchants, Bankers, Householders, Freeholders, Free Burgesses, and Inhabitants of the City of Bristol, and its vicinity, alarmed at the dangers to which the country is exposed by the spread of revolutionary principles, and anxious to avert, as much as in us lies, the calamities which a reckless spirit of innovation is labouring to draw down upon this hitherto favoured land, intreat permission most respectfully to submit to your Majesty, in this our loyal and dutiful address, the reasons of our appeal, and the grounds upon which our apprehensions are founded.

In the present disturbed state of the country, when every artifice is practised to inflame the passions of the people and to diffuse discontent and dissatisfaction through the land, to which a licentious press has but too successfully contributed, we con sider it to be our duty, as loyal subjects, to raise our warning voice against that fatal error,—fatal indeed, if it should prevail within the walls of Parliament,—which would lead to the belief that a popular clamour thus industriously excited for revolutionary innovations under the pretext of reform expresses the sense of the nation.

From the public meetings which have of late been holden for this purpose, as well as from those convened for voting congratulatory addresses on successful revolution abroad, the loval and thinking classes of society have, for the most part, studiously absented themselves; such proceedings, whatever might be the views of the promoters, having a manifest tendency to the encouragement of discontent, the disturbance of the public peace, and, in their ultimate consequences, to the destruction of the balance of power vested by the Constitution in the three branches of the Legislature, upon which depends the preservation of our rights and liberties as subjects.

To our admirable form of government, as composed of King, Lords, and Commons, we are from every feeling of principle and conscience devotedly attached, convinced that of all political systems ever planned by human wisdom for insuring the rights, the liberties, and the general happiness of the subject, it is the most perfect and complete.

But greatly as we prize this inestimable birthright of Britons, we do not deny that it is, like all human institutions, subject to abuses and imperfections. Such defects, as they arise, it is our desire to see corrected: this, however, should be effected with caution, and in the spirit of the Constitution; all rash and ignorant attempts at improvement we deprecate, as endangering the whole fabric of our government; and, above all, we deprecate those theoretical and speculative innovations in the Constitution which, by the introduction of new elements therein, would be destructive of its very form and character.

The pre eminence of the Protestant religion established within these realms we consider to be a main and essential principle of the Constitution; it is the basis of the national morals, and the prime source, under heaven, of the superior degree of civilization and prosperity which has so long distinguished this country above all the nations of Europe. Whatever, therefore, has a tendency to depress or weaken that pre-eminence will ever receive our determined and uncompromising opposition.

The open exercise of the elective franchise is another essential feature of our laws. That it is subject to abuse we readily admit; but the substitution of vote by ballot, so far from operating as any renedy against bribery and corruption, it is easy to perceive would increase the evil ten-fold. It would give to treachery and falsehood the protection of concealment. Instead of the present open and manly exercise of the prondest privilege of the subject, would be substituted the dark and secret machina-

tions of conspiracy and cabal, a mode of proceeding not less repugnant to the feelings of free men than opposed to the spirit of the Constitution, and leading in the end to a most degrading and fatal change in the national character,

Intimidation is another objection which has been prominently brought forward in the outcry against our representative system. That it exists to any considerable extent we utterly disbelieve. The character of Britons, and the shame and odium attendant upon flagrant acts of oppression, are the best security against its general prevalence. The influence which the possession of rank or property naturally gives over the regards and attachment of those to whom it affords the means of employment and subsistence, so far from being an evil in itself, is one of the surest tests of the sound moral state of society; and that, surely, would be a miscrable policy which, with the view of remedying a partial abuse, would sever those ties of mutual protection and dependance, which, uniting the upper and lower classes of society in a bond of kindly and affectionate connection, form the best safeguard of social order,-and this we submit would be the inevitable effect of any enactment establishing the vote by ballot.

This innovation is further to be deprecated as being a preliminary step to the next object of radical reform—universal suffrage; and as thus tending by gradual but certain progression to the final consummation of the work of destruction—a total subversion of the Monarchical and Aristocratical parts of our Constitution.

That such would be the issue of these democratical innovations the evidence of all history attests. Our duty therefore to our King, our attachment to the two Houses of Parliament, and our jealous anxiety to preserve inviolate their respective prerogatives and privileges, forbid us to look with indifference upon changes pregnant with such fearful and fatal consequences to the State.

For these reasons, in the memorable words of our ancestors, but in the qualified sense already explained,—"We are unwilling that the laws of England should be changed." For these reasons, we most earnestly implore that in the measures to be adopted for effecting any amendments in our representative system which lapse of time or a change of circumstances may render expedient, your Majesty will not sanction the admission of any novel and visionary principles opposed to the spirit of our Constitution, and dangerous to its stability. And, more especially, we pray that all attempts to introduce any new laws for the establishment of vote by ballot, or universal suffrage, may be met by a firm and decisive rejection.

In making this our dutiful appeal to your Majesty as the head of the State and the ultimate guardian of our civil rights and liberties, we intreat permission to renew the assurances of our inviolable loyalty and attachment.
