**A**N Address from the Inhabitants of the Ward of Vintry, in the City of London, in favour of Parliamentary Reform, has been laid before His Majesty, and graciously received.

**A**T the Court at *St. James's*, the 23d day of *March 1831*,

PRESENT,

The KING's Most Excellent Majesty in Council.

**H**IS Majesty, by and with the advice of His Privy Council, is hereby pleased to withdraw, and doth hereby withdraw, so much of His Majesty's Royal Proclamation, dated at *St. James's* on the twenty-third of November, in the first year of His Majesty's reign, as declares that rewards, of fifty pounds and five hundred pounds respectively, shall be paid for the detection of offenders therein described; and His Majesty doth, by and with the advice aforesaid, hereby declare, that no such reward will be paid for any information which may be given respecting such offenders, from the date of this Order.

**A**T the Court at *Brighton*, the 31st day of *January 1831*,

PRESENT,

The KING's Most Excellent Majesty in Council.

**W**HEREAS by an Act, passed in the sixth year of the reign of His late Majesty King George the Fourth, intituled "An Act to regulate the trade of the British possessions abroad," it is, amongst other things, enacted, that certain ports, therein particularly mentioned, in the island of Jamaica, and in the provinces of Nova Scotia, Canada, and New Brunswick, and in the island of Barbadoes, shall be free warehousing ports for the purposes of the said Act; and it is further enacted, that it shall be lawful for His Majesty in Council, from time to time, to appoint any port in His Majesty's possessions in America to be a free warehousing port for the purposes of the said Act; and that every such port, so appointed by His Majesty, shall be a free warehousing port under the said Act, as if appointed by the same, in as full and ample a manner in all respects as any of the ports thereinbefore mentioned are free warehousing ports appointed by the said Act:

And whereas His Majesty doth deem it expedient, that the port of Saint George, in the island of Grenada, should be appointed a free warehousing port for the purposes of the said Act, His Majesty doth therefore, by and with the advice of His Privy Council, and in pursuance and exercise of the powers in him vested in and by the said Act of Parliament, order and appoint, that the said port of Saint

George, in the island of Grenada, shall be a free warehousing port for the purposes of the said Act:

And the Right Honourable the Lords Commissioners of His Majesty's Treasury, and the Right Honourable Viscount Goderich, one of His Majesty's Principal Secretaries of State, are to give the necessary directions herein as to them may respectively appertain.

The King has been pleased to grant unto Henry Jelf, Esq. a Captain in the Army (third son of Sir James Jelf, of Oaklands, in the county of Gloucester, Knt. and to Clarissa-Amelia Sharp, of Kincarrochy, in the shire of Perth, in North Britain, spinster, His royal licence and authority that, from and after the solemnization of their intended marriage, they may (in compliance with a proviso contained in a deed of entail-made and executed by James Sharp, late of Kincarrochy aforesaid, Esq. deceased, sometime a Lieutenant-Colonel in the Army) assume, use, bear, and constantly retain the surname of Sharp, in addition to and after that of Jelf, and the designation of Kincarrochy; and that the said Henry Jelf may also bear the arms of Sharp, quarterly with those of Jelf; and that the said surnames and arms may in like manner be borne and used by the issue of their marriage; such arms being first duly exemplified according to the laws of arms, and recorded in the Heralds' Office, otherwise the said royal licence and permission to be void and of none effect:

And also to command, that the said royal concession and declaration be registered in His Majesty's College of Arms.
