REGULATIONS TO BE OBSERVED AT THE KING'S LEVEES, AT ST. JAMES'S-PALACE.

The Noblemen and Gentlemen who propose to attend His Majesty's Levees at St. James's-Palace, are requested to bring with them two cards with their names thereon written, one to be left with the King's Page in attendance in the Presence-Chamber, and the other to be delivered to the Lord in Waiting, who will announce the name to His Majesty. And those Gentlemen who are to be presented are hereby informed, it is absolutely necessary that their names, with the name of the Gentleman who is to present them (not the Lord in Waiting), should be sent in to the Lord Chamberlain's-Office, before twelve o'clock on the Monday previous to each Levee, in order that they may be submitted for the King's approbation; it being His Majesty's command, that no presentation shall hereafter

be made at the Levee, but in conformity with the above regulations; and further, that no person shall be admitted, on any pretence whatever, who has not been so presented.

It is particularly requested, that Gentlemen who are to be presented at the Levees will have their names distinctly written upon the card to be delivered to the Lord in Waiting, in order that there may be no mistake in announcing them to the King.

The state apartments will not be open for the reception of company coming to Court, until half past one o'clock.

N Address from the Bailiffs and Inhabitants of the Town and Parish of Brading and Vicinity thereof, in the Isle of Wight, thanking His Majesty for having dissolved the late Parliament, has been laid before His Majesty, and graciously received.

At the Court at St. James's, May 27, 1831.

A Chapter of the Most Noble Order of the Garter having been summoned for this day, the following Knights Companions, in their mantles and collars, assembled in the Entrée-room, viz.

His Royal Highness the Prince Leopold of Saxe Coburg, the Earl of Westmorland, the Duke of Rutland, the Duke of Beaufort, the Duke of Dorset, the Duke of Devonshire, the Marquess of Exeter, and the Duke of Richmond, attended by the Officers

of the Order, in their mantles, chains, and badges, viz. the Lord Bishop of Winchester, Prelate of the Order; the Lord Bishop of Salisbury, Chancellor of the Order; the Honourable and Reverend the Dean of Windsor, Register of the Order; Sir George Nayler, Knight, Garter Principal King of Arms; and Sir Thomas Tyrwhitt, Knight, Gentleman Usher of the Black Rod.

At three o'clock, the Knights Companions were called over by Garter, and, with the Officers of the Order, proceeded into the presence of the Sovereign, in the Throne-room.

The Sovereign being seated in the chair of state, the Knights Companions took their respective seats at the table according to the order of their stalls, and the Officers of the Order stood in their accustomed places.

By command of the Sovereign, Earl Grey was then introduced into the Royal Presence, preceded by Garter and Black Rod, and was knighted by His Majesty with the sword of state, after which his Lordship, having kissed the Sovereign's hand, retired.

Then the Register (acting for the Chancellor of the Order), by the Sovereign's command, read a new statute, setting forth that His Majesty, being desirous of evincing in an especial manner his gracious , approbation of the distinguished and eminent merits and services manifested and rendered to His Majesty by His Right Trusty and Right Well-beloved Cousin and Councillor, Charles Earl Grey, First Lord of His Majesty's Treasury, was pleased, in virtue of the power and authority inherent in him as Sovereign, to dispense with all statutes and regulations observed within this Most Noble Order, and particularly with the statute whereby the number of Knights Companions is limited, in as far as may be requisite for the especial purpose of admitting the said Earl into the said Order, and to decree, ordain, and enjoin, that the said Charles Earl Grey be declared a Knight of this Most Noble Order, any statute, decree, rule, or usage to the contrary notwithstanding.

The Chancellor having accordingly announced to the Chapter, that Charles Earl Grey had been declared a Knight of the Most Noble Order of the Garter, his Lordship was received at the door of the Chapterroom by the Marquess of Exeter and the Duke of Richmond, the two Junior Knights Companions present, and was conducted between them to His Majesty, preceded by Garter (bearing the ensigns of the Order upon a crimson velvet cushion) and by Black Rod. The Earl, kneeling near the Sovereign, and Garter presenting on his knee the Garter, His Majesty; assisted by His Royal Highness the Prince Leopold of Saxe Coburg and the Earl of Westmorland, the two Senior Knights Companions present, buckled it on his Lordship's left leg, the Chancellor pronouncing the usual admonition.

Garter next presented, in like manner, the ribband with the George, and His Majesty, with the assistance of the said two Knights Companions, put the same over Earl Grey's left shoulder, the Chancellor pronouncing the admonition; after which his Lordship had again the honour to kiss the Sovereign's hand.

Then the Register read a statute, reciting that whereas the number of Knights Companions of this Most Noble Order was limited in manner set forth in the statutes, and His Majesty having, in virtue of the power inherent in him, thought fit, for divers high reasons and considerations him thereunto especially moving, to dispense with the said statutes, and to declare His faithful Subject and Councillor, Charles Earl Grey, to be a Knight of the said Order, thereby increasing the number of Knights Subjects, not being of the Blood Royal, it is nevertheless His Majesty's intent and meaning, that no further election of any of His Majesty's subjects, not being of the Blood Royal, into the said Order shall take place, until the vacancy of a stall of a Knight Subject, not of the Blood Royal, shall have happened, subsequent to the reduction of Knights Subjects not of the Blood Royal, to the number directed by the statutes.

Earl Grey thereupon received the congratulations of each of the Knights Companions, and withdrew.

The Chapter being ended, Garter, by command of the Sovereign, again called over the Knights Companions, and a procession was made to the Royal Closet in the same order as before.

At the Court at St. James's, May 27, 1831.

The King, as Sovereign of the Most Noble Order of the Garter, has been graciously pleased, by letters patent under his royal sign manual and the great seal of the Order, bearing date this day, to dispense with all the statutes and regulations usually observed in regard to installation, and to grant unto the Right Honourable Charles Earl Grey, Knight of the said Most Noble Order, and duly invested with the ensigns thereof, full power and authority to exercise all rights and privileges belonging to a Knight Companion of the Most Noble Order of the Garter, in as full and ample a manner as if his Lordship had been formally installed, any decree, rule, or usage to the contrary notwithstanding.
