A Chapter of the Most Noble Order of the Garter having been summoned this day, the following Knights Companions, in their mantles and collars, assembled at the Castle, viz. His Royal Highness the Duke of Cumberland, His Royal Highness the Duke of Sussex, His Royal Highness the Duke of Gloucester, the Earl of Westmorland, the Marquess Camden, the Duke of Beaufort, the Marquess of Hertford, the Duke of Wellington, the Marquess of Hertford, the Duke of Devonshire, the Duke of Richmond, and the Earl Grey, attended by the under-mentioned Officers of the Order, in their mantles, chains, and badges, viz. the Lord Bishop of Winchester, Prelate of the Order; the Honourable and Reverend the Dean of Windsor, Register of the Order; Sir George Nayler, Knt. Garter Principal King of Arms; and Sir Thomas Tyrwhitt, Knt. Gentleman Usher of the Black Rod.

At half past six o'clock the Knights Companions were called over by Garter, and, with the Officers of the Order, proceeded into the presence of the Sovereign, in the Queen's Drawing-room.

The Sovereign being seated on the Throne, and the Knights Companions having taken their respective places, the Prelate of the Order, by command of His Majesty, read a new statute, declaring the Sovereign's royal will and pleasure that this Most Noble Order should in future consist of the Sovereign and twenty-five Knights Companions, together with such lineal descendants of His Majesty King George the First as shall have been elected, and may hereafter be elected into the same.

Then, by His Majesty's command, His Serone Highness the Duke of Saxe-Meiningen, (Brother of Her Most Excellent Majesty the Queen) who, by a statute, bearing date the 17th day of July 1830, had been declared elected into this Most Noble Order, was conducted from the private apartment of His Majesty into the Chapter-room, between their Royal Highnesses the Dukes of Cumberland and Sussex,

the two Senior Knights Companions, preceded by Garter (bearing the ensigns of the Order upon a crimson velvet cushion), and by Black Rod.

Upon entering the Chapter-room, His Serene Highness was received by the Sovereign, and the Knights Companions standing, and was placed in a chair of state on the right hand of the Sovereign.

Garter thereupon, upon his knee, presenting the Garter to the Sovereign, His Majesty, assisted by their Royal Highnesses the Dukes of Cumbérland and Sussex, buckled it on the left leg of His Serene Highness, the Prelate pronouncing the usual admonition.

Garter, in like manner, next presented the ribband with the George, and the Sovereign, assisted as before, put the same over the shoulder of the Duke of Saxe-Meiningen, the Prelate pronouncing the usual admonition.

The Sovereign, thereupon, gave the accollade to His Serene Highness, who also received the congratulations of each of the Knights Companions present.

The Chapter being ended, the Knights Companions were again called over by Garter, and, with the Officers of the Order, withdrew from the presence of the Sovereign, with the usual reverences.

Her Majesty the Queen, their Royal Highnesses the Princesses, their Royal Highnesses the Duchesses of Gloucester, Cumberland, and Cambridge, their Royal Highnesses Prince George of Cumberland and Prince George of Cambridge, Her Serene Highness the Duchess of Saxe-Weimar, the Great Officers of State, the Officers of the Royal Household, and many persons of distinction, were present at this august ceremony.

In the evening a dinner of state was given by the Sovereign, in St. George's-hall, at which the abovenamed Royal, noble, and distinguished personages were present, with the Officers of the Order.

During the banquet the Sovereign was pleased to drink to the health of His illustrious Visitor, His Serene Highness Bernard, Reigning Duke of Saxe-Meiningen, Knight of the Most Noble Order of the Garter; and afterwards to that of Her Serene Highness the Duchess of Saxe-Meiningen.

Their Majesties shortly after proceeded to the Drawing-room, where they were received by a party of Nobility and Gentry specially invited on this occasion
