THIS day, the Lords being met, a message was sent to the Honourable House of Commons by the Gentleman Usher of the Black Rod, acquainting them, that The Lords, authorised by virtue of a Commission under the Great Seal, signed by His Majesty, for declaring His Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An Act to amend an Act of the fifty-second year of the reign of His late Majesty King George the Third, respecting the auditing the public accounts of Ireland, and to appoint the number of Commissioners competent to grant quietus to public ac-countants under an Act passed in the fifty-sixth year of the reign of His Majesty King George the Third, for consolidating the public revenues of Great Britain and Ireland.

An Act to amend several Acts passed for authorising the issue of Exchequer Bills and the advance of money, for carrying on public works and fisheries, and employment of the poor, and to authorise a further issue of Exchequer Bills for the purposes of the said Acts.

An Act to amend an Act of the fourteenth year of His Majesty King George the Third, for establishing a fund towards defraying the charges of the administration of justice and support of the civil Government within the province of Quebec, in America.

An Act to amend the laws relating to hackney carriages and to waggons, carts, and drays, used in the metropolis, and to place the collection of the duties on hackney carriages, and on hawkers and pedlars, in England, under the Commissioners of Stamps

An Act to explain and amend two Acts of the thirty-fourth and thirty-eighth years of His Majesty King George the Third, so far as the same relate to double assessments of the land-tax.

An Act to amend the Acts for regulating turnpikeroads in England, so far as they relate to certain exemptions from toll.

An Act to enable the Treasurer of the county of Clare to issue his warrants for the levying of the presentments made at the spring assizes of the year one thousand eight hundred and thirty-one.

An Act for more effectually improving the road from the Pondyards, in the county of Hertford, to the town of Chipping Barnet, in the same county.

His Majesty doth therefore, by and with the advice of His Privy Council, and in pursuance and exercise of the powers in him vested, in and by the said Act of Parliament, order and appoint, that the said port of Basseterre, in the island of Saint Chsistopher, shall be a free warehousing port for the purposes of the said Act:

W HEREAS by an Act, passed in the sixth year of His late Majesty's reign, intituled "An Act "to regulate the trade of the British possessions "abroad," it is, amongst other things, enacted, that no goods shall be imported into, nor shall any goods, except the produce of the fisheries in British ships, be exported from any of the British possessions in America by sea, or from or to any place other than the United Kingdom, except into or from the several ports in such possessions called free ports, enumerated or described in the table in the said Act of Parliament contained: And it is thereby provided, that if His Majesty shall deem it expedient to extend the provisions of the said Act to any port or place not enumerated in the said table, it shall be lawful for His Majesty, by Qrder in Council, to extend the provisions of the said Act to such port or ports, and it is enacted, that from and after the day mentioned in such Order in Council, all the privileges and advantages of the said Act, and all the provisions, penalties, and forfeitures therein contained, shall extend, and be deemed and construed to extend, to any such port or ports respectively, as fully as if the same had been inserted and enumerated in the said table at the time of passing the said Act :
