#### Westminster, October 15, 1831.

This day, the Lords being met, a message was sent to the Hoñourable House of Com-

mons by the Gentleman Usher of the Black Rod, acquainting them, that The Lords, authorised by virtue of a Commission under the Great Seal, signed by His Majesty, for declaring His Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An Act for appointing Commissioners to continue the enquiries concerning charities, in England and Wales, for two years, and from thence to the end of the then next session of Parliament.

An Act to repeal several Acts, and parts of Acts, prohibiting the payment of wages in goods or otherwise than in the current coin of the realm.

An Act to prohibit the payment, in certain trades, of wages in goods or otherwise than in the current coin of the realm.

An Act to allow the importation of lumber, and of fish and provisions, duty free, into the islands of Barbadoes and St. Vincent; and to indemnify the Governors and others for having permitted the importation of those articles duty free.

An Act to explain and amend an Act, for regulating the receipt and future appropriation of fees and emoluments receivable by Officers of the superior Courts of Common Law.

An Act to amend and render more effectual an Act, passed in the seventh and eighth years of the reign of His late Majesty, initialed "An Act to amend the Acts for building, and promoting the building, of additional churches in populous parishes."

An Act to repeal the laws relating to apprentices and other young persons employed in cotton factorics and in cotton mills, and to make further provisions in lieu thereof.

An Act to repeal so much of an Act for the management of the Customs, as allows certain fees to be taken by Officers of the Customs, and to make further regulations in respect thereof.

An Act for amending and making more effectual the laws concerning turnpike roads in Scotland. An Act to extend the provisions of an Act, passed
