PRESENT,

The KING's Most Excellent Majesty in Council.

HEREAS by an Act, passed in the second year of the reign of His present Majesty, intituled "An Act to allow the importation of lumber, " and of fish and provisions, duty free, into the islands of Barbadoes and St. Vincent, and to in-" demnify the Governors and others for having per-" mitted the importation of those articles duty free," it is enacted, that from and after the passing of the said Act, lumber, and fish and provisions, shall and may be imported into the said islands respectively, duty free, until the first day of January one thousand eight hundred and thirty two; and it is thereby further enacted, that it shall be lawful for His Majesty, by Order in Council, to continue in force the provisions of the said Act until the first day of March one thousand eight hundred and thirty-two; and whereas His Majesty doth deem it expedient to continue in force the provisions of the said Act, His Majesty doth, therefore, by and with the advice of His Privy Council, and in pursuance and exercise of the powers in him vested in and by the said Act of Parliament, order and direct that the provisions of the said Act shall be continued in force until the first day of March one thousand eight hundred and thirty-two:

And the Right Honourable the Lords Commissioners of His Majesty's Treasury, and the Right Honourable Viscount Goderich, one of His Majesty's Principal Secretaries of State, are to give the necessary directions herein as to them may respectively appertain. C. C. Greville.

Whereas on the 19th July 1830, a Convention, between His Britannic Majesty and the Government of the United Provinces of Rio de la Plata, was concluded and signed at Buenos Ayres, for the purpose of establishing a Commission to consider and decide upon all cases that shall be brought before
