- 2d. By a remittance bill, payable to them at or in the neighbourhood of their residence.
- 3d. By extract, upon which those Officers who reside in the neighbourhood of a Dock-yard, where there is a Clerk of the Treasurer of the Navy, may be paid.

If they wish to receive it by bills of exchange, they are to give notice thereof, by letter, to the Secretary of the Admiralty, marked, in the corner, " Half-pay," and thereupon the proper form will be sent to them.
