

Sir James Bernardiston having by his Council pleaded his Sicknes, and Oath being made that he was not in a condition to go abroad, the Court allowed a farther time for his appearance.

And several Persons who had been taken at a Conventicle at Mr. Key's House in London, and were bound by Recognition to appear in this Court, appeared accordingly; and there being an Information exhibited against them by Mr. Attorney General, they were required to plead to the same, which they did. And the Court continued them bound upon their several Recognizances, in order to their Tryal some time this Term.

This morning the Earl of Danby was brought by *Habes Corpus* from the Tower to the Kings-Bench, and the Return being read, his Lordship prayed by his Council to have the same filed. The Court appointed his Lordship to be brought thither again by Rule, on Monday next, when they will hear what he has to offer by his Council.

In the Afternoon at the Nisi Priuia for the County of Middlesex, before the Lord Chief Justice Jeffreys, Samuel Patcher, Deputy to Richard Goodenough when he was Under Sheriff of the said County, was tryed upon an Indictment for Misdemeanor in publishing and dispersing a scandalous and seditious Libel, and was found Guilty of the same.

After which George Clarendon Steward to the Earl of Clark came to be tried upon an Information for High Misdemeanor against there appearing at the Trial, &c. Witness to prove the orders he was Indicted for, the Court discharged the Jury for that time, and committed the said *Condemn* to the King's Bench Prison, and ordered an Indictment to be brought against him for High Treason.

At the same time, Feb. 8th. This day came being again made that Sir James Bernardiston continued so ill that he could not go abroad without danger of his Life, the Court thought fit the pleading to the Information exhibited against him for High Misdemeanor, to dispence with his personal attendance for some farther time.
