

Sir Samuel Bernardiston having by his Council pleaded his Sickness, and Oath being made that he was not in a condition to go abroad, the Court allowed a farther time for his appearance.

And several Persons, who had been taken at a Conventicle at Mr. Key's House in London, and were bound by Recognizance to appear in this Court, appeared accordingly; and there being an Information exhibited against them by Mr. Attorney General, they were required to plead to the same, which they did. And the Court continued them bound upon their several Recognizances, in order to their Tryal some time this Term.

This morning the Earl of Danby was brought by Habeas Corpus from the Tower to the Kings-Bench, and the Return being read, his Lordship prayed by his Council to have the same Filed. The Court appointed his Lordship to be brought thither again by Rule, on Monday next, when they will hear what he has to offer by his Council.

In the Afternoon at the Nisi Return for the County of Middlesex, before the Lord Chief Justice Jeffreys, Samuel Parker, Deputy to Richard Goodenough, when he was Under Sheriff of the said County, was tried upon an Indictment for Misdemeanor in publishing and dispersing a scandalous and seditious Libel, and was found Guilty of the same.

After which George Lumbray Steward to the Bail of Clary came to be tried upon an Information for High Misdemeanor such as there appearing at the Tryal was a Witness to prove the words he was indicted for, the Court discharged the Jury for that time, and committed the said Lumbray to the Kings-Bench Prison, and ordered an Indictment to be brought against him for High Treason.

At the Kings-Bench, Jan. 26. This day Oath being again made that Sir Samuel Bernardiston continues so ill that he could not go abroad without danger of his Life, the Court thought fit to plead to the Information exhibited against him for High Misdemeanor, to dispence with his Personal attendance for some farther time.
