IS Majesty's Commissioners for building new churches, in pursuance of the directions of an Act, passed in the fifty-eighth year of the reign of His Majesty King George the Third, intituled "An Act for building, and promoting the building, of additional churches in populous parishes," do hereby give notice, that upon a representation from the said Commissioners, His Majesty was pleased, by an Order in Council, of the 1st day of August, in the year 1832, to order that the parish of St. Augustine in the city and diocese of Bristol, should be divided, into two distinct and separate parishes, under the 16th section of the above-mentioned Act, and that the said parishes should be named respectively the parish of St. Augustine, and the parish of St. George, Brandon-hill; that the chapel called St. George, Brandon-hill Chapel, should be the parish church of the said parish of St. George, Brandon-hill; and that the boundaries of the said parish of St. George, Brandon-hill, should be as follows:

The boundary to commence at the top of Parkstreet, and continue on the north and west sides of the parish of St. Augustine, in the line now separating the said parish from Clifton and St. Michael's, to Jacob's well, along Woodwell-lane and premises connected with a dock in Clifton, heretofore called Osborne's dock, and now the Lime. Kiln dock, to a point in the Floating-harbour on the south and in a line, so far separating the parish of St. Augustine and city of Bristol from the parish of Clifton, in Gloucestershire; thence eastward and in the said Floating-harbour, in a line extending about 460 feet, and separating the said parish and city from the parish of Bedininster, in Somersetshire; thence northward on the east of the Oil Gas-works, in a straight line to Anchor-lane, and along the said lane to the west side of a garden and cottage on the north of the said lane, belonging to the Deanery of

Bristol; and from thence in a direct line at the back | part of houses and premises in the Lower Collegegreen, being the property of the Dean and Chapter of Bristol, to the back part of the said Deanery; thence continuing the line, having the property of the said Dean and Chapter, on the east side, to Little Frog-lane, and through the middle thereof to the bottom of Park-street, and up the middle of the said street to the before stated commencement of the said boundary, excepting so much of the cemetry or burying-ground on the north east side of the said chapel, in a straight line from Charlotte-street to Great George's-street, being fifty-four feet in breadth on the north west end, next Charlotte-street, and seventy-six feet in breadth on the south east end, next Great George-street, and in length two hundred and seventy-one feet, or nearly thereabout, left uncoloured on the map, to be used for burying the inhabitants of St. Augustine parish till such time as a more convenient burying-ground can be obtained for the said parish of St. Augustine, reserving to the Vicar of St. Augustine's church, or his officiating Assistant free access thereto.

And the description of the said boundaries has been since enrolled in the High Court of Chancery, and registered in the Office of the Registry of the Lord Bishop of Bristol.

#### POST HORSE DUTIES.

Stamp-Office, London, October 30, 1832.

OTICE is hereby given, that, by virtue of an Act, passed in the second and third years of the reign of His present Majesty, intituled "An

Act to repeal the duties, under the management of the Commissioners of Stamps, on stage carriages and on horses let for hire in Great Britain, and to grant other duties in lieu thereof, and also to consolidate and amend the laws relating thereto," the Commissioners of Stamps will put up the Duties by the said Act granted on horses let for hire, at the Crown and Anchor Tavern, in the Strand, on Wednesday the 12th day of December next, at eleven o'clock in the forenoon, subject to such conditions as will then be produced, to be let to farm at yearly rents, for the term of three years, from the 1st day of February next inclusive, in the several divisions or districts following, that is to say:

#### DISTRICTS.

- 1. North Britain.
- Northumberland (with the town of Newcastleupon-Tyne), Cumberland, Westmorland, and Durham.
- Yorkshire (with the city of York, and town of Kingston-upon-Hull).
- Lancashire, Cheshire (with the city of Chester), Derbyshire, Staffordshire (with the city of Lichfield, and the whole of Tamworth).
- Lincolnshire (with the city of Lincoln), Nottinghamshire (with the town of Nottingham), Leicestershire, Rutlandshire.

The person declared to be the farmer of any district will be required to pay down immediately, in Bank notes, seven and a half per cent. upon the annual rent of such district as a deposit.

The farmer of each district will be required to give bond, with three or more sureties, to be approved of by the Commissioners of Stamps, in the penalty of half the annual rent, for securing the payment of the rent and the performance of the contract.

All persons intending to bid for any of the said duties are to notify their intention in writing, addressed to the Commissioners, at the Stamp-Office,

Somerset-place, at least three days previous to the said 12th day of December next, signed with their names, stating the places of their abode, and specifying the district or districts for which they intend to bid.

And no persons licenced to let horses for hire, nor any one for their use, can be admitted to contract for any of the said duties.
