This day, the Lords being met, a message was sent to the Honourable House of Commons by the Gentleman Usher of the Black Rod, acquainting them, that The Lords, authorised by virtue of a Commission under the Great Seal, signed by His Majesty, for declaring His Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Cantierbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and natify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An Act for raising the sum of twelve millions by Exchequer bills, for the service of the year one thousand eight hurdred and thirty-three.

An Act to apply certain sums to the service of the year one-thousand eight hundred and thirty-three.

An Act for continuing to His Majesty until the

fith day of April one thousand eight hundred and thirty-four, certain duties on sugar imported into the United Kingdom, and for one year certain duties on personal estates, offices, and pensions in England, for the service of the year one thousand eight hundred and thirty-three.

An Act for repealing an Act passed in the fourth year of the reign of His Majesty King George the Third, for the better relief and employment of the poor in the hundred of Bosmere and Claydon, in the county of Suffolk, and for granting more effectual powers instead thereof.

An Act for lighting with gas the borough of Congleton and the township of Buglawton, within the parish of Astbury, in the county of Chester.
