Majesty has been pleased to order, that at the Queen's Drawing-Rooms and Her Majesty's State Balls, the Masters of the Horse, the Master of the Buck Hounds, Equerries and Pages of Honour, and all Officers of the Navy and Army, Militia and Yeomanry, the Lords Lieutenants of Counties and Deputy Lieutenants, should appear in uniform pantaloons and boots, agreeably to regulation.

All persons belonging to their Majesties' House-holds, and all others who wear the civil uniform, are, on similar occasions, to appear in shoes with buckles, and breeches with knee buckles.

By the Lords of His Majesty's Most Honourable Privy Council.

HEREAS by an Act, passed in the second year of the reign of His present Majesty, intituled An Act for the prevention, as far as may be pos-

" sible, of the disease, called the cholera, or spas-" modic, or Indian cholera, in England," it is, amongst other things, enacted, that it shall and may be lawful for the Lords and others of His Majesty's Most Honourable Privy Council, or any two or more of them (of whom the Lord President of the Council. or one of His Majesty's Principal Secretaries of State for the time being, shall always be one), by any Order or Orders to be by them from time to time made. to establish, and again, from time to time, by any such Order or Orders, to revoke, renew, alter, or vary all such rules and regulations, or to substitute any such new rules and regulations, as to them may appear necessary or expedient, for the prevention, as far as may be possible, of the spreading of the said disease, called the cholera, or spasmodic, or Indian cholera, in England and Wales, or any part thereof, or for the relief of any persons suffering under, or likely to be affected by, the said disease:

And whereas it is further enacted by the said Act, that all and every the expences which may be reasonably and properly incurred, in carrying into effect any Order of the Lords of His Majesty's Most Honourable Privy Council, made as aforesaid, shall, under and by virtue of an order in writing of some justice of the peace, dwelling in or near the parish or division (and which said order any such justice is thereby empowered and directed to make), commanding the churchwardens, overseers, or guardians of the poor, for the time being, to pay a certain sufficient sum of money for such purpose, be de-

frayed out of the rates for the relief of the poor of the parish, township, or extra parochial place maintaining its own poor, in which the same shall be incurred, and, in other extra parochial places, out of the poors' rate of the parish nearest adjoining;

And whereas the said disease of cholera extended to many parts of Great Britain, and the townships of Goole and Hook, in the district of Marshland, in the county of York, were affected with the same; and a Board of Health was constituted and appointed for the said township of Goole and district of Marshland, by the Lords of the Privy Council:

And whereas by two several Orders in Council, made ou the sixth day of March and the nineteenth day of July last past, by the Lords and others of His Majesty's Privy Council (of whom the Lord President of the Council was one), it was, amongst other things, ordered and directed, that every Board of Health, constituted by an Order of the Privy Council, should and might apply to the select or parish vestry of the parish, township, ecclesiastical division, district, or place for which such Boards of Health were appointed, for authority and powers to carry into effect the sanitary purposes of the before-recited Act, and the measures of preparation and precaution in the said Orders described, and to provide a certain sufficient sum of money for the discharge of the necessary expences thereof:

And whereas it hath been represented to the Lords of the Council, that the Board of Health, constituted for the township of Goole and district of Marshland for the sake of giving effect to an agreement of the parochial officers of the different townships of such district, that they would bear all the necessary expences incurred for such sanitary purposes in due and rateable proportions, proceeded in the execution of their Lordships' Orders and expended a large sum of money, amounting in the whole to the sum of four hundred and twelve pounds ten shillings and nine pence, in providing a common hospital, medical advice, medicines, nurses and attendants, and other necessaries, of all which incidental expences a detailed account was laid before the justices of the peace in quarter sessions assembled, and by such justices approved and allowed :

And whereas it doth appear to their Lordships, that such charges are reasonable and proper, and fit to be defrayed out of the rates for the relief of the poor of the several townships in the said district of Marshland, in due and rateable proportions:

And whereas it hath been shewn to the satisfaction of their Lordships, that a statement of such expences as aforesaid, supported by accounts and vouchers, was submitted to the officers of the different townships, duly convened for the purpose of receiving and inspecting the same, and a request made for the funds to meet the same, according to their several proportions, to which no objections were stated; yet, whilst the township of Goole has consented to pay the sum of one hundred and fifteen pounds fourteen shillings and three pence, being its proportionate share of the entire sum of four hundred and twelve pounds ten shillings and nine pence, the township of Hook has since declined or avoided to pay the sum of forty-one pounds six shillings; the township of Swinefleet hath refused thirty-six pounds four shillings and six pence; Whitgift hath refused thirty-one pounds and six pence; Reedness, forty-seven pounds ten shillings and six pence; Ousefleet, forty-seven pounds seventeen shillings and three pence; Fockerby, twelve pounds and four shillings; Adlingfleet, twenty-nine pounds thirteen shillings and nine pence; Eastoft, thirty-four pounds sixteen shillings and six pence; and Holdenby, sixteen pounds three shillings and six pence; such several sums having been applied for by the said Board of Health, from the different townships aforesaid, to provide for the just expences necessarily incurred in carrying into effect the precautionary and sanitary purposes of the before-recited Act, and of the Orders of their Lordships founded thereon:

It is, therefore, ordered by the Lords and others of His Majesty's Most Honourable Privy Council (of whom the Lord President of the Council is one), in pursuance of the powers vested in them by the before-recited Act, that so much of the Orders in Council of the sixth day of March and nineteenth day of July, as requires the amount of the sum to be defrayed in discharge of the necessary expences, to be fixed and declared by vestries as aforesaid, be, and they are hereby, revoked and altered, in so far as respects the said townships of Hook, Swinefleet, Whitgift, Reedness, Ousefleet, Fockerby, Adlingfleet, Eastoft, and Holdenby, and the said several sums of forty-one pounds and six shillings, thirtysix pounds four shillings and six pence, thirty-one pounds and six pence, forty-seven pounds ten shillings and six pence, fortw-seven pounds seventeen shillings and three pence, twelve pounds and four shillings, twenty-nine pounds thirteen shillings and nine pence, thirty-four pounds sixteen shillings and. six pence, and sixteen pounds three shillings and I they will incur the penalties consequent upon dissix pence:

And the said Board of Health for Goole and Marshland shall and may, and they are hereby authorised and empowered to make application, by their chairman or secretary, to some justice of the peace living in or near the township or division, to make his order in writing upon the parish officers, guardians of the poor, or district churchwardens of the said township of Hook, commanding them to pay the said sum of forty-one pounds six shillings, for the purposes aforesaid, out of the rates levied, or next thereafter to be levied, for the relief of the poor of such township; and another order upon the parish officers of the township of Swinefleet, commanding them to pay the said sum of thirty-six pounds four shillings and six pence, out of the poors' rate of the said township; and another order upon the parish officers of the township of Whitgift, commanding them to pay the said sum of thirty-one pounds and six pence, out of the poors' rate of such township; and another order upon the officers of the township of Reedness, commanding them to pay the said sum of forty-seven pounds ten shillings and six pence, out of the poors' rate of such township; and another order upon the officers of Ousefleet, commanding them to pay the said sum of fortyseven pounds seventeen shillings and three pence, out of the poors' rate of such township; and another order upon the officers of the township of Fockerby, commanding them to pay the said sum of twelve pounds four shillings out of the poors' rate of such township; and another order upon the officers of Adlingfleet, commanding them to pay the said sum of twenty-nine pounds thirteen shillings and nine pence, out of the poors' rate of such township; and another order upon the officers of Eastoft, commanding them to pay the said sum of thirty-four pounds sixteen shillings and six pence, out of the poors' rate of the said township; and another order upon the officers of Holdenby, commanding them to pay the said sum of sixteen pounds three shillings and six pence, out of the poors' rate of such township; which said several orders such justice of the peace is hereby required and enjoined to make, in pursuance and exercise of the powers vested in him by the before-recited Act; and the said parish officers, guardians of the poor, or district churchwardens, are hereby ordered and commanded to pay such several sums of money in obedience to the order of such justice, in the manner therein directed, or

And the Lords and others of His Majesty's Privy Council (of whom the Lord President of the Council is one) do hereby declare, that for all acts, deeds, matters, and things properly done by such Board of Health, justice of the peace, overseers, churchwardens, guardians of the poor, and others His Majesty's subjects, in execution and furtherance of this present Order of the Lords and others in Council, or of any order so to be made by any such justice as aforesaid, this Order shall be their full and sufficient warrant.

The KING's Most Excellent Majesty in Council.

T is this day ordered by His Majesty in Council, that His Majesty's Order in Council of the sixth of November last, directing that no ships or vessels belonging to any of His Majesty's subjects be permitted to clear out for any of the ports within the dominions of the King of the Netherlands until further orders; and that an embargo be laid upon all ships and vessels belonging to the subjects of the King of the Netherlands which then were, or which should thereafter come into any of the ports, harbours, or roads within any part of His Majesty's dominions; and that the commanders of His Majesty's ships of war should detain and bring into port all merchant ships and vessels bearing the flag of the Netherlands, be revoked, and the same is hereby revoked accordingly; and it is hereby further ordered, that the said embargo be taken off, and that all such ships and vessels be permitted to depart with their cargoes to their respective ports of destination:

And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Lords Commissioners of the Admiralty, and the Lord Warden of the Cinque Ports, are to give the necessary directions therein as to them may respectively appertain. Wm. L. Bathurst.
