The King has been pleased to give and grant unto William Marshall, of Laughton-en-le-Morthen, and of Newton-Kyme, in the county of York, Esq. in

the Commission of the Peace, and one of the Deputy Lieutenants for the west riding of the said county, His royal licence and authority that, in order to commemorate his descent from the ancient family of Hatfield, of Laughton-en-le-Morthen, and to testify his respect for the memory of John Hatfield, late of Laughton aforesaid, and of Doncaster, in the said county of York, Esq. deceased, he, the said William Marshall, and his issue may take and use the surname of Hatfield, in lieu of that of Marshall, and bear the arms of Hatfield; such arms being first duly exemplified according to the laws of arms, and recorded in the Heralds' Office, otherwise the said licence and permission to be void and of none effect:

And also to command, that the said royal concession and declaration be registered in His Majesty's College of Arms.

NOTICE is hereby given, that application is intended to be made to Parliament in the ensuing session, for leave to bring in a Bill and obtain an Act to consolidate, amend, extend, enlarge, or otherwise alter the powers and provisions contained in an Act of Parliament, passed in the third year of the reign of His late Majesty King George the Fourth, intituled "An Act for more effectually amending certain roads in the several parishes of Lambeth, Newington, Saint George Southwark, Bermondsey, and Christchurch, in the county of Surrey, and for watching, lighting, and otherwise improving the said roads;" and also in an Act, passed in the ninth year of the reign of His said late Majesty, intituled "An Act for more effectually amending the road leading from the Stones-end, in Blackman-street, in the borough of Southwark, in the county of Surrey, to Highgate, in the county of Sussex, and several other roads therein mentioned, and for other purposes relating thereto;" by which Act, so to be obtained, it is intended to consolidate the said several roads, and place the repair and management thereof under the trustees to be by that Act appointed, or such parts of the said several roads as may be deemed expedient to be united; also to authorise the said trustees to continue or take down all and every or any of the toll-gates, bars, turnpikes, and toll-houses on the said roads, and to erect other toll-gates, bars, turnpikes, and toll-houses in lieu thereof, or in addition thereto, as may be thought proper, and at such several toll-gates, bars, turnpikes, or toll-houses, to demand and receive all and every the tolls granted and made payable under and by virtue of the Acts of Parliament above referred to, or such other tolls as shall be granted by the Act to be applied for as aforesaid; also to empower the said trustees to water the said several roads, or any part or parts thereof, and during such times and seasons of the year as they may direct, and for that purpose to demand and take a toll or tolls upon such road or roads as shall be directed by the said trustees to be watered; also to authorise the relinquishment of the repair of the carriage-way of such parts of the said roads as the said trustees may deem expedient, and the repair of all and every the footpaths by the sides of the several roads included in the said Acts, or either of them, or any part or parts of such footpaths,
