And also to command, that the said royal concession and declaration be recorded in His Majesty's College of Arms.

Whitehall, February 29, 1834.

WHEREAS it hath been humbly represented unto the King, that, about half past six o'clock in the evening of Wednesday the 26th day of February instant, Mr. John Richardson, bailiff to J. Perkins, Esq. of Pendhill, near Bletchingley, in the county of Surrey, was inhumanly murdered between Epsom and Banstead, on his return from Epsom market, and robbed of cash and Bank of England notes to the amount of about £20 or £30;

His Majesty, for the better apprehending and bringing to justice the persons concerned in the murder before mentioned, is hereby pleased to promise His most gracious pardon to any one of them (except the person who actually committed the same) who shall discover his accomplice or accomplices therein, so that he, she, or they may be apprehended and convicted thereof.

And, as a further encouragement, a reward of ONE HUNDRED POUNDS is hereby offered by the Right Honourable the Lords Commissioners of His Majesty's Treasury, and an additional reward of ONE HUNDRED POUNDS by the said John Perkins, Esq. to any person (except as aforesaid) who shall discover the said offender or offenders, so that he, she, or they may be apprehended and convicted of the said offence.
