**I**T has been notified by the Ottoman Government to His Majesty's Ambassador at Constantinople, by a communication dated the 31st March 1834, that the Sublime Porte has given instructions for the establishment of a strict blockade of the island of Samos.

THE following joint Address of both Houses of Parliament was this day presented to His Majesty on the Throne:

*Most Gracious Sovereign,*

WE, your Majesty's most dutiful and loyal subjects, the Lords Spiritual and Temporal and Commons in Parliament assembled, feel it our duty humbly to approach your Majesty's Throne, to record in the most solemn manner our fixed determination to maintain unimpaired and undisturbed the Legislative Union between Great Britain and Ireland, which we consider to be essential to the strength and stability of the empire, to the continuance of the connection between the two countries, and to the peace and security and happiness of all classes of your Majesty's subjects.

We feel this our determination to be as much justified by our views of the general interests of the State, as by our conviction that to no other portion of your Majesty's subjects is the maintenance of the Legislative Union more important than to the inhabitants of Ireland themselves.

We humbly represent to your Majesty, that the Imperial Parliament have taken the affairs of Ireland into their most serious consideration, and that

various salutary laws have been enacted since the Union, for the advancement of the most important interests of Ireland and of the empire at large.

In expressing to your Majesty our resolution to maintain the Legislative Union inviolate, we humbly beg leave to assure your Majesty, that we shall persevere in applying our best attention to the removal of all just causes of complaint, and to the promotion of all well considered measures of improvement.

To which Address His Majesty was pleased to return the following most gracious Answer:

*" My Lords, and Gentlemen,*

" IT is with the greatest satisfaction that I receive this solemn and united expression of the determination of both My Houses of Parliament to maintain unimpaired the Legislative Union of Great Britain and Ireland, which I entirely agree with you in considering as essential to the peace, integrity, and safety of the British empire.

" You may rely, therefore, on My discharging with fidelity and firmness the sacred duty which I owe to My subjects, in exerting the powers with which the Constitution has invested Me for their protection against attempts which, if successful, must inevitably produce a separation of My dominions.

" In thus expressing My concurrence in the determination which you have so justly taken, I look back with satisfaction to the salutary laws which, since the Union, have been passed for the advancement of the interests of Ireland; and I shall at all times be anxious to afford My best assistance in removing all just causes of complaint, and in sanctioning all well considered measures of improvement."

Murch; Benjamin Marden, M.A.; Samuel Wood, A.M.; John Young, M.A.; George Kenrick; Charles Stovel; and Thomas Morell; which Address His Majesty was graciously pleased to receive in His Closet:

To the KING's Most Excellent Majesty.

*May it please your Majesty,*

WE, your Majesty's loyal and dutiful subjects, the Protestant Dissenting Ministers of the Three Denominations residing in and about the Cities of London and Westminster, in approaching your royal presence beg to express our unfeigned gratitude for the important benefits conferred on our country during your Majesty's gracious reign, and for the general prospect of national improvement and prosperity afforded by the anticipated measures of your Majesty's Government.

We would humbly represent to your Majesty, that we consider the attainment of academical degrees, as being the generally recognised means of attaching due honour to proficiency in learning and science, to be a laudable object of pursuit, and that we regard an exclusion from such honours as a serious grievance, operating invidiously in respect to those who are subject to such a privation.

We cannot therefore, but deeply regret that the only bodies in England, legally empowered to confer such tokens of academical acquirement, should have determined to withhold them from all persons not professing their approval of the doctrines and usages of the Established Church, thus depriving all classes of Dissenters of academical distinction, unless sought at great expence and disadvantage in distant parts.

It is to us also a matter of deep concern that whilst in the University of London this large class of your Majesty's subjects have ample means of prosecuting the liberal sciences that institution is unable to confer those degrees on the students which would be alike incentives to exertion and the evidence of success in their literary and scientific pursuits; this inability on the part of that establishment we the more regret as the advantages of its instructions are tendered without any interference with the theological principles of its students.

We, therefore, humbly pray your Majesty to be graciously pleased to grant to the University of London your royal charter empowering that institution to confer the customary academical degrees in arts, medicine, and law.

*"THE whole course of My reign must have proved to you that I am a sincere friend to religious liberty. It is, however, My duty, as the Head of the Established Church of this country, to protect its rights and interests. At present I can say no more, than that I shall be always ready to receive and consider such proper and respectful representations as that which you have now presented to Me."*

THAT your petitioners approach your Majesty with sentiments of unfeigned loyalty to your Majesty's Royal Person, and of attachment to the Protestant Constitution of this realm; that your petitioners are sincerely and devoutly attached to the Established Church of England and Ireland, as an instrument, under God, of diffusing true religion through the land, that they love its doctrines and its formularies, as being eminently scriptural and devout; that they are warm friends to any measures which may improve its discipline and thereby augment its efficiency.

That they implore your Majesty as, under Christ, the supreme governor of that Church, and accountable to God for the exercise of your power, to sanction no scheme for the alienation of its property, and to permit no interference, on the part of its enemies, in its government or constitution; and your petitioners will ever pray that, after a prosperous reign on earth, the King of Kings and Lord of Lords may grant to your Majesty a crown of glory incorruptible, undefiled, and that fadeth not away.

*May it please your Majesty,*

WE, the undersigned, members of the Established Church of this Kingdom, beg leave to approach your Majesty with the expression of our dutiful and

loyal attachment to your Majesty's Person, and to the principles which seated and have maintained your Majesty's illustrious Family on the Throne of these Realms.

We further consider it our duty, at this eventful period, to declare our firm and unfeigned attachment to the Church of which we are members, as having been the means, under the blessing of God, of conveying those many spiritual and temporal benefits which we and our forefathers have so long enjoyed, and which we earnestly desire that our posterity also may enjoy.

We likewise find ourselves called upon by the events which are daily passing around us, to declare to your Majesty our firm conviction that the consecration of the State by the public maintenance of the Christian religion, is the first and paramount duty of a Christian King and people, and that the Church established in these realms has been their main bulwark against infidelity and immorality; and by carrying its sacred and beneficial influence through all orders and degrees, and into every corner of the land, has for many ages been the great and distinguishing blessing of this country, and not less the means, under Divine Providence, of national prosperity than of individual piety.

In the preservation, therefore, of this our National Church in the enjoyment of her unimpaired rights and privileges, her scriptural doctrines, and public forms of worship, as well as her alliance with the State, we feel a deep and anxious interest; and we, therefore, humbly address your Majesty as the temporal head of the Church, imploring your Majesty to exercise all the constitutional powers vested in the Crown for the welfare of the people committed to your charge, in the maintenance of the integrity, property, and efficiency of our venerated establishment, and its continued connection with the State.

WE, your Majesty's most dutiful, loyal, and affectionate subjects, approach your Majesty with every possible feeling of duty, submission, and respect, to assure your Majesty of our dutiful, unalterable, loyal, and affectionate attachment both to your Crown and sacred Person. Although some alteration may have been found requisite in the Constitution of the Country accordant with the change in the times, we hope never to witness such a change as would place us under any other than that tripartite government of King, Lords, and Commons, which we so happily possess; and proud shall we ever be to acknowledge your Majesty, with all humility on our parts, as the head and fountain of all honour: but we fervently hope never to see such a change as would unset the brightest jewel in your Majesty's diadem by disuniting the Church from the State; that Church which in our humble opinion forms the principal bulwark of the nation, and has proved itself, under the influence and mercy of Divine Providence, the tower of our strength. As the want of religion and morality amongst the

people has caused the fall of many nations, so the propagation of real Christianity upholds the glory of Great Britain; that good book the Bible, and the preservation of an established Church, the Liturgy of which is so comprehensive and complete as to need no change, being, as we humbly trust it ever will be, part and parcel of the law of the land.

That your Majesty may long live in health and happiness, to enjoy, protect, and maintain inviolate all your just rights and prerogatives in Church and State, on which the best and dearest interests of your people depend, and partake of all the blessings they afford, is the ardent desire and sincere prayer of your Majesty's most dutiful, humble, loyal, and affectionate subjects.

To His Most Excellent Majesty the KING.

WE, the undersigned, Inhabitants of the Parish of Brailsford, in the County of Derby, beg leave humbly to approach your Royal Person with the most sincere expressions of our devoted homage and allegiance.

Viewing with unfeigned regret the attempts which are made to excite unfounded prejudices against the Church, as established in this Kingdom, we feel it our duty to convey to your Majesty our conscientious conviction of its truly scriptural constitution; and considering it to be the chief instrument, through the gracious providence of God, of individual piety and national prosperity, we respectfully avow the veneration and attachment which we cherish towards it, and our desire, not only for its firmest maintenance, but for its widest possible diffusion. We, therefore, humbly beseech your Majesty that no changes affecting the spiritual concerns of the Church may receive your royal sanction, unless with the full concurrence of those in whom its internal economy is constitutionally vested; and that your Majesty would resist any proposition to dissolve the connection between Church and State, to alienate any of her ancient rights and endowments, or degrade her spiritual rulers; and that your Majesty would graciously be pleased to favour such measures as may extend her efficient instruction and clerical superintendence not only to all the people in this Kingdom, but to all the foreign possessions and dependencies of the Empire.

And that your Majesty, "plenteously endued with heavenly gifts, in health and wealth long may live," shall be the prayer of your Majesty's humble, loyal, and devoted subjects.
