Church Commissioners'-Office May 2, 1835.

HE following is a copy of an Order of His Majesty in Council, dividing the chapelry of Oldham into ecclesiastical districts, under the 16th section of 59 Geo. 3, c. 134:

At the Court at St. James's, the 4th of March 1835, present, the King's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the 58th year of the reign of His late Majesty King George the Third, intituled " An Act for building, and promoting the building, of additional churches in populous parishes," it is amongst other things en-acted, "that in every case in which the Commissioners appointed for carrying into execution the purposes of the said Act, shall be of opinion that it will be expedient to divide any parish into two or more distinct and separate parishes, for all ecclesiastical purposes whatever, it shall be lawful for the said Commissioners, with the consent of the Bishop of the diocese in which such parish is locally situated, signified under his hand and seal, to apply to the patron or patrons of the church of such parish for his or their consent to make such division, and for such patron or patrons to signify his or their consent thereto, under his or their hand and seal; and the said Commissioners shall, upon the consent of the said patron or patrons so signified, represent the whole matter to His Majesty in Council, and shall state in such representation the bounds by which it is proposed, with such consent as aforesaid, to divide such parish, together with the relative and respective proportions of glebe land, tithes, moduses, or other endowments, which will by such division arise and accrue, and remain and be within each of such respective divisions, and also the relative proportions of the estimated amount of the value or produce of fees, oblations, offerings, or other ecclesiastical dues or profits, which may arise and accrue within each of such respective divisions; and if thereupon His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting such division; provided always, that no such division of any parish into district parishes shall completely take effect until after the death, resignation, or other avoidance of the existing in-cumbent of the parish to be divided;" and whereas by the said Act it is further enacted, "that in any case in which the said Commissioners shall be of opinion that it is not expedient to divide any populous parish, or extra parochial place, into such complete, separate, and distinct parishes as aforesaid, but that it is expedient to divide the same into such ecclesiastical districts as they, with the consent of the Bishop, signified under his hand and seal, may deem necessary, for the purpose of affording accommodation for the attending divine service, according to the rites of the United Church of England and Ireland, to persons residing therein, in the churches and parochial chapels already built, or in additional churches or chapels to be built therein, and as may appear to such Commissioners to be convenient for the enabling the spiritual person or persons who may serve such churches or chapels to perform all

ecclesiastical duties within the districts attached to such respective churches and chapels, and for the due ecclesiastical superintendence of such district, and the preservation and improvement of the religious and moral habits of the persons residing therein; the said Commissioners shall represent such opinion to His Majesty in Council, and shall state in such representation the bounds by which such districts are proposed to be described; and if, thereupon, His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting such division:" and whereas by an Act, passed in the 59th year of the reign of His late Majesty King George the Third, intituled " An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes;" and by another Act, passed in the 7th and 8th years of the reign of His late Majesty King George the Fourth, intituled "An Act to amend the Acts for building, and promoting the building, of additional churches in populous parishes; and by another Act, made and passed in the 1st and 2d year of His present Majesty, intituled " An Act to amend and render more effectual an Act, passed in the 7th and 8th year of the reign of His late Majesty, intituled 'An Act to amend the Acts for building, and promoting the building, of additional churches in populous parishes;" and also by another Act, made and passed in the 2d and 3d year of His said Majesty, intituled "An Act to render more effectual an Act, passed in the 59th year of His late Majesty King George the Third, intituled 'An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes; further provisions are made for carrying such divisions into effect:

And whereas the said Commissioners have made a representation to His Majesty in Council, stating that, in the year 1831, when the last census was taken, the parochial chapeiry of Oldham, in the parish of Prestwich cum Oldham, in the county palatine of Lancaster and diocese of Chester, contained a population of 50,513 persons; that there are besides the parochial chapel of Oldham, five other chapels in the said chapelry, called respectively Saint Peter's Chapel, Saint James's Chapel, Saint Margaret's Chapel Hollinwood, Saint Paul's Chapel Royton, and Shaw Chapel Crompton; that the parochial chapel of Oldham contains accommodation for 14:0 persons, including 300 free scats appropriated to the use of the poor; that Saint Peter's Chapel contains accommodation for 900 persons, including 100 free seats appropriated to the use of the poor; that Saint James's Chapel contains accommodation for 1837 persons, including 896 free seats appropriated to the use of the poor; that Saint Margaret's Chapel contains accommodation for 560 persons; that Saint Paul's Chapel contains accommodation for 450 persons; that Shaw Chapel contains accommodation for 800 persons, including 100 free seats appropriated to the use of the poor; and that divine service is regularly performed in all . the said chapels:

And whereas the said Commissioners have further represented to His Majesty, that having taken into consideration all the circumstances attending the said chapelry of Oldham, it appears to them to be expedient, that a particular district should be assigned to each of the above-mentioned chapels, under the provisions of the 16th section of an Act, passed in the 59th year of the reign of His late Majesty King George the Third, intituled "An Act to amend an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes;" and that such districts should be respectively named, the Parochial Chapel District, the Saint Peter's District, the Saint James's District, the Hollinwood District, the Royton District, and the Crompton District, with boundaries as follows, viz.

PAROCHIAL CHAPEL DISTRICT.

(Parts of the Township of Oldham and Chadderton.)

The boundary to commence in the centre of Yorkshire-street, opposite the Old Horsedge-road, and thence proceed northward, continuing along the boundary which separates the subdivisions of ham township, called the hamlets of Oldham below Town and Oldham above Town (including the west side thereof, or Oldham below Town), to where the township of Royton joins the township of Oldham; thence south westward, and continuing along the boundary which separates the townships of Royton and Oldham, to where the township of Chadderton joins the township of Oldham, in the valley below Plumpton; thence westward, and continuing along the boundary which separates the townships of Chadderton and Royton, to where the parish of Middleton joins the chapelry of Oldham, at the junction of the townships of Royton, Chadderton, and Thornham; thence north westward, and continuing along the boundary which separates the parish of Middleton from the chapelry of Oldham, to where the parish of Prestwich joins the parish of Middleton; thence southward, and continuing along the boundary which separates the parish of Prestwich from the chapelry of Oldham, to the centre of the road leading from Middleton to Oldham, at Mills-hill; thence eastward, along the centre of the Middleton and Oldham-road, and continuing along the centre of Huntlane (including the north or left side thereof); thence southward, continuing along the centre of the Werneth and Littleborough turnpike road; thence along the centre of the Austerlands and Manchester turnpike road to the foot path, leading from Werneth; thence south eastward, along the said foot path to Chamber-lane, thence north eastward and continuing along the centre of Chamber-lane to the old road between Oldham and Ashton, leading to Broadwaylane; thence north westward, and continuing along the centre of the Oldham and Ashton turnpike road, Fog-lane, and King-street (including the west or left side thereof); thence eastward, and continuing along the centre of Manchester-street, Market-place, highstreet, and Yorkshire-street (including the north or left side thereof), to the centre of Yorkshire-street, opposite the Old Horsedge-road, where the boundary commenced, as the same is delineated in the plan thereunto annexed, and therein coloured red.

SAINT PETER'S DISTRICT.

Part of the Hamlet of Oldham below Town and Oldham above, in the Township of Oldham).

The boundary to commence in the centre of Manchester-street, opposite to King-street, and thence proceed south eastward, continuing along the centre of King-street, Fog-lane, and the high road, leading from Oldhani to Ashton-under-Lyne (including the east or left side thereof) to where the parish of Ashton-under Lyne joins the chapelry of Oldham; thence north eastward, and continuing along the boundary which separates the parish of Ashton from the chapelry of Oldham, to the centre of the bridge at Leesbrook; thence westward, and continuing along the centre of the high road leading from Lees to Mumps (including the south or left side thereof); thence westward, and continuing along the centre of Oldham-lane, Yorkshire-street, High-street Marketplace, and Manchester-street (including the south or left side thereof) to the centre of Manchester-street, opposite the end of King-street, where the boundary commenced, as the same is delineated in the plan thereunto annexed, and therein coloured blue.

SAINT JAMES'S DISTRICT.

(Part of the Hamlet of Oldham above Town, in the Township of Oldham.)

The boundary to commence in the centre of Yorkshire-street, opposite the Old Horsedge-road, and thence proceed northward, continuing along the boundary which separates the subdivisions of Oldham Township (called the Hamlets of Oldham below Town and Oldham above Town, including the east side thereof, or Oldham above Town), to where the township of Royton joins the township of Oldham; thence north eastward, and continuing along the boundary which separates the township of Oldhanr and Royton to where the township of Crompton joins the township of Royton; thence northward, and continuing along the boundary which separates the township of Crompton and Oldham to where the county of York joins the county of Lancaster at Grains; thence south eastward, a d continuing along the boundary which separates the two counties, and also the chapelries of Oldham and Saddleworth, to where the parish of Ashton-under-Lyne joins the chapelry of Saddleworth, near Mill bottom; thence southward, and continuing along the boundary which separates the chapelry of Oldham from the parish of Ashton-under-Lyne to the centre of the bridge at Leesbrook; thence westward, and continuing along the centre of the road leading from Lees to Mumps (including the north or right side thereof); thence westward, and continuing along the centre of Oldham-lane and Yorkshine-street (including the north or right side thereof), to the centre of Yorkshire. street, opposite the Old Horsedge-road, where the boundary commenced, as the same is delineated in the plan thereunto annexed, and therein coloured lake.

Hollinwood District.

(Parts of the Townships of Oldham and Chadderton.)

The boundary to commence in the centre of the high road leading from Middleton to Oldham, where the parish of Prestwich joins the chapelry of Oldham, near Mill's-hill, and thence proceed castward

along the centre of the Oldham and Middleton+ road; and continuing eastward along the centre of Hunt-lane (including the south or right side thereof); thence southward, continuing along the centre of the Werneth and Littleborough tumpike road; thence, along the centre of the Austerlands and Manchester turnpike road to the footpath leading from Werneth; thence south eastwards along the said footpath to Chamber-lane; thence north eastward, continuing along the centre of Chamber-lane to the Old road between Cldham and Ashton, leading to Broadwaylane; thence south eastward, continuing along the centre of the high road leading from Oldham to Ashton-under Lyne to where the parish of Ashton-under-Lyne joins the chapelry of Oldham; thence north westward, and continuing along the boundary which separates the parish of Ashton from the chapelry of Oldham to where the parish of Manchester joins the parish of Ashton; thence northward, and continuing along the boundary which separates the parish of Manchester from the chapelry of Oldham, to where the parish of Prestwich, joins the parish of Manchester, near the centre of the White Moss; thence north eastward, and continuing along the boundary which separates the parish of Prestwick from the chapelry of Oldhani to the centre of the high road leading from Middleton to Oldham, near Mill's-hill, where the boundary commenced, as the same is delineated in the plan thereunto annexed, and therein coloured yellow.

ROYTON DISTRICT.

(Township of Royton.)

The boundary to commence at the junction of the three townships of Royton, Chadderton, and Thornham, near Jelliots, and thence proceed north eastward, continuing along the boundary which separates the parish of Middleton from the chapelry of Oldham to where the township of Crompton adjoins the township of Royton; thence eastward, continuing along the boundary which separates the townships of Royton and Crompton to where the township of Oldham joins the township of Crompton, near Oldbank; thence southward, and continuing along the boundary which separates the township of Royton and Oldham to where the township of Chadderton joins the township of Oldham, in the valley below Plumpton; thence westward, and continuing, along the boundary which separates the township of Royton and Chadderton to where the parish of Middleton joins the chapelry of Oldham, at the junction of the township of Thornham, Royton, and Chadderton, near Jelliots, where the boundary com-menced, as the same is delineated in the plan thereunto annexed, and therein coloured green.

CROMPTON DISTRICT.

(Township of Crompton.)

The boundary to commence at the junction of the three townships of Crompton, Royson, and Thornham, at Dogfort's brook, and thence proceed northward, continuing along the boundary which separates the township of Thornham, in the parish of Middleton, from the township of Crompton, in the chapelry of Oldham, to where the parish of Rochdale joins the parish of Middleton; thence eastward, continuing along the boundary which separates the parish of

Rochilale from the chapelry of Oldham to where the chapelry of Saddleworth, in the county of York, joins the parish of Rochdele, in the county of Lancaster; thence southward, and continuing along the boundary which separates the counties of York and Lancaster, and likewise the chapelries of Saddleworth and Oldham, to where the township of Oldham joins the township of Crompton, at Grains; thence westward, and continuing along the boundary which separates the townships of Oluham and Crompton to where the township of Royton joins the township of Oldham, near Old bank; thence westward, and continuing along the boundary which separates the townships of Crompton and Royton to where the parish of Middleton joins the chapelry of Oldham, at the junction of the townships of Thornham, Royton, and Crompton, at Dogfort's-brook, where the boundary commenced, as the same is delineated in the plan thereunto annexed, and therein coloured brown

That marriages, baptisms, churchings, and burials shall be performed in each of the above mentioned chapels, and that the ees for the same should, from and after the next avoidance of the rectory of the said parish of Prestwich cum Oldham, belong to, and be received by, the ministers of the said six chapels

respectively.

That the consent of the Lord Bishop of Chester has been obtained thereto, as required by the abovementioned section of the said Act passed in the 59th year of the reign of His said Majesty King George the Third; and that in testimony thereof the said Lord Bishop has signed and sealed the said representation; and humbly praying, that His Majesty would be pleased to take the premises into consideration, and to make such order in respect thereto, as to His Majesty might seem meet:

His Majesty, having taken the said representation, and the plan thereunto annexed, into consideration, was pleased, by and with the advice of His Privy Council, o approve thereof, and to order, as it is hereby ordered, that the districts described in the said representation be respectively assigned to the said six several chapels accordingly, agreeably to the provisions of the said Acts.

At the Court at St. James's, the 4th of March 1835, present, the King's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the 58th year of the reign of His late Majesty King George the Third, intituled "An Act for building, and promoting the building, of additional churches in populous parishes," it is, amongst other things, enacted, "that in every case in which the Commissioners appointed for carrying into execution. the purposes of the said Act, shall be of opinion that

more distinct and separate parishes, for all ecclesiastical purposes whatever, it shall be lawful for the said Commissioners, with the consent of the Bishop of the diocese in which such parish is locally situated, signified under his hand and seal, to apply to the patron or patrons of the church of such parish for his or their consent to make such division, and for such patron or patrons to signify his or their consent thereto, under his or their hand and seal; and the said Commissioners shall, upon the consent of the said patron or patrons so signified, represent the whole matter to His Majesty in Council, and shall state in such representation the bounds by which it is proposed, with such consent as aforesaid, to divide such parish, together with the relative and respective proportions of glebe land, tithes, moduses, or other endowments, which will by such division arise and accrue, and remain, and be within each of such respective divisions, and also the relative proportions of the estimated amount of the value or produce of fees, oblations, offerings, or other ecclesiastical dues or profits which may arise and accrue within each of such respective divisions; and if thereupon His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting such division; provided always that no such division of any parish into distinct parishes shall completely take effect until after the death, resignation, or other avoidance of the existing incumbent of the parish to be divided;' And whereas by the said Act it is further enacted " that in any case in which the said Commissioners shall be of opinion that it is not expedient to divide any populous parish or extra parochial place into such complete, separate, and distinct parishes as aforesaid, but that it is expedient to divide the same into such ecclesiastical districts as they, with the consent of the Bis .op, signined under his hand and seal, may deem necessary for the purpose of affording accommodation for the attending divine service, according to the rites of the United Church of England and Ireland, to persons residing therein, in the churches and parochial chapels already built, or in additional churches or chapels to be built therein, and as may appear to such Commissioners to be convenient for the enabling the spiritual person or persons who may serve such churches or chapels, to perform all ecclesiastical duties within the districts attached to such respective churches and chapels, and for the due ecclesiastical superintendence of such district, and the preservation and improvement of the religious and moral habits of the persons residing therein, the said Commissioners shall represent such opinion to His Majesty in Council, and shall state in such representation the bounds by which such districts are proposed to be described; and if, thereupon, His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting such division;" and whereas by an Act, passed in the 9th year of His late Majesty King George the Third, intituled "An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes;" and by another Act, passed in the 7th and 8th years it will be expedient to divide any parish into two or of the reign of His late Majesty, intituled " An Act to amend the Acts for building, and promoting the building, of additional churches in populous parishes;" and also by another Act, made and passed in the 1st and 2d year of the reign of His present Majesty, intituled "An Act to amend and render more effectual an Act, passed in the 7th and 8th years of the reign of His late Majesty, intituled 'An Act to amend the Acts for building, and promoting the building, of additional churches in populous parishes;" and also by another Act, made and passed in the 2d and 3d year of His said Majesty, intituled "An Act to render more effectual an Act, passed in the 59th year of His late Majesty King George the Third, intituled 'An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes," further provisions are made for carrying such divisions into effect:

And whereas the said Commissioners have made a representation to His Majesty in Council, stating that, in the year 1831, when the census was taken, the parish of Portsea, in the county of Southampton and in the diocese of Winchester, contained a population of 38,379 persons, which has since considerably increased; that there are besides the parish church, five chapels in the said parish, namely, Saint George's, Saint John's, Saint Paul's, All Saints, and the Dock-yard Chapel, two of which, namely, Saint Paul's and All Saints' Chapels, have been built by His Majesty's said Commissioners; that the parish church is capable of affording accommodation to 800 persons, including 300 free seats appropriated to the use of the poor; that Saint George's Chapel affords accommodation to 1000 persons, without any free seats; that Saint John's Chapel affords accommodation to 1800 persons, including 200 free seats appropriated to the use of the poor; that Saint Paul's Chapel affords accommodation to 1821 persons, including 903 free seats appropriated to the use of the poor; that All Saints Chapel affords accommodation to 1739 persons, including 1106 free seats appropriated to the use of the poor; and that the Dock-yard Chapel affords accommodation to 1000 persons, without any free scats; that all the said five chapels, excepting the Dock-yard Chapel, have been duly consecrated and divine service is regularly performed therein:

And whereas the said Commissioners have further represented to His Majesty that, having taken into consideration all the circumstances attending this parish, it appears to them to be expedient that particular districts should be assigned to the above named chapels of Saint John, Saint Paul, and All Saints, under the provisions of the 16th section of an Act, passed in the 58th year of the reign of His Majesty King George the Third, intituled "An Act to amend an Act, passed in the last session of Parliament, for building and promoting the building of additional churches in populous parishes:"

That baptisms and churchings should be performed in the said chapels, and that one moiety of the fees for the same should belong respectively to the Ministers of such charels; and that such districts should be respectively named, Saint Paul's

District, All Saints District, and Saint John's District, with boundaries as follow:

SAINT PAUL'S DISTRICT.

The boundary to commence at South Sea Castle, on the south east, following a straight line to Marmiou-place, and thence continuing in the centre of the road to the canal at Keith-bridge: on the north side the boundary extends westward down the centre of the canal to the London-road, thence crosses to the centre of Union road, terminating at the Lion Havelin-gate, the outer line of the fortifications of the towns of Portsea and Portsmouth forms the western boundary, on the south it is bounded by the sea.

ALL SAINTS DISTRICT.
