The carriages of the Cabinet Ministers and Great Officers of State may afterwards wait in the King's-court, those of the Ambassadors and Foreign Ministers in the Ambassadors'-court, and those of all other persons having the entrée may wait in Stable-yard or St. James's-park, till called for; they are then to take up in the same order as they had set down, pass away into Cleveland-row, and up the left hand side of St. James's-street.

No carriage will be admitted with company a second time with the same ticket, to prevent which, it must be produced at Constitution-hill-gate, and at Stable-yard-gate also, where a corner of it will be torn off by the Marshalmen in attendance; and no person can be allowed the privilege of the entree by

any other approach to the Palace than the gates above mentioned.

Tickets for carriages belonging to persons having the *entrée* will be delivered at the Board of Green Cloth, St. James's-Palace, on Tuesday next, between the hours of eleven and three o'clock.
