THEREAS by an Act, passed in the fourth year of the reign of His late Majesty King George the Fourth, intituled "An Act to authorise " His Majesty, under certain circumstances, to " regulate the duties and drawbacks on goods im-" ported or exported in foreign vessels, and to " exempt certain foreign vessels from pilotage;" His Majesty is authorised, by and with the advice of His Privy Council, or by any Order or Orders in Council, in all cases in which British vessels, of less burthen than sixty tons, are not required by law to take pilots, to exempt foreign vessels, being of less burthen than sixty tons, from taking on board a pilot to conduct them into or from any of the ports of the United Kingdom, any law, custom, or usage to the contrary notwithstanding :

His Majesty, by virtue of the power vested in him by the said Act, and by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, that, for the period of six months from and after the date of this Order, all vessels belonging to the subjects of His Majesty the King of the Belgians, and being of less burthen than sixty tons, which shall enter in, or clear out from, any of the ports of the United Kingdom shall be, and they are hereby, exempted from taking on board a pilot to conduct them into or from any such port, in all cases where British vessels, being of less burthen than sixty tons, are not required by law to take pilots, any law, custom, or usage to the contrary notwithstanding:

And the Right Honourable the Lords Commissioners of His Majesty's Treasury are to give the necessary directions herein accordingly.
