

a formal Resolution in this important Matter, and sign the Treaty proposed. The States of *Holland* have, it's said, ordered that the Papers of *Amsterdam* that were sealed up, shall be restored to the Deputies of that City.

*Brussels, June 23.* The French Army commanded by the *Marschal de Schomberg* continues encamped at *Leffines*, and it's said they are near 60000 strong. The Dutch and Spanish Troops we are told will change their Camp to-morrow, having consumed all the Forage where they now are. We had yesterday our Spanish Letters, which brought nothing considerable, except the account they give of the raising of the Siege of *Gironne*, and the retreat of the French Army: They tell us that the French lost in the Assault they made upon that place, above 4000 men and 107 Captains. Our Letters from *Cologne* of the 20th Instant inform us, that the Elector was removed from thence to *Bonne*, being very much dissatisfied with the Magistrates of *Cologne*. And from *Trier* we have an account that the *Marschal de Crequi* had put some Troops into that City, and that they were demolishing the Fortifications of it. The advices from *Hungary* say, The Imperial Army marches directly towards *Buda*, with intention to Besiege it; and confirm the news we had of a great Victory obtained by the Poles and Cossacks on the Frontiers of *Moldavia*; of the Turks and Tartars, who were marching to relieve *Caminiec*, 18000 with five or six Passes were killed or taken; and upon this defeat the Aga of the Janisaries, who was marching with a great Army towards *Hungary*, was called back and ordered to march towards *Valachia* and *Moldavia*.

*Paris, June 24.* The *Marschal de Schomberg*, according to our last advices from *Flanders*, was still encamped at *Leffines*, expecting the Resolution of the States General upon the offers that have been made to them by his Most Christian Majesty. On Sunday last we had an account that the *Marschal de Crequi* had put some men into *Trier*; and that they were working with great diligence to demolish the out-works, and to fill up the Ditches: It's said *Prince Waldeck* had a design to put 4000 Germans into that place, but coming too late, was obliged to retire again. On Wednesday last the Duke of *Mecklenbourg*, who has been some time here, was arrested by order of the King, and carried to *Vincennes*. The last Letters from *Catalonia* said, the *Marschal de Belfonds* was encamped at *S. Pere Pescador*, not being at present in a condition to undertake any thing considerable.

*Westminster, June 18.* This day according to a Rule made by the Court of *Kings Bench*, *Sir Peter Daniel* and *Samuel Dashwood* Esq; the present High Sheriff of *Middlesex*, attended the said Court with a Jury by them summoned, to enquire of Damages upon an Action of *Scandalum Magnatum*, brought by his Royal Highness against *Tizza Oates*, for saying his Royal Highness was a Traitor, with several such other Malignant and Scandalous Reflections upon his Royal Highness, to which Action the said *Oates* suffered Judgment to pass by Default; and after publick examination of several Witnesses in Court, who gave a full proof of the Words contained in the Declaration, and of divers others most Malicious and Scandalous words spoken of his Royal Highness by the said *Oates*, the Jury assented to his Royal Highness's Damages.

*Francis Smith* was brought to the *Kings Bench* Bar to receive the Judgment of the Court, being convicted of Publishing several Scandalous and Seditious Libels, and now lately of that called the *Race Sheet*. The Court ordered, He should pay a Fine of 500

That he should stand thrice in the Pillory, and the said Libel be burnt by the hands of the common Hangman; That he should find Sureties for his good Behaviour during his Life; and that he should be committed till all this was performed.
