PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the session of Parliament held in the third and fourth years of the reign of His present Majesty, intituled "An Act to regulate the trade of the "British possessions abroad," it is, amongst other things, enacted, that the several ports therein in that behalf mentioned shall be free warehousing ports for all the purposes of the said Act; and it is thereby further enacted, that it shall be lawful for His Majesty, by Order in Council, from time to time, to appoint any port in His Majesty's possessions in America, to be a free warehousing port for all or any of the purposes of the said Act; and that every port so appointed shall be, for all the purposes expressed in such Order, a free warehousing port under the said Act, as if appointed by the same:

And whereas His Majesty doth deem it expedient to appoint the port of Saint George, in the Bermudas, a free warehousing port under the said Act, subject to the proviso hereinafter contained:

Now, therefore, in pursuance and exercise of the powers and authorities in His Majesty by the said Act in that behalf vested, His Majesty, by and with the advice of His Privy Council, doth order, and it is hereby ordered, that the said port of Saint George, in the Bermudas, shall be a free warehousing port for all the purposes of the said Act:

Provided always, and it is hereby ordered, that nothing herein contained shall exempt any goods, wares, or merchandise, imported from the said port of Saint George into any of the British possessions in the West Indies, or on the Continent of South America, or into the Bahama Islands, from the pay-

ment of the duties now chargeable thereon in such places under the said Act:

And the Right Honourable the Lords Commissioners of His Majesty's Treasury are to give the necessary directions herein accordingly.

HEREAS there was this day read at the Board, the humble Memorial of Sir Henry Halford, Baronet, Physician to His Majesty, and President of the College or Commonalty of the Faculty of Physic in London, setting forth, that the said President and College have, with great care, pains, and industry, revised, corrected, and reformed a book, by them formerly published, intituled Pharmacopœia Collegii Regalis Medicorum Londinensis, prescribing and directing the manner of preparing all sorts of medicines therein contained, together with the true weights and measures by which they ought to be made; which book is now perfected and ready to be published, and, it is conceived, will contribute to the public good of His Majesty's subjects, by preventing all deceits, differences, and uncertainties in making and com-pounding of medicines, if, for the future, the manner and form prescribed therein should be practiced by apothecaries and others in their compositions of medicines; the Memorialist, therefore, most humbly prays, that His Majesty will be graciously pleased to enforce the observance thereof, in such manner as to His Majesty shall seem meet; His Majesty this day took the said Memorial into His royal consideration, and being desirous to provide, in all cases, for the common good of His people, and being persuaded that the establishing the general use of the said book may tend to the prevention of such deceits in the making and compounding medicines, wherein the lives and health of His Majesty's subjects are so highly concerned, hath, therefore, thought fit, by and with the advice of His Privy Council, hereby to notify to all apothecaries and others concerned, to the intent they may not pretend ignorance thereof, that the said book, called Pharmacopœia Collegii Regalis Medicorum Londimensis, is perfected and ready to be published; and His Majesty doth, therefore, strictly require, charge, and command all and singular apothecaries and others, whose business it is to compound inedicines, or distil oils or waters, or make other extracts, within any part of His Majesty's kingdom of Great Britain called England, dominion of Wales, or town of Berwick-upon-Tweed, that they and every of them, immediately after the said Phar. macopœia Collegii Regalis Medicorum Londinensis shall be printed and published, do not compound ro make any medicine or medicinal receipt or prescription, or distil any oil or waters, or make other extracts, that are or shall be in the said Pharmacopœia Collegii Regalis Medicorum Londinensis mentioned or named, in any other manner or form than is or shall be directed, prescribed, and set down by the said book, and according to the weights and measures that are or shall be therein limited, except it shall be by the special direction or prescription of some learned physician in that behalf; and His Majesty doth hereby declare, that the offenders to the contrary shall not only

ceeded against for such their contempt and offences, according to the utmost severity of law.

THE following is a copy of an Order of His Majesty in Council, assigning a district, under the 16th section of the 59th Geo. 3, cap. 134, to Saint Peter's Chapel, in the parish of Hammersmith:

At the Court at St. James's, the 19th day of August 1836, present, the King's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the 58th year of the reign of His late Majesty King George the Third, intituled "An Act for building, and promoting the building, of additional churches in populous parishes," it is, amongst other things, en-acted, " that in every case in which the Commissioners appointed for carrying into execution the purposes of the said Act, shall be of opinion that it will be expedient to divide any parish into two or more distinct and separate parishes, for all ecclesiastical purposes whatever, it shall be lawful for the said Commissioners, with the consent of the Bishop of the diocese in which such parish is locally situated, signified under his hand and seal, to apply to the patron or patrons of the church of such parish for his consent to make such division, and for such patron or patrons to signify his or their consent thereto, under his hand and seal; and the said Commissioners shall, upon the consent of the said patron or patrons so signified, represent the whole matter to His Majesty in Council, and shall state in such representation the bounds by which it

is proposed, with such consent as aforesaid, to divide such parish, together with the relative and respective proportions of glebe land, tithes, moduses, or other emoluments, which will by such division arise and accrue, and remain and be within each of such respective divisions, and also the relative proportions of the estimated amount of the value or produce of fees, oblations, offerings, or other ecclesiastical dues or profits, which may arise and accrue within each of such respective divisions; and if, thereupon, His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting steh division; provided always, that no such division of any parish into distinct parishes shall completely take effect until after the death, resignation, or other avoidance of the existing incumbent of the parish to be divided;" and whereas by the said Act it is further enacted, " that in any case in which the said Commissioners shall be of opinion that it is not expedient to divide any populous parish, or extra parochial place, into such complete, separate, and distinct parishes as aforesaid, but that it is expedient to divide the same into such ceclesiastical districts as they, with the consent of the Bishop, signified under his hand and seal, may deem necessary, for the purpose of affording accommodation for the attending divine service, according i to the rites of the United Church of England and . Ireland, to persons residing therein, in the churches wand parochial chapels already built, or in additional churches or chapels to be built therein, and as may appear to such Commissioners to be convenient for the enabling the spiritual person or persons who may serve such churches or chapels, to perform all ecclesiastical duties within the districts attached to such respective churches and chapels, and for the due ecclesiastical superintendence of such district, and the preservation and improvement of the religious and moral habits of the persons residing therein, the said Commissioners shall represent such opinion to His Majesty in Council, and shall state in such representation the bounds by which such districts are proposed to be described; and if, thereupon, His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Ccuncil shall be valid and good in law for the purpose of effecting such divisions." and whereas by an Act, passed in the 59th, year of His "An Act to amend and render nurre effectual in Act, passed in the last session, of Parlia-ment, for building, and promoting the building, of additional churches in populous parishes;" it is, any any approximately and the first session of the first parliament. amongst other things, enacted, " that it shall be lawful for the Commissioners, in the same manher and with the like consents as are required in case of division into ecclesiastical districts under the said recited Act, or the said Act now in recital, to assign a particular district to any chapel of ease gr parochial chapel already existing, or to any chapel built, or which may hereafter be built, or ac quired under the powers of the said former Act, or the said Act now in 'recital; and such district shall be under the immediate care of the Curate appointed to serve such chapel, but subject, nevertheless, to the superintendence and controul of the incumbent of the parish church; and all such Curates shall be chapel, under the provisions of the 16th section of

nominated by the incumbent of the parish to the Bishop for his licence, except where the right of nomination shall already be legally vested in any other persón or persons, and in every such case by the person or persons possessing such right of nomination, subject to all the laws in force relating to Stipendiary Curates, except as to the assigning of salaries to such Curates; provided always, that it shall be lawful for the Commissioners, with the consent of the Bishop of the diocese, to determine whether any and what part or proportion of the fees or dues for marriages, baptisms, churchings, and burials shall be assigned to any such Curate; and whether banns of marriages shall be published, and marriages or baptisms, churchings or burials, shall be solemnized or performed in any such chapel or not; and in any case in which marriages shall be allowed in any such chapel, the Commissioners shall cause the boundaries of the district assigned to such chapel to be enrolled in the High Court of Chancery, and in the office of the Registry of the diocese, any thing in the said recited Act to the contrary notwithstanding; and no such chapel shall become a benefice by reason of any augmentation of the maintenance of the Curate, or by any grant or bounty under the provision of any Act or Acts of Parliament, or law or laws for augmenting small livings, any thing in such Act or Acts of Parliament, or law or laws, to the contrary notwithstanding;" and whereas by another Act, passed in the 7th and 8th years of the reign of His late Majesty, intituled "An Act to amend the Acts for building, and promoting the building, of additional churches in populous parishes;" and by another Act, made and passed in the 1st and 2d year of His present Majesty, intituled " An Act to amend and render more effectual an Act, passed in the 7th and 8th years of the reign of His late Majesty, intituled . An Act to amend the Acts for building, and promoting the building, of additional churches in populous parishes; " and also by another Act, made and passed in the 2d and 3d year of His present Majesty, intituled "An Act to render more effectual an Act, passed in the 59th year of His late Majesty King George the Third, intituled 'An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes;'" further provisions are made for carrying such divisions into effect:

And whereas the said Commissioners have made a representation to His Majesty in Council, stating that when the last census was taken, the parish of Hammersmith, in the county of Middlesex and diocese of London, contained a population of 10,222 persons; that besides the parish church, which affords accommodation to 100 persons, there is one chapel in the said parish, recently built by your Majesty's said Commissioners, called Saint Peter's Chapel, which affords accommodation to 1600 persons, including 600 free seats, appropriated to the use of the poor, and in which divine service is regularly performed :

And whereas the said Commissioners have further hepresented to His Majesty, that, having taken into consideration all the circumstances attending this parish, it appears to them to be expedient, that a particular district should be assigned to the said

an Act, passed in the 59th year of the reign of His Majesty King George the Third, intituled "An Act to amend an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes;" and that such district should be named Saint Peter's District, with boundaries as follows:

It is bounded on the west by the parish of Chiswick; on the south by the River Thames, the creek, the high bridge, and the warple way, including the north side of that way to the southern extremity of Waterloo-street; on the east, northwardly, Waterloostreet, including the west side of that street; then, westward, by King's-street, including the south side thereof, that is, the turnpike road leading from London to Brentford, as far as Webb's-lane; then, northward, again by Webb's-lane as far as Gold Hawke-road, including all the west side thereof; and on the north by Gold Hawke-road, including all the south side thereof, until the said ancient road terminates in Chiswick parish, at Stamford Brook, as the same is more particularly delineated in the plan annexed to the said representation, and therein coloured green :

That marriages, baptisms, churchings, and burials should be performed in the said chapel and chapelyard; and that two thirds of the fees arising therefrom, as well as from the erection of monuments, tombstones, or gravestones, registrations and certificates, which would become due to the Vicar of Hammersmith, should belong to, and be received by, the Minister of the said chapel for the time being:

That the consent of the Lord Bishop of London has been obtained thereto, as required by the abovementioned section of the said Act passed in the 59th year of the reign of His Majestv King George the Third, in testimony of which he has signed and scaled the said representation; and humbly praying, that His Majesty would be graciously pleased to take the premises into His royal consideration, and to make such order in respect thereto, as to His Majesty in His royal wisdom shall seem meet:

His Majesty, having taken the said representation, together with the plan thereunto annexed, into consideration, was pleased, by and with the advice of His Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed division be accordingly made and effected agreeably to the provisions of the Acts.
