This day, the Lords being met, a message was sent to the Honourable House of Commons by the Gentleman Usher of the Black Rod, acquainting them, that The Lords, authorised by firtue of a Commission under the Great Seal, signed by Her Majesty, for declaring Her Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Arch-hishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An Act to explain and amend two Acts, passed in the last session of Parliament, for marriages, and for registering births, deaths, and marriages in England.

An Act for continuing, until the first day of June one thousand eight hundred and thirty nine, and to the end of the then next session of Parliament, the several Acts for regulating the turnpike roads in Great Britain which will expire with the present or with the next session of Parliament.

An Act to empower the recorder or other person presiding in quarter sessions in corporate cities and tou us, and justices of the peace for counties, ridings, or divisions, to divide their respective courts in certain cases.

HE following is a copy of an Order of His.

Majesty in Council, for assigning an ecclesiastical district, under the provisions of the 21st section of the 58th Geo. 3, cap. 45, to St. Paul's.
Chapel, in the parish of St. Peter the Great, otherwise Subdeanry Chichester:

At the Court at St. James's, the 10th day of May 1837, present, the King's Most. Excellent Majesty in Council.

WHEREAS by an Act, passed in the 58th year of the reign of His late Majesty King George-the Third, intituled "An Act for building, and promoting the building, of additional churches in populous parishes," it is, amongst other things, enacted, "that in every case in which the Commissioners appointed for carrying into execution the purposes of the said Act, shall be of opinion that it will be expedient to divide any parish into two or more distinct and separate parishes, for all

Bishop of the diocese in which such parish is locally situated, signified under his hand and seal, to apply to the patron or patrons of the church of such parish for his consent to make such division, and for such patron or patrons to signify his or their consent thereto, under his hand and seal; and the said Commissioners shall, upon the consent of the said patron of patrons so signified, represent the whole matter to His Majesty in Council, and shall state in such representation the bounds by which it is proposed, with such consent as aforesaid, to divide such parish, together with the relative and respective proportions of glebe land, tithes, moduses, or other emoluments, which will by such division arise and accrue, and remain and be within each of such respective divisions, and also the relative proportions of the estimated amount of the value or produce of fees, oblations, offerings, or other ecclesiastical dues or profits, which may arise and accrue within each of such respective divisions; and if, thereupon, His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting such division; provided always, that no such division of any parish into distinct parishes shall completely take effect until after the death, resignation, or other avoidance of the existing incumbent of the parish to be divided;" and whereas by the 21st section of the said Act it is further enacted, "that in any case in which the said Commissioners shall be of opinion that it is not expedient to divide any populous parish, or extra parochial place, into such complete, separate, and distinct parishes as aforesaid, but that it is expedient to divide the same into such ecclesiastical districts as they, with the consent of the Bishop, signified under his hand and scal, may deem necessary, for the purpose of affording accommodation for the attending divine service, according to the rites of the United Church of England and Ireland, to persons residing therein, in the churches and parochial chapels already built, or in additional churches or chapels to be built therein, and as may appear to such Commissioners to be convenient for the enabling the spiritual person or persons who may serve such churches or chapels, to perform all ecclesiastical duties within the districts attached to such respective churches and chapels, and for the duc ecclesiastical superintendence of such district, and the preservation and improvement of the religious and moral habits of the persons residing therein, the said Commissioners shall represent such opinion to His Majesty in Council, and shall state in such representation the bounds by which such districts are proposed to be described; and if, thereupon, His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting such division:" and whereas by an Act, passed in the 59th year of His late Majesty King George the Third, intituled " An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building,

ecclesiastical purposes whatever, it shall be lawful of the reign of His late Majesty, intituled for the said Commissioners, with the consent of the "An Act to amend the Acts for building, and promoting the building, of additional churches in populous parishes;" and by another Act, made and passed in the 1st and 2d year of His present Majesty, intituled "An Act to amend and render more effectual an Act, passed in the 7th and 8th years of the reign of His late Majesty, intituled An Act to amend the Acts for building, and promoting the building, of additional churches in populous parishes; " and also by another Act, made and passed in the 2d and 3d year of His said Majesty, intituled "An Act to render more effectual an Act, passed in the 59th year of His late Majesty King George the Third, intituled An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes;" further provisions are made for carrying such divisions into effect:

And whereas the said Commissioners have made a representation to His Majesty in Council, stating that, when the last census was taken, the parish of Saint Peter the Great, otherwise Subdeanry, lying partly within and partly without the liberties of the city of Chichester, in the county of Sussex, and in the diocese of Chichester, contained a population of 4579 persons; that there is, besides the parish church, which affords accommodation for 500 persons, one chapel recently erected in the said parish, which affords accommodation to 1040 persons, including 658 free seats, appropriated to the use of the poor; that such chapel has been consecrated, and is called Saint Paul's Chapel, and divine service is regularly performed therein:

And whereas the said Commissioners have further represented to His Majesty, that, having taken into consideration all the circumstances attending this parish, it appears to them to be expedient that the parish should be divided into ecclesiastical districts, under the 21st section of the said Act, passed in the 58th year of the reign of His Majesty King George the Third, and that one of such districts should be assigned to the said chapel of Saint Paul, for the purpose of affording accommodation for attending divine service to the persons residing in the said district, and for enabling the spiritual person serving such chapel to perform all ecclesiastical duties within the said district, and for the due ecclesiastical superintendence of such district, and the preservation and improvement of the moral habits of the persons residing therein, and that such district should be named the District Parish of Saint Paul, with boundaries as follows:
