HEREAS it is deemed expedient by Her Majesty, by and with the advice of Her Privy Council, to make certain new regulations, in manner following, for the attendance of the Justices in the Police Offices hereinafter mentioned, it is hereby ordered by Her Majesty, by and with the advice of Her Privy Council, that one of the Justices appointed to the several Police Offices now, established in the parishes of St. Margaret, Westminster; Saint James, Westminster; St. Mary-le-bone, Saint Andrew, Holborn; St. Leonard, Shoreditch; Saint Mary, Whitechapel; and St. John, of Wapping, in the county of Middlesex; and St. Saviour, of the county of Surrey; shall, from and after the thirteenth day of August next, attend at each of the said offices from the hour of ten of the clock in the morning until five of the clock in the afternoon; and that two of the said Justices shall, in like manner, attend together at each of the said offices, from twelve of the clock at noon until three of the clock in the afternoon, instead of the hours at which they are now required to be in attendance, according to the form of the Statute in such case made and provided:

And the Right Honourable Lord John Russell, one of Her Majesty's Principal Secretaries of State, is to give the necessary directions herein accordingly.

HEREAS Her Majesty's Royal Predecessors were pleased, from time to time, by their respective Orders made in Council, to declare and signify their pleasure, that their servants should have and enjoy all ancient liberties, rights, and privileges; and that none of their servants in ordinary with fee should be enforced or obliged to bear any public office, serve on juries or inquests, or be subjected to any mulct or fine for not submitting thereunto: Her Majesty, this day taking the same into consideration, and thinking it reasonable that all Her servants in ordinary with fee, should, in regard to their constant attendance upon Her Majesty's Person, enjoy the like privileges with those of Her Predecessors, doth therefore hereby order, with the advice of Her Privy Council, that the Lord Chamberlain of Her Majesty's Household, in relation to such of Her Majesty's servants who are under his Lordship's command above stairs; and the Lord Steward of Her Majesty's Household, or, in his absence, Her Majesty's Officers of the Green Cloth, as to such as are accounted Officers below stairs; and the Master of the Horse, for the servants belonging to the stables, do respectively signify unto the Lord Mayor of London, and to Her Majesty's Justices of the Peace, within the city of Westminster, counties of Middlesex and Surrey, and the Mayors, Sheriffs, and Bailiffs, of any corporation, or county, and to all such as may be therein concerned, whensoever there shall be cause for asserting the said privilege, that Her Majesty has thought proper, conformably to the example of Her Predecessors in this behalf, to order and require, that Her servants should have, hold, and enjoy all the said liberties, rights, and privileges; and that henceforward none of Her servants in ordinary with fee, be enforced or any ways obliged to bear any public offices, serve on juries or inquests, watch or ward, in any place where they dwell, or elsewhere, nor subjected to any mulct or fine for not submitting thereunto: And the Lord Chamberlain of Her Majesty's Household for those servants above stairs, the Lord Steward of Her Majesty's Household, and, in his elsence Majesty's Officers of the Green Cloth, for the servants below stairs, and the Master of the Horse for the servants belonging to the stables, are hereby authorised and required to take especial carethat this Her Majesty's pleasure be duly observed and put in execution; and that Her Majesty's Attorney General for the time being be, and he is hereby authorised and required, upon any application made to him by any of Her Majesty's servants in ordinary with fee, to cause a stop to be put to all proceedings already had or to be commenced against them, or any of them, for refusing to watch or to serve on juries, or bear or undergo any public office or employment above-mentioned; and Her, Majesty doth hereby further order, that copies of this Order be left with the respective Clerks of the Peace for the cities of London and Westminster, and counties of Middlesex and Surrey, to be kept amongst the records of Her Majesty's Sessions, to the intent that due obedience may be given thereunto, and Her servants may not be vexed with unreasonable proceedings.

#### PRESENT.

The QUEEN's Most Excellent Majesty in Council.

HEREAS by an Act, passed in the last session of Parliament, intituled "An Act for " carrying into effect the reports of the Com-" missioners appointed to consider the state of " the Established Church in England and Wales, " with reference to ecclesiastical duties and re-" venues, so far as they relate to episcopal dioceses,. " revenues, and patronage," reciting, amongst other things, that His late Majesty was pleased, on the fourth day of February, and on the sixth day of June, in the year one thousand eight hundred and thirty-five, to issue twoseveral commissions to certain persons therein respectively named, directing them to consider the stateof the several dioceses in England and Wales, with reference to the amount of their revenues, and the more equal distribution of episcopal duties, and theprevention of the necessity of attaching, by commendam, to bishoprics, benefices with cure of souls; and to consider also the state of the several cathedral and collegiate churches in England and Wales, with a view to the suggestion of such measures as. might render them conducive to the efficiency of the-Established Church, and to devise the best mode of ... providing for the cure of souls, with special reference to the residence of the clergy on their respective benefices; and reciting; that the said Commissioners had, in pursuance of such directions, madefour several reports to His said late Majesty, bearing date respectively the seventeenth day of March onethousand eight hundred and thirty-five, and the fourth day of March, the twentieth day of May, and the twenty-fourth day of June, one thousand eight hundred and thirty-six; and reciting, that the said Commissioners had in their said reports, amongst other things, recommended that commissioners should be appointed by Parliament for the purpose of preparing and laying before His Majesty in Council such schemes as should appear to them to be best adapted for carrying into effect, amongst other things, the following recommendations; and that His Majesty in Council should be empowered to make Orders ratifying such schemes, and having the full force of law; and that, in order to provide for the augmentation of the incomes of the

bishopricks, such fixed annual sums should be paid to the Commissioners out of the reve nues of the larger sees respectively as should, upon due inquiry and consideration, be determined on, so as to leave, as an average annual income, to the Archbishop of Canterbury fifteen thousand pounds, to the Archbishop of York ten thousand pounds, to the Bishop of London ten thousand pounds, to the Bishop of Durham eight thousand pounds, to the Bishop of Winchester seven thousand pounds, to the Bishop of Ely five thousand five hundred pounds, to the Bishop of Saint Asaph Bangor five thousand two hundred pounds, to the Bishops of Worcester, and Bath and Wells respectively five thousand pounds; that out of the fund thus accruing, fixed annual payments should be made by the Commissioners, such instances and to such amount as should be in like manner determined on, so that the average annual incomes of the other bishops respectively should be not less than four thousand pounds, nor more than five thousand pounds:

It is enacted, amongst other things that the Lord Archbishop of Canterbury for the time being, the Lord Archbishop of York, and the Lord Bishop of London for the time being, John Lord Bishop of Lincoln, James Henry Lord Bishop of Gloucester, the Lord High Chancellor of Great Britain, the Lord President of the Council, the Lord High Treasurer or the First Lord of the Treasury, and the Chancellor of the Exchequer for the time being, respectively, and such one of His Majesty's Principal Secretaries of State as should be for that purpose nominated by His Majesty, under His royal sign manual (such Lord Chancellor, Lord President, Lord High Treasurer or First Lord of the Treasury, Chancellor of the Exchequer, and Secretary of State being respectively members of the United Church of Great Britain and Ircland), the Right Honourable Dudley Earl of Harrowby, the Right Honourable Henry Hobhouse, and the Right Honourable Sir Herbert Jenner, Knt. should, for the purposes of this Act, be one body politic and corporate, by the name of the Ecclesiastical Commissioners for England, and by that name should have perpetual succession and a common seal:

And it is further enacted, that the said Commis sioners should, from time to time, prepare and lay before His Majesty in Council such schemes as should appear to the said Commissioners to be best

recited recommendations, and should in such schemes recommend and propose such measures as might upon further inquiry, which the said Commissioners are thereby authorised to make, appear to them to be necessary for carrying such recommendations into full and perfect effect; provided always, that nothing therein contained should be construed to prevent the said Commissioners from proposing in any such scheme such modifications or variations, as to matters of detail and regulation, as should not be substantially repugnant to any or either of the said recommendations:

And it is further enacted, that when any scheme, prepared under the authority of the said Act, should be approved by His Majesty in Council, it should be lawful for His Majesty in Council to issue an Order or Orders ratifying the same, and specifying the time or times when such scheme, or the several parts thereof, should take effect, and to direct in every such Order that the same should be registered by the registrar of each of the dioceses, the bishops whereof might or should be in any respect' affected thereby:

And it 's further enacted, that every such Order, as soon as might be after the making and issuing thereof by His Majesty in Council, should be inserted and published in the London Gazette:

And it is further enacted, that, so soon as any such Order in Council should be so registered and gazetted, it should in all respects, and as to all things thereincontained, have and be of the same force and effect as if all and every part thereof were included in the said Act, any law, statute, canon, letters patent, grant, usage, or custom to the contrary notwithstanding:

And whereas the said Commissioners, pursuant to the authority vested in them by the said Act, have duly prepared and laid before Her Majesty in Council a scheme, bearing date the seventh day of July one thousand eight hundred and thirtyseven, in the words and figures following, that is to say:

the Ecclesiastical Commissioners for England, appointed and incorporated by an Act passed in the last session of Parliament, intituled " An Act for carrying into effect the reports " of the Commissioners appointed to con-" sider the state of the Established Church in " England and Wales, with reference to ecclesias. adapted for carrying into effect the thereinbefore | " tical duties and revenues, so far as they relate "to episcopal dioceses, revenues, and patronage," have, in pursuance of the said Act prepared, and now humbly lay before your Majesty in Council, the following scheme for fixing the annual sum to be paid by us for the augmentation of the income of the bishoprick of Liehfield.

We humbly recommend andd ropose, that in order to raise the average annual income of the Bishop of Lichfield to the sum of four thousand five hundred pounds, as near as may be, there shall be paid by us to the Right Reverend Samuel now Bishop of Lichfield, and his successors, bishops of Lichfield for the time being, out of such moneys as shall from time to time be standing to our credit and account in the Bank of England, being part of payments from the larges sees respectively, towards the augmentation of the incomes of the bishops of the smaller sees, the fixed annual sum of eight hundred and fifty pounds, by equal half-yearly payments, on the thirteenth day of February, and the thirteenth day of August in every year; and that the first of such payments, to the thirteenth day of February last, shall be made forthwith, and that the next of such payments shall be made on the thirteenth day of August next; and that whenever a vacancy of the see of Lichfield shall happen, on any other day than the thirteenth day of February, or the thirteenth day of August, the next half-yearly payment shall be apportioned between the bishop making the vacancy or his representatives, and the bishop succeeding to the see, according to the time which shall have elapsed from the last half-yearly day of payment to the day of the vacancy, inclusive, and such proportions shall be paid to the respective parties accordingly.

And whereas the amount of the moneys from time to time applicable to the purposes aforesaid, and to the augmentation of any other of the smaller sees upon vacancies occurring therein respectively, will depend on the contingency of vacancies occurring among the larger sees from which payments are hereafter to be made towards such purposes; and the amount of the demand upon such moneys will depend on the contingency of vacancies occurring among the said smaller sees; and it may therefore happen that the demands upon such moneys may for a time exceed the amount thereof; we further recommend and propose, that if at the commencement of any half year calculated from the first day of January to the last day of June, and from the first day of July to the last day of December respec-

tively, it shall appear to us that there will in the current half year be a deficiency of the said moneys to pay the sums then charged thereon, and payable in the same half year, it shall be lawful for us to resolve that a deduction be made from the sum payable in the same half year to the Bishop of Lichfield for the time being, and from the sums payable to the respective bishops of other smaller sees, who by virtue of any other scheme prepared or to be prepared by us, and of any Order or Orders of your Majesty in Council for ratifying the same, shall then be entitled to payments. in augmentation of their respective incomes, so as to keep the sums to be paid during the same half year within the amount of the moneys applicable as aforesaid, during such half year; and to calculate such deduction in proportion to the sums which have been or may be named in this and every such other scheme as the future annual average income of the said sees respectively; and that upon the amount of every such deduction being certified by us or by our secretary, to the bishop to be affected thereby, within fourteen days after the commencement of such half year, the said bishop shall have no present claim to any greater sum than the residue of his half yearly payment after such deduction as aforesaid, nor any future claim, except as is hereinafter mentioned; that is to say, that so soon thereafter as the sums to be paid to us in any half year, applicable to the purposes aforesaid, shall exceed the sums to be paid by us for those purposes within the same half year, we shall be authorized and bound to divide the surplus rateably among the bishops from whose payments such deductions shall have been made, or the representatives of such of them as shall be dead, and so from half year to half year, until the whole sums deducted shall be paid; the deductions of one half year to be paid before any payment shall be made on account of the deductions of any subsequent half year.

And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the said bishopric of Lichfield, in conformity to the provisions of the said Act.

All which we humbly recommend and propose to your Majesty in Council.

In witness whereof we have hereunto set our common seal, this seventh day of July in the year one thousand eight hundred and thirty-seven.

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall take effect immediately from and after the time when the same shall have been registered as hereinafter directed, and shall have been duly published in the London Gazette pursuant to the said Act, and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of Lichfield.

#### Foreign-Office, August 11, 1837:

A DISPATCH, dated the 2d June 1837, has been received by the Right Honourable Viscount Palmerston, G.C.B. Her Majesty's Principal Secretary of State for Foreign Affairs, from the Honourable Charles Ashburnham, Her Majesty's Chargé d'Affaires at Mexico, transmitting a Proclamation of the Mexican Government, of which the following is a translation:

#### PROCLAMATION.

The President of the Mexican Republic to the Inhabitants thereof; know, that the 68th article of the general tariff of the maritime and frontier customlrouses, declaring that the said tariff should not begin to take its full effect until six months after its publication in this capital, was dictated for the benefit of commerce, with the important object of regulating that of all nations upon a footing of perfect equality; and consequently, provided that this just principle be observed, all those regulations of the said tariff which are notoriously favourable to commerce in general, as stimulating speculation, and as destructive of fraudulent traffick, as pernicious to the public good as to commerce itself, may immediately come into operation, and be observed; and, in order that commerce may, as soon as possible, enjoy the aforesaid advantages, I have thought fit to Decree as follows:

Art. 1. From the date of the publication of this Decree, in every port or place where there are maritime or frontier custom-houses, those articles of the general tariff of the 11th March last, which hereinafter shall be enumerated, shall begin to be observed, maritime custom-houses being bound to for shipping or unshipping cargoes; but the noti-

observe all, and those of the frontier such as apply to them.

Art. 2. The articles of the new tariff which shall immediately come into operation, at the aforesaid custom-houses, according to the terms of the foregoing article, are the following:

First. The second article, which lowers the amount of tonnage duties.

Second. The 3d and 4th articles, which accords to ships after taking on board their cargoes, to proceed to another port with the view to ship produce of the country which is exempt from duty, and which (articles) prescribe the formalities under which this concession is to be made use of.

Third. The 20th and 21st articles relative to the cessation, in ordinary cases, of the custom of placing a permanent guard of tidesmen (celadores) on board: relative to the guards keeping watch, by rounds, at a distance, and to its being the duty of the officer commanding the tidesmen, or of the Customhouse officers, to seal up the hatchways and bulkheads of the vessel.

Fourth. The 23d article, which imposes penalties upon any person who fraudently may break the seals; but this article shall be expressly and formally notified to the master of the ship by the officer commanding the tidesmen, or the Custom-house officer, on his coming on board to take the manifests.

Fifth. The 44th article, relative to the regulations: to be observed with regard to applications for passing. the cargo.

Sixth. The 45th article, which names the Customhouse functionaries, whose duty it is to attend at the passing of the goods.

Seventh. The 56th article, by which it is provided that Mexican Consuls and Vice-Consuls shall forward to the Custom-house statements of pricescurrent, which shall be made use of in the way pointed out in the 57th article, when the tariff comes into force in all its parts.

Eighth. The 65th article, which regulates the examination of goods in the Custom-houses.

Ninth. The 91st article, which imposes penalties on masters of ships, or supercargoes, in every case of making trans-shipment of goods to another vessel, or permitting it on board their own; but this article shall be expressly and formally notified to the captains, or supercargoes, by the officer commanding the tidesmen upon their coming on board.

Tenth. The 92d article, which fixes the legal hours

fication, as prescribed in the foregoing paragraph, shall be previously made.

Eleventh. The 93d, 91th, and 95th articles, refating to the penalties denounced against Customhouse officers, and other public functionaries, for aiding or concealing smuggling; and authorising the informers to be present at the examination of goods seized in consequence of their information.

Twelfth. All the articles of the 7th chapter, relative to the distribution of confiscations, except as to pecuniary and personal penalties, inasmuch as, until the 17th day of September inclusive, of this year, those imposed by the laws in force previously to the 11th of March last, shall continue in full effect.

Article 3. The remaining articles of the new tariff not expressly declared by this Decree to be in force from the time of its publication in the respective places, shall not commence taking effect until from the 18th day, inclusive, of September of this year, the general tariff of 16th November 1827, the law of 31st March 1831, and the other existing regulations remaining in the mean time in force and vigour in all such matters as are not altered or modified by those articles of the new tariff as are enumerated in the present Decree.

I accordingly command that it be published, circulated, and duly observed.

parishes shall completely take effect until after the death, resignation, or other avoidance of the existing incumbent of the parish to be divided;" and it is thereby further enacted, "that in any case in which the said Commissioners shall be of opinion that it is not expedient to divide any populous parish or extra parochial place into such complete, separate, and distinct parishes as aforesaid, but that it is expedient to divide the same into such ecclesiastical districts as they, with the consent of the Bishop, signified under his hand and seal, may deem necessary, for the purpose of affording accommodation for the attending divine service, according to the rites of the United Church of England and Ireland, to persons residing therein, in the churches and parochial chapels already built, or in additional churches or chapels to be built therein, and as may appear to such Commissioners to be convenient for the enabling the spiritual person or persons who may serve such churches or chapels to perform all ecclesiastical duties within the districts attached to such respective churches and chapels, and for the due ecclesiastical superintendence of such districts, and the preservation and improvement of the religious and moral habits of the persons re-siding therein, the said Commissioners shall represent such opinion to His Majesty in Council, and shall state in such representation the bounds by which such districts are proposed to be described; and if, thereupon, His Majesty in Council shall think fit to direct such division to be made, such Order of His Majesty in Council shall be valid and good in law for the purpose of effecting such division; and whereas by an Act, passed in the 59th year of His late Majesty King George the Third, intituled "An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes," after reciting, " that a considerable population is frequently collected together at the extremities of, and locally situate in, parishes, or extra parochial places contiguous to each other, at a distance from the respective churches or chapels of such respective parishes, or extra parochial places, it is enacted, "that it shall be lawful for the said Commissioners, with such consent as is required by the said herein before recited Act, in the case of district parishes to unite and consolidate any such contiguous parts of such parishes, and extra parochial places, into a separate and distinct district for all ecclesiastical purposes, and to cause such district to be named, ascertained, and marked out by described bounds, and such name and the description of such bounds, when approved by His Majesty in Council, to be enrolled in the High Court of Chancery, and in the office of the Registry of the diocese to which such district shall belong, under the provisions of the said Act; and to make grants or loans for or towards the building of, or to build, any chapel or chapels, with or without cemetries, in and for the use of the inhabitants of any such district, in such manner, and under such regulations as may, in the judgement of the Commissioners, appear from the circumstances to be most expedient, and to constitute any such district or conunder the superintendance of such spiritual person as shall be appointed, under the provisions of the said Act now in recital, to serve any such chapel; and such spiritual person shall have the cure of souls in such district, and the right of presentation and appointment of such spiritual person shall thenceforth belong to such person or persons, and be exercised in such manner as may be agreed by the several patrons of the churches or chapels of such parishes and extra parochial places respectively, with the approbation of the Commissioners; and banns of marriage may be published, and that marriages, christenings, churchings, and burials may be solemnized and performed in any such chapel, immediately and at all times after the consecration thereof; and the pew rents in such chapel shall be fixed, and salaries to the minister and clerk assigned therefrom, in such manner as is directed in the said hereinbefore recited Act, or in the said Act now in recital, concerning pew rents and salaries in separate or district parishes; and that all fees and offerings which may arise and accrue within such chapelry, according to such table of fees as the Commissioners shall make, with the approbation of the Bishop, may be demanded, received, sued for, prosecuted, and recovered by the spiritual person having cure of souls therein, and by the clerk and sexton of such chapelries, in like manner as if every such chapelry was a distinct parish; and that it shall be lawful for such said Commissioners, and they are by the the Act now in recital required in every said case, to ascertain and make compensation, in manner directed in like cases under the said recited Act, for any loss which may be sustained by the incumbent of any contiguous parish, or extra parochial place, which shall form any part of such district, by reason of any fees, oblations, and offerings being transferred to the spiritual person serving any such chapel; and that all such chapelries shall be deemed to be benefices, and be subject to the jurisdiction of the Bishop and Archdeacon within whose diocese and archdeacoury the altar of such chapel shall be locally situate, and to all the laws in force concerning presentation and appointment to benefices and churches and lapse, and all other laws relating to the holding of benefices and churches:

And it is, by the said Act now in recital, amongst other things, further enacted " that it shall be lawful for the Commissioners, in the same manner and with the like consents as are required in case of division into ecclesiastical districts under the said herein-before recited Act, or the said Act now in recital, to assign a particular district to any chapel of ease or parochial chapel already existing, of to any chapel built, or which might thereafter be built, or required under the powers of the said former Act, or the said Act now in recital; and such district shall be under the immediate care of the Curate appointed to serve such chapel, but subject, nevertheless, to the superintendence and controll of the incumbent of the parish church; and that all such Curates shall be nominated by the incumbent of the parish to the Bishop for his licence, except where the right of nomination shall already be legally vested in any other person or persons, and in every such case by the person or persons possessing such right of nomination, subject to all the laws in force relating to

Stipendiary Curates, except as to the assigning of salaries to such Curates; provided always, that it shall be lawful for the Commissioners, with the corsent of the Bishop of the diocese, to determine whether any and what part or proportion of the fees or dues for marriages, baptisms, churchings, and burials shall be assigned to any such Curate; and whether banns of marriage shall be published, and marriages or baptisms, churchings or burials, shall be solemnized or performed in any such chapel or not; and in any case in which marriages shall beallowed in any such chapel, the Commissioners shall cause the boundaries of the district assigned to such chapel to be enrolled in the High Court of Chancery, and in the office of the Registry of the diocese, any thing in the said recited Act to the contrary notwithstanding; and no such chapelry shall become a benefice by reason of any augmentation of the maintenance of the Curate, by any grant or bounty under the provisions of any Act or Acts of Parliament, or law or laws for augmenting small livings, any thing in such Act or Acts of Parliament, or law or laws, to the contrary notwithstanding; and whereas by another Act, passed in the 7th and 8th years of the reign of His late Mājesty King George the Fourth, intituled "An Act to amend the Acts for building, and promoting the building, of additional churches in populous parishes;" and by another Act, made and passed in the 1st and 2d year of His late Majesty King William the Fourth, intituled "An Act to amend and render more effectual an Act, passed in the 7th and 8th years of His late Majesty, intituled 'An Act to amend the Acts for building, and promoting the building, of additional churches in populous parishes;'" and also by another Act, made an passed in the 2d and 3d years of His said late Majesty, intituled "An Act to render more effectual an Act, passed in the 59th year of His late Majesty King George the Third, intituled 'An Act to amend and render more effectual an Act, passed in the last session of Parliament, for building, and promoting the building, of additional churches in populous parishes," further provisions are made for carrying such divisions into effect:

that the extremities of the said parishes of Buxted and Mayfield which lie contiguous to each other, at Hadlow Down, and are delineated in the plan accompanying the said representation, and contain a

population of 10:)0 persons:

And whereas the said Commissioners have further represented to His late Majesty that, having taken into consideration all the circumstances above mentioned, it appears to them to be expedient to unite and consolidate the said contiguous parts of the said parishes of Buxted and Mayfield into a separate and distinct district, to be assigned to the said chapel for all ecclesiastical purposes, and to constitute such district a consolidated chapelry, under the 6th section of the said Act, passed in the 59th year of the reign of His Majesty King George the Third, for the purpose of affording accommodation for attending divine service to the persons spiritual person serving such chapel to perform all ecclesiastical duties within the said district, attucked to such chapel, and for the due ecclesiastical superintendence of such district, and the preservation and improvement of the moral habits of the persons residing therein, and that such district should be named the Consolidated Chapelry of St. Mark, Hadlow Down, and that the boundaries should be as

Her Majesty, having taken the said representation, together with the plan thereunto annexed, into consideration, is pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, as it is hereby ordered, that the proposed union and consolidation be accordingly made and effected, agreeably to the provisions of the said Acts.
