The Queen has been pleased to grant unto John-Bruce Bruce (heretofore John-Bruce Knight), now calling himself John-Bruce Pryce, of Duffryn, in the parish of Aberdare, and of Duffryn, in the parish of St. Nicolas, both in the county of Glamorgan, Esq. Her royal licence and permission, that he may, from affectionate regard to the memory of his relative, Thomas Pryce, late of Duffryn, in the parish of Aberdare aforesaid, Esq. deceased, hence-

forth continue to use the surname of Pryce, in lieu of that of Bruce, and bear the arms of Pryce quarterly with those of Bruce and Knight; and also that his eldest son, John-Wyndham Bruce, now calling himself John-Wyndham Bruce-Pryce, may continue to use the surname of Pryce, in addition to and after that of Bruce, and bear the arms of Pryce quarterly with those of Bruce and Knight; and that the said surname and arms may in like manner be borne and used by the issue of the said John-Wyndham Bruce-Pryce; such arms being first duly exemplified according to the laws of arms, and recorded in the Heralds' Office, otherwise Her Majesty's said licence and permission to be void and of none effect:

And also to command, that the said royal concession and declaration be recorded in Her Majesty's College of Arms.
