Whitehall, October 10, 1837.

HE following Addresses, having been transmitted to the Right Honourable Lord John Russell, one of Her Majesty's Principal Secretaries of State, by the several persons whose names are respectively subjoined to each Address, were by him presented to Her Majesty, who was pleased to receive the same very graciously:

No. 1.

To the QUEEN's Most Excellent Majesty.

Most Gracious Sovereign,

WE, your Majesty's most loyal subjects, the Nobility, Gentry, Clergy, Freeholders, and other Inhabitants of the County of Salop, beg leave, respectfully to offer our heartfelt congratulations on your Majesty's happy Accession to the Throne of these realms, and to assure your Majesty of our sincere and devoted attachment to your Royal Person and Family.

Convinced as we are that the just rights and security of the Crown, as well as the liberties and happiness of the people, depend entirely, under Divine Providence, on the due maintenance of our excellent Constitution in Church and State, we have felt highly gratified to find these sentiments in concurrence with your Majesty's first public expressions of opinion; and we earnestly pray that your Majesty may be blessed with a long and prosperous reign, to reap the fruits of such patriotic declaration, to reflect, by your princely virtues, increased lustre on the Diadem of your Royal Predecessors, and to secure, by the wisdom of your counsels, the

continued happiness and lasting prosperity of a free, united, and mighty empire.

No. 2.

To the QUEEN's Most Excellent Majesty.

Most Gracious Sovereign,

WE, your Majesty's dutiful and loyal subjects, the Mayor, Aldermen, and Councillors of your ancient City of Rochester, in Council assembled, humbly offer to your Majesty the expression of our sincere condolence on the heavy affliction sustained by your Majesty, in common with the whole nation, by the decease of our late honoured and lamented Soverign; we, at the same time, humbly offer to your Majesty our heartfelt congratulations upon your Majesty's accession to the Throne of your Ancestors.

Desirous at all times to testify our loyalty to our Sovereign, and our veneration for the established Constitution of this country in Church and State, we feel ourselves to be now peculiarly called upon to avow our attachment to those principles which hitherto have maintained our national glory, and which cannot be subverted without the greatest danger to those Institutions, and that order of things which form that glory, and have gained for this country the envy and admiration of the civilized world.

It is our earnest prayer that your Majesty's reign may, and the subject of our unshaken confidence that it will, be marked by an uniform and fostering protection of our Institutions, ecclesiastical and civil, against the restless attacks of innovators, who would seek not merely the removal of those defects which the lapse of time and changes in the social body create in all human institutions, but the removal of

all the safeguards of our Institutions, so as to-endanger their stability in every period of popular excitement, and finally bring on their overthrow; and thus your Majesty will be the Protector and Preserver of the rights, the property, and the peace of the public and of individuals, and secure the love and veneration of the good, the loyal, and the peaceable among all classes of your people.

Praying for a continuance of your Majesty's health, we anxiously hope that you may long rule over a people sensible of the happiness they enjoy, and determined not to endanger it by joining in the clamours of factious discord, or seeking visionary

and wild schemes of improvement.

To the QUEEN's Most Excellent Majesty.

Madam, may it please your Majesty,

WE, your Majesty's most dutiful and loyal subjects, the Society of Dramatic Authors, humbly approach the Throne with the expression of our condolence on the death of our late lamented Sovereign, and of our congratulation on your Majesty's Accession to the Crown of your Ancestors. Fully aware that the only claim we can possess to your Majesty's gracious attention, is 'the circumstance of our being associated for the purpose of watching over the interests of a high art, we should have felt it most befitting our situation to abstain from any intrusion of the sentiments which we share with the entire nation, had we not remembered, that, under the benesicent sanction of His late Majesty, the only laws ever passed in this country, with the object of encouraging the drama, were enacted; and did we not conceive this to be a proper opportunity to lay at the feet of Royalty a petition on behalf of that branch of literature, the permanent welfare of which it is no less our duty than our interest to endeavour to

For this purpose, after respectfully claiming our share in the joy and exultation felt by all classes on the auspicious commencement of your Majesty's reign, we humbly crave your Majesty's patience, and your Royal pardon, for the length at which we find it necessary for distinctness' sake to present our solicitation. May we presume, in excuse rather than in importunity, most humbly to urge to your Majesty, that the drama, always among the noblest and most enduring monuments of great nations, has been, and yet is, the first, the peculiar honour of the literature of that country over which your Majesty is, as we earnestly pray, long and gloriously to reign. We humbly present to your Majesty's recollection, that no trophy of the constant triumphs of the great Elizabeth remains so untarnished and unmutilated as the dramatic poetry of which she was the benevolent patron, and which was reared to its immortality under

her sway.

We humbly represent to your Majesty, that a kindred spirit still exists capable, under the favouringcircumstance of the Royal regard, of producing kindred effects. In laying the proofs of this bold assertion at your Majesty's feet, we rely in by much the greater degree upon the works of some who, though connected with this association as honorary members, are not cognizant of our humble petition, and of one or two whom accidental circumstances only have prevented from co-operating with us; we are not therefore under the necessity of shrinking from a declaration which we feel to be

We most humbly adduce to your Majesty, as instances of this power, such plays as De Montfort and Count Basil: Rienzi, Charles the First, and the Foscari; Virginius, William Tell, Alfred the Great, the Huncl back; and the Wife; Mirandola, Fazio, the Provoit of Bruges, Damon and Pythias. These plays have been written under circumstances of discouragement. May we implore of your Majesty to foster into ripened strength the power which has produced them, and to enable such authors and their

successors to owe the full existence of their fame to | bestowing on them the cheering approval of the your Majesty.

We are most painfully aware that a considerable number of the pieces now produced upon the English stage are translations and adaptations from foreign works, little calculated to uphold the literary reputation of our own country, and in many instances not merely uncongenial with its manners, but tending to debase them. But we most humbly represent to your Majesty, that the circumstances of the English stage have forced upon many authors the less troublesome, the less hazardous, and by far the quicker task of preparing for our theatres, what had already succeeded before a foreign audience, in preference to an attempt to enrich the stores of native atchievement.

In this state of the drama, deprived of that temporary countenance which gives to the dramatic artisan the means of pursuing his work, it cannot be wondered at that he neglects the long, toilsome, and most precarious attempt to secure a permanent name, though this would be the highest object of his honest ambition, if he might enter upon the arduous attempt with a reasonable chance of existence.

We humbly solicit your Majesty's peculiar encouragement for works written in the old and severer form, as requiring longer study, more continuous vigour, and as reminding men of the ancient glories of the art and the means of recalling them. all of us in turn, the producers of more trifling dramas, are not to ask of your Majesty to withhold favour from the meritorious of this class, but, in the serious attempt to revive the drama, by invoking for it your Majesty's condescending notice, we feel that we should solicit that high and beneficial honour principally for works in every particular of the first rank.

At this time the arts of painting and sculpture are receiving from your Majesty's favour the encouragement they so entirely merit in the persons of those who exercise them. For us, all that we would permit ourselves to hope from Royal consideration, would be, the fostering patronage of our works. If we dare to suggest means of encouragement to your Majesty, it is to shew the humility of our own views, and, comparatively, how very little of your Majesty's gracious favour we should consider of in-estimable value to our cause. Your Majesty's most honouring command that any truly original play, newly produced, should be played before you whenever your Majesty's high duties or more grateful recreations might permit it, would be a peculiar and most valuable mark of favour. The slightest token of approval conveyed through any of your Majesty's officers entrusted with so gracious a command, still more the permission to dedicate such works to the Sovereign, after a fit examination of their merit, whatever might mark to the nation at large the will of it's Monarch that such efforts should be respected, would give high honour to our art in the eyes of those who now scarcely regard it, and be a means of enabling its professors to vanquish the difficulties which surround it.

Your Majesty can command the fashion of the day to be our ally, instead of our enemy, and enable those earnest in their calling to write for futurity, by

present.

May it please your Majesty,

IT is long since men of our calling have been familiar with the language as with the favour of courts; our Memorial is, we fear, deficient in many of those expressions of respectful homage with which it might have been adorned. But we yield to none of your Majesty's subjects in the deep and firm loyalty to your Majesty's Person, and devoted attachment to your Majesty's service, which we believe to be shared by the whole realm. We arrogate no pre-eminent zeal in the gratifying certainty that all vie in the cherishing such feelings. We know that your Majesty's name is written on the living tablet of every British heart. We should account it our highest honour, that, by your Majesty's gracious reception of this Address, the drama might be made one means of recording to posterity a second Elizabethan age, under the sanction of a name as memorable.

To the QUEEN's Most Excellent Majesty.

Most Gracious Sovereign,

WE, your Majesty's dutiful and loyal subjects, the Committee of the Metropolitan Society for Clothing, Boarding, and Educating the Necessitous Blind, and Embossing the Scriptures for their use, which your Majesty has kindly condescended to patronize, venture humbly to approach your Royal presence, to express the depths of sorrow we feel, which must also have filled the heart of your Majesty, on account of the death of our late revered Sovereign, your Majesty's Royal Uncle, King William the Fourth. We, therefore, entreat your Majesty graciously to receive our expressions of condolence on so important a visitation of Divine Providence, which we trust will be truly sanctified to the best interests of your Majesty's Royal Person, that your Majesty may, upon reflection, remember, that the lives of Kings, Queens, and Subjects, are alike in the hands of the Creator of all mankind, "who doth as he please in the armies of Heaven, and also among the inhabitants that cover the earth.

We also entreat, most earnestly, that your Majesty. will be pleased to receive and accept our hearty congratulations on your Majesty's Accession to the seat" of your Forefathers, the British Throne; which we haif as a predication of unspeakable benefit and blessing to this kingdom at large, and especially to the most important designs of our Society, wherein we are endeavouring to carry out the desires of our once illustrious Sovereign, your Majesty's deceased Grandfather, King George the Third, namely, that "every poor child in these dominions may be able to For while he was not permitted to. read the B.ble." see those desires fully accomplished, your Majesty is now blessed to know, that the last long neglected portion of your Majesty's subjects, even the necessitous Blind, are thus to be provided for, upon principles which we firmly believe will be grateful to the feelings of your Majesty, they being the same upon. which your Royal Father urged the establishment of

the British Schools, and also countenanced the British and Foreign Bible Societies, both by his personal attendance and pecuniary aid, in order to promote the free circulation of the Sacred Scriptures throughout the empire; and while he displayed such philanthropic feelings on this account, we congratulate your Majesty upon the recollection of having now the satisfaction to see the matter carried still further than your Majesty's Royal Father, namely, by countenancing and supporting the embossing of those same Scriptures, to enable the Blind to read by feeling, which your Majesty's Royal Father, and Grandfather, were so anxious to disseminate to all, that they might read by seeing, and thus become acquainted with the word of eternal life.

We, therefore, most gracious Sovereign, adore the wisdom of that Divine Providence, which has so ordered the events and occurrences of the times, as to place your Majesty upon that Throne, which is the glory of the universe; upon which may it be your Majesty's high honour long to sit and sway the British sceptre, to the comfort and prosperity of the Protestant Church, the extension of religious liberty, and the promulgation of the pure word of God, which by the power of the Holy Spirit, is able to make us wise to eternal salvation.

Furthermore, we, as an associated portion of your Majesty's loyal and dutiful subjects, unitedly present our supplications at the Throne of the Heavenly Grace, unto Him who is the King of Kings, and Lord of Lords, by whom Kings and Queens reign, and Princes decree justice, that He may be pleased, in His sovereign good pleasure, to give unto your Majesty wisdom to direct in all the arduous duties of the state, and in every concern to which your Majesty's attention may be called; that your Majesty's invaluable life and health may be long continued to reign over a dutiful, loyal, and affectionate people; and that your Majesty may be so strengthened by the influence of the Holy Spirit of truth, that it may be your Majesty's constant happiness to enjoy the best of blessings under an earthly crown; and finally, when this life shall cease, receive the approbation of the Judge of all the earth; an inheritance with the Saints in glory; and an immortal Crown, which God the righteous Judge shall bestow on all who believe in Jesus, which shall not fade away, world without end, Amen.

To the QUEEN's Most Excellent Majesty.

Most Gracious Sovereign,

WE, your Majesty's most loyal and dutiful subjects, the Archbishop and Clergy of the diocese of Armagh, humbly beg permission to lay at the feet of your Majesty our heartfelt congratulations on your Majesty's Accession to the Throne of your Ancestors, and to tender the earnest assurances of our firm allegiance to your Majesty's Person and Government.

We should, however, be ill-deserving of your Majesty's favourable regard, and we should but little enter into the feelings of your heart, were we not also, on this occasion, to offer our sincere con-

dolence on the deep affliction which your Majesty has sustained, in common with ourselves, in the demise of your revered Uncle, our late most gracious Sovereign.

Bereaved of the blessings of his paternal rule, we unreservedly transfer to your Majesty, his lawful and hereditary successor, that prompt and willing obedience which we paid to your lamented predecessor, and that devoted attachment which the Ministers of the Established Church have ever cherished to the

persons of their Sovereigns.

The bright promise of your Majesty's youth, adorned with the highest intellectual excellence, and with every noble and ingenuous sentiment; your Majesty's conscientious and deliberate profession of the pure principles of that faith, in which you have been educated by the pious care of Her Royal Highness, your illustrious Mother; the practice of every duty proper to your earlier years, by which you have been distinguished; the dignified demeanour and appropriate expression, bespeaking an exalted mind, which so strongly marked your Majesty's entrance on your high office;—all these we hail as the auspicious presages of a glorious and happy reign.

In thus expressing our entire confidence in your Majesty's jealous protection of the established Church, assailed as it is by numerous and powerful adversaries, far be it from us to suggest, that your Majesty bears the sceptre of this empire for the support of that Church alone, and not for the vindication of those sacred rights of conscience, which we are among the foremost to claim for those who

dissent from her faith and discipline.

We may not further intrude upon your Majesty; than by imploring you to believe, that both in our public and private devotions, we shall never cease to offer up our unfeigned prayers to the Giver of all Good, that He will be pleased, amidst those difficulties and dangers with which the Thrones of Princes are surrounded, to direct your counsels by the suggestions of His Holy Spirit, and to guard your sacred person by the constant care of His overruling providence. May He grant that your Majesty's solicitude for the public good, may be requited by: the gratitude and attachment of a wise and understanding people; the highest temporal reward of a patriotic Sovereign; and that when you shall bet

freed from the care of an earthly kingdom, you may be translated to a crown of heavenly glory.

To the QUEEN's Most Excellent Majesty.
