To the QUEEN's Most Excellent Majesty.

WE, your Majesty's most loyal and dutiful subjects, the Mayor, Community, and Citizens of Londonderry, in Common Council assembled, humbly ask permission to lay before your Majesty, our dutiful and heartfelt congratulations on the auspicious event of your Majesty's Ascending the Throne of your Royal Ancestors.

The sixth in descent of an illustrious race of Monarchs, who were called to the Government of this mighty empire to be the guardians of our glorious constitution, we feel already confident, from your. Majesty's own gracious assurance, that, under your Royal countenance and protection, the reformed religion, in defence of which our forefathers maintained an arduous and successful struggle, will be preserved inviolate; and all classes of your Majesty's subjects secured in the enjoyment of the blessings of civil and religious liberty.

And we humbly trust, and fervently pray, that in the devoted attachment and willing obedience of all your Majesty's subjects, and which, on behalf of this ancient and loyal city, we most heartily tender, your Majesty may enjoy a long and prosperous reign, happy in making your exalted station the means of advancing the honour and glory of Almighty God, and the welfare and happiness of the British empire and all its inhabitants.

To the QUEEN's Most Excellent Majesty.

Most Gracious Sovereign,

WE, your Majesty's dutiful and loyal subjects, the Inhabitant Householders of the town and parish of Woolwich, in the county of Kent, in Vestry assembled, approach your Majesty with the most profound sentiments of fidelity and attachment.

The demise of His late Majesty, your Royal

The demise of His late Majesty, your Royal Uncle, excited in our minds, in common with our fellow subjects throughout this great empire, sentiments of the deepest regret. But that regret is softened by the reflection, that, during his short and glorious reign, His Majesty's energies were directed to, and exerted for, the welfare and happiness of his subjects, especially by placing their liberties on a firmer and more permanent basis, which has endeared his memory in the affectionate recollections of a grateful people.

We rejoice in, and humbly thank your Majesty for, the noble and endearing sentiments expressed in your Majesty's first address to your Privy Council: "that it will be your unceasing study to maintain the Reformed Religion as by law established, and to secure, at the same time, to all the full enjoyment of

religious liberty."

We, your Majesty's faithful subjects, have the strongest attachment for the British Constitution, and are fully sensible that it is calculated to promote the best interests of all classes of your Majesty's subjects; and we cherish the earnest hope, that it will be your Majesty's care and study, under the protecting hand of Divine Providence, to uphold, support, and maintain the same; and should any part of it, through lapse of time, become defective, or require modification, we have the greatest confidence that your Majesty will (to use the language of a late eminent statesman) "repair it where decayed, amend it where defective, prop it where it needs support, so as to adapt it to the purposes of the times in which we live," as our ancestors have done from time to time; that we may thus transmit it to posterity, not only unimpaired, but amended and improved.

That your Majesty's reign may be of long duration, that it may be signalized by its patriotic spirit, pacific principles, and beneficial reforms, is the devout wish, and fervent aspiration, of your Majesty's affectionate, dutiful, and loyal subjects, the Inhabitant Householders of the town and parish of

To the QUEEN's Most Excellent Majesty.

The dutiful and loyal Address of the Synod of Aberdeen.

WE, the Ministers and Elders of the Provincial Synod of Aberdeen, desire, on this the first occasion of our assembling together since your Accession to the Throne of your Fathers, respectfully to approach your Royal Person, to lay at the foot of the Throne the expressions of our warm attachment to

your Majesty's Person and Government.

Participating, as we did, in that unaffected sorrow which came on the people of these lands, by the demise of our late beloved Monarch, King William, we yet hail it as a signal proof of the continued farour of Almighty God, that in His providence He has called to fill the Throne the descendant of a race of Monarchs, under whose beneficent and enlightened sway Great Britain and Ireland have risen to a glorious pre-eminence among the nations of the world. In your Majesty's early and gracious declaration, of your unalterable resolution to maintain the Church of Scotland, as by law established, in all her rights and privileges, we gratefully recognise the earnest of that firm attachment to the Protestant faith, by which the Sovereigns of the illustrious House of Brunswick have been uniformly distinguished, and through which we humbly, but firmly, believe a blessing from the King of Kings has rested on their government.

As office-bearers of the Church of Scotland, we shall earnestly seek to advance the interests of pure and undefiled religion; that your Majesty's Throne may be upheld in righteousness; and we shall hold it our happiness and duty to foster, in the hearts of our people, attachment to our mixed form of Monarchical government, by King, Lords, and Commons, under which a greater share of individual and national prosperity and liberty has been enjoyed by all ranks, than was ever vouchsafed to any other

kingdom.

And our prayers, honoured Sovereign, shall ascend before the Throne of Grace, day by day, continually, that the God and Father of our Lord and Saviour Jesus Christ may enrich you with a wise and understanding heart; that He may, by His Holy Spirit, grant you the rich consolations of those who are His honoured ministers for good, and that after a long, a glorious, and happy reign on earth, He may adorn you with an imperishable, and unfading Crown, in His everlasting kingdom.
