Most Gracious Sovereign,

WE, your Majesty's most dutiful and loyal subjects, the Bishop and Clergy of the Diocese of Durham, beg leave to offer to your Majesty our sincere condolence on the death of our late revered. Sovereign, and at the same time to lay before you. our humble congratulations on your Accession to the

We have lost, in your late august Uncle, a King whose paternal reign was marked by an endeavour, continued to its close, to improve and support our institutions at home, to maintain peace abroad, to promote justice and charity in their most comprehensive forms, and especially to uphold the interests of our national faith.

His memory lies in the gratitude of his subjects, but they turn with equal confidence from the recollection of the past to the hope of the future.

It will be our constant prayer that the Supreme Disposer of events may shed His influence over you, and be the guide and support of your reign.

WE, the undersigned Roman Catholic Archbishop. and Clergy of the Diocess of Tuam, beg leave to approach your Majesty, with the sincere assurance of our congratulation on your Majesty's auspicious Accession to the Throne of these realms, as well as of our dutiful devotion to your Majesty's august Person. Among the millions who own the sway of your Majesty's sceptre, allow us to assure you, there are none who hailed with sincerer joy than we have, your peaceful possession of your hereditary Throne, or who shall be ever more ready than we, in the manifestation of that conscientious allegiance, which is due to your supreme authority.

To Her Most Gracious Majesty QUEEN VICTORIA.

May it please your Majesty,

YOUR Majesty having been pleased to issue a Royal Proclamation, bearing the date of the 21st day of June 1837, to the intent that the honour and service of Almighty God be preserved and advanced, and that all vice, profaneness, debauchery, and im-

morality be discouraged and suppressed.

Your Majesty's loyal and dutiful subjects, the friends of morality, purity, piety, and virtue, who have organized themselves into associated bodies, for the express purpose of eradicating vice and licentiousness, do herewith, by signature of their respective secretaries, or other officers, make bold to attempt an expression of their most humble and hearty thanks to your Majesty, for so nobly and worthily asserting your visible displeasure, by Royal Proclamation, against the vices and practices therein enumerated and named; and do hereby signify their most hearty concurrence with your Majesty's authority in the punishment and reformation of evil-doers; and do also fervently offer their most zealous and strenuous services to prevent every exhibition of shameful, intemperate, and disorderly habits, within the limits of these realiss. And your Majesty's

servants further express their deep sense of the benefits likely to result from the due reading of the said Proclamation (as therein commanded) four times in every year, by the minister of every church or chapel; and especially from such ministers' inciting and stirring up their respective auditories to the practice of piety and virtue, and the avoiding of immorality and profaneness.

And your Majesty's loyal and dutiful subjects present their earnest wish and prayer to Almighty God (by whom Kings and Queens reign), that He would so direct, guide, and govern the heart and mind of your Majesty, that peace and happiness, truth and justice, religion and piety, may be established among

us for all generations.

That God, in his infinite goodness and mercy, may so give your Majesty favour, through the merits of His Son our Lord and Saviour Jesus Christ, as to bless the reign of your Majesty to the temporal and eternal happiness of yourself and of your people, eventually exchanging your temporal for a more glorious and eternal crown, is the humble, but heartfelt prayer of your Majesty's most devoted servants and subjects.
