To the QUEEN's Most Excellent Majesty.

Most Gracious Sovereign,

WE, your Majesty's loyal and dutiful subjects, the Mayor and Council of the City and Borough of Carlisle, desire most respectively to tender the expression of our heartfelt congratulations on your Majesty's Accession to the constitutional Throne of your Ancestors, and our unshaken fidelity and attachment to your Royal House.

Birmingham, Bristol, and Thames Junction Railway. [
