It is with peculiar delight and satisfaction that we nt present address your Majesty, when we contemplate the unprecedented burst of genuine loyalty which the happy occasion of your Majesty's Coronation drew forth from all classes of your Majesty's subjects, and of the testimony they thereby bore to the high sense they entertain of their Sovereign's exalted virtues. We regard this demonstration as indeed an auspicious omen. And as we have every confidence that it will be your Majesty's highest ambition to maintain the unrivalled character of our glorious constitution, as well as the just liberties of your Majesty's people, we doubt not that you will long live in the hearts, and enjoy the best wishes of the whole community. The peace and tranquillity that every where at present prevail throughout your Majesty's dominions, and the good understanding that subsists between your Majesty's empire and foreign states-coupled with the growing attachment to your Majesty's Person, hold out to your Majesty well founded prospects of a happy reign. That these prospects may be realised to their fullest extent, and that your Majesty's reign may, under the Divine blessing, be indeed long, prosperous, and happy, is the sincere desire, and ardent prayer, of those of your Majesty's faithful and devoted subjects who now humbly address your Majesty.
