WHEREAS His late Majesty King William the Fourth, by letters patent, dated the 8th day of October 1836, granted unto John Sharp, of the borough of Dundee, in North Britain, flax-spinner, the sole use and exercise of his invention of certain machinery for converting ropes into tow, and certain improvements in certain machinery for preparing hemp or flax for spinning; part of which improvements are also applicable to the preparing of cotton, wool, and silk for spinning; notice is hereby given, that the said John Sharp has presented a petition to Her Majesty's Solicitor General, for his permission that he, the said John Sharp, may be at liberty to enter and enrol certain alterations and modifications in the description of certain parts of his said invention, as described in the specification enrolled in pursuance of the said letters patent and in the drawings referred to thereby, for the purpose of more fully explaining the same and to render the subject matter thereof more easy to be understood and put into practice; and which said parts are stated in the said specification to relate to the several objects following, that is to say; firstly, the combination of certain parts of machinery for converting ropes into tow, described under the first head of my said specification; secondly, certain improvements in heckling machinery, described under the fifth head of my said specification; and thirdly, a method of untwisting ropes of hemp or flax, so as to separate them into strands and afterwards into the original yarns, described under the ninth head of my said specification.—Dated the 23d day of August 1838.
