# PRESENT,

The QUEEN's Most Excellent Majesty in Council.

HEREAS by an Act, passed in the last session of Parliament, intituled "An Act to abridge the " bolding of benefices in plurality, and to make " better provision for the residence of the clergy, it was, amongst other things, enacted, that when any spiritual person should be desirous of obtaining a licence or dispensation for holding together any two benefices, such spiritual person should, previously to applying for the grant of such licence or dispensation, deliver to the bishop of the diocese, where both benefices are situate in the same diocese, or to the bishops of the two dioceses where such benefices are situate in different dioceses, a statement in writing, according to a form or forms to be promulgated from time to time by the Archbishop of Canterbury, and approved by the Queen in Council, in which statement such spiritual person should set forth the several matters and things in the said Act in that behalf mentioned:

And whereas at this present Council, the Archbishop of Canterbury has laid before Her Majesty a form of statement to be promulgated by him, pursuant to the said Act, in case the said form should be approved by Her Majesty in Council; and such form or statement is in the words and figures following, that is to say:
