CONTRACTS FOR SUGAR, RAISINS, BISCUIT BAGS, CANVAS, WILLOW RODS, AND COOPERS' FLAGS.

THE Commissioners for executing the office of Lord High Admiral of the United Kingdom of Great Britain and Ireland do hereby give notice, that on Thursday the 3d January next, at one o'clock, they will be ready to treat with such persons as may be willing to contract for supplying and delivering into Her Majesty's Victualling Stores at Deptford, the under-mentioned articles, viz.

Sugar, the produce of the British possessions, 80 tons; half to be delivered in three weeks, and the remainder in three weeks afterwards.

Raisins, new black Smyrna, 60 tons; half to be delivered in three weeks, and the remainder in three weeks afterwards.

Biscuit Bags, large, 70,000 No.; one third to be delivered by the 30th April, one third by the 30th June, and the remainder by the 31st August next.

Biscuit Bags, small, 10,000 No.; to be delivered by the 30th April next.

Canvas for Pudding Bags, 2000 ells; to be delivered within two months.

Willow Rods for Coopers' Twigs, 600 mille; to be delivered by the 31st of March next, in equal monthly proportions.

Coopers' Flags, 500 Bolts; to be delivered within six weeks, in equal weekly proportions.

The Sugar and Raisins to be exempted from the Customs' duties.

Samples of the sugar intended to be supplied, of the raisins (not less than three pounds), and of the rods (not less than 500 great tale) must be produced by the parties tendering; and samples of the biscuit bags and canvas, and also of the descriptions of sugar admissible, together with the conditions of the contracts, may be seen at the said Office.
