

Hague, October 31. The States of *Holland* and *Frisland* will re-assemble the 8th of the next Month, And its said one of the main points they are to deliberate upon, is about making a farther reform in their Troops, and particularly in the Cavalry. The *Herr Van Euxen* Ambassador Extraordinary from this State in *Sueden* has leave to return home; Our last Letters from *Stockholm*, wh chare of the 11th Instant told us, He had had several conferences with the Chancellor and other principal Ministers of that Court, in order to the renewing the def'nity alliance between the King of *Sueden* and this State, which is now going to expire. Prince *Casimir* of *Nassau* Stadtholder of *Friseland* and *Groningen* is still at *Amsterdam*, where he is treated with great respect; and the Magistrates of that City have made him a present of a Balin and a pair of large Candlesticks of Gold. We have Letters from *Vienna* of the 19th Instant which give an account that the Assault which our last told us was intended to be made upon *Buda*, the 15th of this Month was put off till the 24th. That the *Seraskier* Bassa, after all that has been said of his having pass'd the Bridge of *Essecke* lay within 4 Hungarian Miles of *Buda* having lately as they say, received a reinforcement of 6000 Men from *Bosnia*. That the Margrave of *Baden* was gone from *Vienna* to the Army to command there as *Veldt-Marschal-General*; And that the Duke of *Wirtemberg* was arrived at *Vienna*, and expected his Regiment there in a day or two in its march for *Hungary*; These Letters add that the Elector of *Bavaria* had sent Orders for the rest of his forces to come and join him before *Buda* being resolved not to stir from thence till he hath reduced the place. They write from *Cracow*, that the King of *Poland* had pass'd the *Niesler* with his whole Army, with a resolution to enter into *Moldavia* and *Valachia*, but that he had been oblig'd upon the advice he receiv'd that 30000 Tartars were fallen into *Podolia* to ravage that County, to return to secure his own Dominions.

Paris, November 1. The Court continues at *Fontainebleau*, from whence it's believed they will now quickly remove to *St. Germain*. On Thursday last 15 Men were Disbanded in each Company of the Regiment of Guards, which it's believed is done to make room for a great many young Gentlemen that desire to serve in the said Regiment. From *Thoulon* we have advice, that the Magazine about two miles from that place, where is always kept a very great quantity of Powder, had accidentally taken fire, and gave so terrible a blow that it made a kind of an Earthquake in the Neighborhood, and broke all the Glass Windows at *Thoulon*.

Deale, October 25. It blew very hard yesterday, and several Ships broke from their Anchors, two whereof its feared are lost upon the *Goodwin*.

Deale, October 28. Yesterday about 4 in the Afternoon there arose a most violent Storm the Wind at E. S. E. which continued till Midnight; several Ships were forced from their Anchors, some whereof are since returned into the *Downes*, two Ships were driven a shore where they were both Staved to pieces; the one an English Ship of about 80 Tun Laden with Tarr and Copper, and the other a French Vessel of 30 Tuns.

Whitehall, October 26. His Majesty has been

pleas'd to Confer the Honor of Knighthood upon Doctor *Thomas Weikerley*, one of His Majesty's Physicians in Ordinary, and Preident of the Colledge of Physicians.

Whitehall, October 29. His Majesty has been pleas'd, upon the Death of Mr. Justice *Wyndham*, to remove Mr. Baron *Streete* to the Common-Pleas, and to Constitute in his place Sir *Robert Wright*; His Majesty's Serjant at Law, one of the Barons of the *Exchequer*.

London October 29. This day Sir *James Smith*, Commissionated by His Majesty to be Lord Mayor of this City for the Year ensuing, was Sworn before the Barons of the *Exchequer* at *Westminster*, whither he went by Water accompanied by the late Lord Mayor, the Recorder, Aldermen and Sheriffs, and attended by the several Companies in their respective Barges adorned in the usual manner; Their Majesties, his Royal Highness, and Prince *George*, doing them the Honor to be upon the Leads at *Whitehall* when they pass'd by, My Lord Mayor being come back from *Westminster*, was received at his landing at *Black-Friers* by the Artillery Company, and from thence his Lordship, pass'd with the accustomed Solemnity to *Grocers-Hall*, where a very Splendid Dinner was provided, at which were the Lords of His Majesty's most Honorable Privy-Council, with many others of the Nobility, the Judges, and other Persons of Quality.
