NOTICE TO MARINERS.

LEMAN AND OWER LIGHT VESSEL.

Trinity-House, London, February 20, 1840.

ARINERS making this light vessel during the day time are to observe, that, in order to render her readily distinguishable from all other light vessels in the North Sea, a ball is constantly hoisted upon the mizen mast, in addition to that upon the fore mast.

The Corporation deem it also proper, upon this occasion, to renew the caution contained in the notice issued under date the 26th November last, viz.

"That the light at the Leman and Ower is to be used only as a warning light, to indicate the position of those dangerous shoals; and that the vessel must not be approached either by night or by day."

And, as a further precaution for preventing accidents, in cases in which vessels may be observed standing into danger, a gun will be fired on board the light vessel, upon which signal such measures should be immediately taken by the persons in charge, as they shall deem best calculated to avoid the danger.
