The Queen has been pleased to grant unto Thomas-Dove Jones, of Stamford, in the county of Lincoln, and of Emanuel College, in the university of Cambridge, Gent. eldest son of Thomas Jones and of Elizabeth his wife, the only child of Thomas Dove, late of West Deeping, in the said county of Lincoln, Gent. deceased, by Sarah his wife (formerly Sarah Haynes), also deceased, Her Majesty's royal licence and authority, that, in compliance with a proviso contained in a certain deed of settlement, bearing date the 20th day of September 1826, he, the said Thomas-Dove Jones, may discontinue the surname of Jones, and that he and his issue may henceforth use the surname of Dove:

And also to command, that the said royal concession and declaration be registered in Her Majesty's College of Arms.
