A PROCLAMATION.

#### VICTORIA, R.

HEREAS We have thought fit to order, that certain pieces of copper money should be coined, which should be called "half farthings," every such piece having for the obverse impression Our effigy, with the inscription, " Victoria D.G. " Britanniar. Regina F.D.," and for the reverse the words "half farthing," with the date of the year, surmounted by the royal crown, and below the united emblem of the rose, thistle, and shamrock: and whereas pieces of the copper money of the description aforesaid have been coined at Our Mint, and will be coined there: We have therefore, with the advice of Our Privy Council, thought fit to issue this Proclamation; and We do hereby declare, ordain, and command, that all pieces of copper money, so coined and to be coined as aforesaid, shall be current and lawful money of the kingdom of Great Britain and Ireland, and shall pass and be received as current and lawful money of the said kingdom, every such half farthing piece as of the value of half a farthing of like lawful money: provided that no person shall be obliged to take more of such pieces in any one payment than shall be of the value of six pence.

#### A PROCLAMATION.

#### VICTORIA, R.

HEREAS it has been represented unto Us that great quantities of the gold coin of this realm deficient in weight are now in circulation, contrary to the tenor of two Proclamations issued, one by His late Royal Highness George Prince Regent, in the name and on the behalf of His late Majesty King George the Third, bearing date the first of July one thousand eight hundred and seventeen, and the other issued by His late Majesty King George the Fourth, bearing date the sixth of February one thousand eight hundred and twenty-one; and there being reason to believe that due attention is not paid to the weighing of the said gold coin, and the directions given in the Acts of Parliament now in force with respect to the cutting, breaking, or defacing such pieces thereof as are found to be of less weight than those declared by the last of the aforesaid Proclamations to be current, and to pass and be received in payment; We do by this Our Royal Proclamation declare and command that from and after the date hereof every gold so-

vereign of less weight than five penny-weights two grains and a half, and every gold half sovereign of less weight than two penny-weights thirteen grains and one eighth, be not allowed to be current or pass in any payment whatsoever: and We do hereby strictly require and command all Our loving subjects, and particularly all the officers, collectors, and receivers of Our revenues, strictly to conform to the orders hereby given, and to the directions and regulations enacted and established in the several Acts of Parliament now in force with respect to the cutting, breaking, and defacing such pieces of the said gold coin as shall be found deficient in weight: and We do hereby further ordain, declare, and command, that the said gold sovereigns and half sovereigns of the weights last above described shall pass and be received as current and lawful money of the United Kingdom of Great Britain and Ireland, every such sovereign as of the value of twenty shillings, and every such half sovereign as of the value of ten shillings, in all payments whatsoever.

THEREAS Her Majesty doth deem it expedient to appoint the ports of Toronto, in the province of Canada, and also the port of Hamilton, in the said province, situate at or near the western extremity of Lake Ontario, to be free ware, housing ports for the purposes of an Act, passed in the session of Parliament held in the third and fourth years of His late Majesty King William the Fourth, intituled " An Act to regulate the trade of the British " possessions abroad:"

Now, therefore, in pursuance and exercise of the

Act in that behalf vested, Her Majesty, by and with the advice of Her Privy Council, doth order, and it is hereby ordered, that the ports of Toronto and Hamilton shall, from and after the first day of August one thousand eight hundred and forty-two, be free warehousing ports for the purposes of the said Act:

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury, and the Right Honourable Lord Stanley, one of Her Majesty's Principal Secretaries of State, are to give the necessary directions herein as to them may respectively appertain.

HEREAS an Ordinance, passed by the Governor and Council of Ceylon, on the first day of September 1841, intituled "An Ordinance " enacted by the Governor of Ceylon, with the ad-" vice and consent of the Legislative Council there-" of, for prohibiting the importation of rum and " rum shrub, the produce of certain places," has this day been laid before Her Majesty in Council, and Her Majesty, with the advice of Her Privy Council, hath been pleased to declare, and doth hereby declare, that the same is satisfactory proof; that rum and rum shrub, the produce of any foreign country, or of any British possession into which foreign sugar or rum can be legally imported, has been prohibited to be imported into the island of Ceylon:

Now, therefore, Her Majesty, by and with the advice and consent of Her Privy Council, and in parsuance of the power and authority in this behalf vested in Her by an Act of Parliament, passed in the session of Parliament held in the fourth and fifth years of Her Majesty's reign, intituled "An Act to " reduce the duty on rum and rum shrub, the pro-" duce of, and imported from, certain British pos-" sessions in the East Indies into the United King-" dom," doth hereby order, and it is hereby ordered accordingly, that, from and after the date of this Order, so long as the prohibition established by the powers and authorities in Her Majesty by the said | hereinbefore recited Ordinance shall continue in

force, rum and rum shrub, the produce of the island of Ceylon shall, on importation into the United Kingdom, be admitted to entry at the duties by the said Act of Parliament imposed and set forth in the schedule hereunto annexed, instead of the duties to which rum and rum shrub, the produce of the said island of Ceylon, would now be liable on the importation thereof into the United Kingdom, subject, nevertheless, to the provisions in the said Act contained with regard to the certificates and declaration thereby required:

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury, and the Right Honourable Lord Stanley, one of Her Majesty's principal Secretaries of State, are to give the necessary directions herein, as to them may respectively appertain. Wm. L. Bathurst.

#### SCHEDULE.

For every gallon of rum, of any strength, not exceeding the strength of proof by Sike's hydrometer, and so in proportion for any greater or less strength than the strength of proof, and for every greater or less quantity than a gallon, being the produce of the said island of Ceylon, not being sweetened or mixed with any article so that the degree of strength thereof cannot be exactly ascertained by such hydrometer, nine shillings and four pence.

For every gallon of rum shrub, however sweetened, the produce of, and imported from, the said island of Ceylon, and so in proportion forany greater or less quantity than a gallon, nine shillings and four pence.

HEREAS under or by virtue of an Act of Parliament, passed in the sixth year of the reign of His late Majesty King George the Fourth, intituled "An Act to regulate the trade of the "British possessions abroad," containing the like recitals and conferring the like powers as are hereinafter mentioned to be contained and conferred by the Act hereinafter recited, and under or by virtue of an Order in Council, bearing date the sixteenth day of December one thousand eight hundred and

twenty-six, issued in pursuance of the first hereinbefore mentioned Act, His said late Majesty King George the Fourth, by and with the advice of His Privy Council, did declare and grant that it should be lawful for French ships to import into the island of the Mauritius from the dominions of His Most Christian Majesty, such goods being the produce of those dominions, as in the Order now in recital are referred to:

And whereas by a certain Act of Parliament, passed in the session of Parliament held in the third and fourth years of the reign of His late Majesty King William the Fourth, intituled " An " Act to regulate the trade of the British posses-" sions abroad," after reciting, that " by the law " of navigation, foreign ships are permitted to " import into any of the British possessions abroad " from the countries to which they belong, goods, " the produce of those countries, and to export " goods from such possessions to be carried to any " foreign country whatever ; and that it is expedient " that such permission should be subject to certain " conditions;" it is enacted, that the privileges thereby granted to foreign ships shall be limited to the ships of those countries which, having colonial possessions, shall grant the like privileges of trading with those possessions to British ships ; unless His Majesty by His Order in Council shall in any case deem it expedient to grant the whole or any of such privileges to the ships of any foreign country, although the conditions aforesaid shall not, in all respects, be fulfilled hy such foreign country :

"And whereas Her Majesty has deemed it expedient that ice, the produce or manufacture of the island of Bourbon, should be added to the list of goods which may be lawfully imported into the Mauritius in French ships :

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, and, in pursuance and exercise of the powers and authorities in Her vested by the said lastly hereinbefore recited Act, doth hereby declare and grant, that it shall be lawful for French ships to import into the said island of Mauritius, from the said island of Bourbon, ice, being the produce or manufacture of the said island of Bourbon:

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury, and the Right Honourable Lord Stanley, one of Her Majesty's Principal Secretaries of State, are to [ give the necessary directions herein as to them may respectively appertain.

THEREAS by an Act, passed in the seventh year of the reign of His late Majesty King William the Fourth, intituled " An Act for " rendering more easy the taking the poll at " county elections," it is enacted, that it shall be lawful for His Majesty, by and with the advice of His Privy Council, from time to time, on petition from the justices of any county, riding, parts, or division in England or Wales, in quarter sessions assembled, representing, that the number of polling places for such county, riding, parts, or division is insufficient, and praying, that the place or places mentioned in the said petition may be a polling place or polling places for the county, riding, parts, or division of the county within which such place or places is or are situate, to declare that any place or places mentioned in the said petition shall be a polling place or polling places for that county, riding, parts, or division; and that the justices of the peace for such county, riding, parts, or division, in quarter sessions or some special sessions assembled, as mentioned in the Act, passed in the third year of the reign of His said late Majesty, intituled "An " Act to settle and determine the divisions of counties, " and the limits of cities and boroughs, in England " and Wales, in so far as respects the election of "Members to serve in Parliament," shall, conformably to the said last-mentioned Act, divide such county, riding, parts, or division into convenient polling districts, and assign one of such districts to each polling place :

And whereas the justices of the peace for the county of Cornwall, at a general quarter session of the peace holden at Bodmin, in and for the said county, on the fifth day of April in the year of our Lord one thousand eight hundred and forty-two, have presented their petition to Her Majesty, representing that the number of polling places for the eastern division of the said county is insufficient, and therefore praying that pension of canonries in the said cathedral church.

the borough of Lostwithiel, within the said division, may be appointed a polling place for the said division :

Now, therefore, Her Majestv, having taken the said petition into consideration, doth, pursuant to the said Act of the seventh year of His late Majesty's reign, by and with the advice of Her Privy Council, declare, order, and direct, that the said place mentioned in the said petition, namely, the borough of Lostwithiel, shall be a polling place for the eastern division of the said county of Cornwall; and further, that the justices of the peace for the said county of Cornwall, assembled at the general quarter sessions or some special sessions, as mentioned in the said Act of the third year of His late Majesty's reign, shall, conformably to the said last-mentioned Act, divide the said eastern division of the said county of Cornwall into convenient polling districts, and assign one of such districts to each polling place.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of Her Majesty's reign intituled " An " Act to carry into effect, with certain modifications, " the fourth report of the Commissioners of Eccle-" siastical Duties and Revenues," duly prepared and laid before Her Majesty in Council a scheme, bearing date the third day of May one thousand eight hundred and forty-two, in the words and figures following, that is to say :

" We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of your Majesty's reign, intituled "An Act to carry " into effect, with certain modifications, the fourth " report of the Commissioners of Ecclesiastical " Duties and Revenues," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for relieving the present canons of the cathedral church of Winchester from the performance of additional duty, by reason of the sus"Whereas, it was by the said Act enacted, that out of the proceeds of the suspended canonries in any chapter, provision might from time to time be made, by the authority therein provided, for relieving the then existing canons of such chapter from the performance of any additional duty by reason of such suspension, by the employment of substitutes, to be approved by the respective bishops:

"And whereas, application has been made to us by the Dean and Chapter of the cathedral church of Winchester, to make provision for a substitute or substitutes, to be employed and approved according to the said Act, to perform the duties which, by reason of the present suspension of one canonry, and of the future suspension of six other canonries, in the said church, would otherwise be imposed on the remaining canons:

"We, therefore, humbly recommend and propose, that the said Dean and Chapter be empowered, from time to time, to appoint a substitute or substitutes, to be approved by the Bishop of Winchester for the time being, to perform the duties of a Canon in residence, for such calendar month or months in this present and each succeeding year, as shall remain unprovided for, after the periods of statutable and customary residence by all the existing canons shall have been fixed.

"And we further recommend and propose, that until the said Chapter shall consist exclusively of Canons to be appointed after the passing of the said recited Act, it shall be lawful for the Treasurer or other officer for the time being of the said Dean and Chapter, to retain, out of the monies payable to us as such proceeds as aforesaid, in each year, the sum of fifty pounds for every calendar month to be so provided for as aforesaid, and to pay the same to the person or persons so appointed and approved, in such proportions if more than one person as shall be equal to the period of residence and duty by each of them actually kept and performed.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing other measures relating to the said cathedral church of Winchester, in conformity with the provisions of the said Act."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said

Council, is pleased hereby to ratify the said scheme, and to order and direct, that the same shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Winchester.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of Her Majesty's reign, intituled "An "Act to carry into effect, with certain modifications, "the fourth report of the Commissioners of Eccle-"siastical Duties and Revenues," duly prepared and laid before Her Majesty in Council a scheme, bearing date the seventh day of June, in the year one thousand eight hundred and forty-two, in the words and figures following, that is to say :

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the third and fourth years of your Majesty's reign, initialed "An Act "to carry into effect, with certain modifications, the "fourth report of the Commissioners of Ecclesias-"tical Duties and Revenues," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for fixing the number and emoluments of the Minor Canons in the Cathedral Church of Gloucester.

"Whereas it is by the said recited Act enacted, that, so soon as conveniently may be, and by the authority therein provided, regulations shall be made for fixing the number and emoluments of the Minor Canons in each Cathedral and Collegiate Church, provided that there shall not in any case be more than six nor less than two, and that the stipend of each such Minor Canon hereafter to be appointed shall not be less than one hundred and fifty pounds per annum; and that arrangements may from time to time be made, by the like authority, for securing to any Minor Canon, not otherwise competently

provided for, such annual sum as shall make up to him an income, as Minor Canon, not exceeding in any case the said sum of one hundred and fifty pounds :

" And whereas application has been made to us by the Dean and Chapter of the Cathedral Church of Gloucester, to fix the number and emoluments of the Minor Canons in the said Church as hereinafter mentioned :

" And whereas it has been represented to us, by the said Dean and Chapter, that the number of Minor Canons in the said Church has hitherto been four, but is now reduced to three, and that it is expedient that there should continue to be three Minor Canons only therein; and it has been further represented to us by the said Dean and Chapter that they have assigned to the junior of the present Minor Canons, who has been appointed since the passing of the said recited Act, a fixed annual stipend, as such Minor Canon, of one hundred and fifty pounds, and that the senior of such Minor Canons, although receiving a smaller stipend as Minor Canon, is otherwise competently provided for; but that the Reverend Edward Vaughan, who is the second of the present Minor Canons, receives an annual stipend of ninety pounds only, and is not otherwise competently provided for; and it has been further represented to us, by the said Dean and Chapter, that the collective amount of the stipends so paid to the three present Minor Canons exceeds the aggregate annual sum which has heretofore been paid out of the revenues of their Church to the Minor Canons thereof :

" Now, therefore, we humbly recommend and propose, with the consent of the said Dean and Chapter, testified by their having hereunto affixed their Chapter seal, that the number of Minor Canons in the said Cathedral Church of Gloucester shall from henceforth be three, and that there shall be paid to each Minor Canon appointed in the said Church, after the passing of the said recited Act, a fixed annual stipend, as such Minor Canon, of one hundred and fifty pounds out of the revenues of the said Church.

"And we further recommend and propose, that so long as the said Edward Vaughan shall continue to be a Minor Canon in the same Church, and shall to be a Minor Canon in the same Church, and shall joying every domestic happiness, is the prayer of, not hold any other office therein or any benefice, may it please your Majesty, your Majesty's loyal and

there shall be paid to him by the Treasurer of the said Church, in addition to his aforesaid stipend of ninety pounds, the annual sum of sixty pounds, by equal half-yearly payments, the first of such payments to be made at the expiration of six calendar months from the day of the general audit of the said Dean and Chapter now last past, and that the said Treasurer shall and may from time to time retain, out of any monies payable to us in respect of any Canonry or Canonries suspended in the said Church, such sum of money as may have been so paid to the said Edward Vaughan.

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify, the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Gloucester.
