THIS day, the Lords being met, a message was sent to the Honourable House of Commons by the Gentlemen Usher of the Black Rod, acquainting them, that The Lords, authorised by virtue of a Commission under the Great Seal, signed by Her Majesty, for delaring Her Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Arch-bishop of Canterbury, the Lord High Chancellor of Great Britain, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An Act for providing for the further security and protection of Her Majesty's person.

An Act to amend the laws for the regulation of the trade of the British possessions abroad.

An Act to continue, until the first day of October one thousand eight hundred and forty-three, the exemption of inhabitants of parishes, townships, and villages from liability to be rated as such, in respect of stock in trade or other property, to the relief of the poor.

An Act to indemnify witnesses who may give evidence before the Lords Spiritual and Temporal, on a Bill to exclude the borough of Sudbury from sending Burgesses to serve in Parliament.

An Act for further extending the approaches to London-bridge and the avenues adjoining to the Royal Exchange, in the city of London, and for amending the Acts relating thereto respectively; and for raising a sum of money towards opening a street to Clerkenwell-green, in the county of Middlesex, in continuation of the new street from Farringdon-street, in the city of London.

An Act for amending some of the powers of the Acts relating to the London and Greenwich Railway.

An Act for providing additional burial grounds in the parish of Leeds, in the west riding of the county of York.

An Act for better lighting, cleansing, sewering, and improving the borough of Leeds, in the county of York.

An Act for the improvement, good government, and police regulation of the borough of Liverpool.

An Act for better paving and improving the streets and highways within the extra-parochial place of Toxteth-park, in the county palatine of Lancaster, and for the sewerage of certain parts of the said place.

THE following is a copy of an Order of Her Majesty in Council, for assigning a chapelry district to St. Michael's Chapel, at Tonge, in the parish of Prestwich-cum-Oldham, in the county of Lancaster, under the 16th section of the 59th Geo. 3., cap. 134 :

> At the Court at Buckingham-Palace, the 27th of April 1842, present, the Queen's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the fifty-eighth year of the reign of His late Majesty King George the Third, intituled "An Act for building, and promoting the building, of additional churches in populous parishes," it is, amongst other things, enacted, "that in every case in which the Commissioners appointed for carrying into execution the purposes of the said Act shall be of opinion that it will be expedient to divide any parish into two or more distinct and separate parishes, for all ecclesiastical purposes whatever, it shall be lawful for the said Commissioners, with the consent of the bishop of the diocese in which such parish is locally situated, signified under his hand and seal, to apply to the patron or patrons of the church of such parish for his consent to make such division, and for such patron or patrons to signify his or their consent thereto under his hand and seal; and the said Commissioners shall, upon the consent of the said patron or patrons so signified, represent the whole matter to His Majesty in Council, and shall state in such representation the bounds by which it is proposed, with such consent as aforesaid, to divide such parish, together with the relative and respective proportions of glebe land, tithes, moduses, or other endowments which will by such division arise and accrue, and remain and be, within each of such respective divisions, and also the re-
